**NOTICE OF OPPOSITION**

Apex, LLC, a limited liability company organized and existing under the laws of the State of Rhode Island, having a business address of 100 Main Street, Pawtucket, Rhode Island 02860 (“Opposer”), believes that it will be damaged by registration of Application Serial No. 85/477,601 as it relates to services in Class 12, namely solid tires for use with forklifts, earthmoving vehicles and other industrial grade vehicles, sold to construction and other industrial businesses.

The grounds for opposition are as follows:

**Apex and its Marks**

1. Since at least as early as 1924, Apex and its predecessors have used the mark “APEX” and other marks incorporating the word “APEX” on and in connection with various automotive, tire, manufacturing, wholesale, retail, on-line retail, commercial and residential real estate development, real estate management, advertising and other businesses.

2. Apex is the owner of common law rights in the marks APEX, APEX ONLINE, APEX STORES, and APEX COMPANIES as a result of the continuous use of the APEX mark since at least as early as 1924 in connection with tires, automotive repair and maintenance services and retail automobile parts and accessories store services, as a result of its continuous use of the APEX mark since at least as early as September 1924 for retail services, as a result of its continuous use of the APEX ONLINE and APEX STORES marks since at least as early as November 1996 in connection with retail services and as a result of continuous use of the APEX COMPANIES mark in connection with tires and automotive repair and maintenance, among other things, since at least as early as September 2002.

3. Apex owns the following U.S. registrations for its trademarks and service marks, among others:

4. Registration Nos. 1,847,961; 2,155,905; 2,454,720; 2,562,812; 2,657,639; 2,443,933 have been renewed pursuant to the provisions of the Lanham Act, and are incontestable.

5. Registration No. 2,918,976 is incontestable.

**Applicant and its Marks**

6. Upon information and belief, Apexway Products Corporation (“Applicant”) is a Taiwanese corporation with offices at 8F-12, No. 77 Shih-Jen N. 1<sup>st</sup> Rd. Taichung, Taiwan.

7. Applicant is the record owner of the following U.S. Trademark Registration for the mark APEX:

## **COUNT I: LIKELIHOOD OF CONFUSION**

8. Apex repeats and incorporates herein by reference the averments in the preceding paragraphs.

9. The goods and services listed in Serial No. 85/477,601 are closely related to, and in some instances identical to, those of Apex, in particular, to Apex's tire and automotive repair and maintenance services and retail automobile parts and accessories stores services.

10. On information and belief, Apex is the prior user of the APEX mark. Apex began using APEX in connection with tires, automotive repair and maintenance services and retail automobile parts and accessories stores at least as early as 1924, began using APEX in connection with retail services at least as early as September 1924, began using APEX ONLINE and APEX STORES in connection with retail services at least as early as November 1996, and began using APEX COMPANIES in connection with tires, automotive repair and maintenance at least as early as September 2002. Applicant's date of first use for their mark is subsequent to Opposer's actual date of first use of the Apex Marks for identical or closely related goods and services.

11. Apex has expended considerable effort and expense in promoting its APEX service marks and the goods and the services sold under such marks, with the result that the purchasing public has come to know, rely upon and recognize the products and services of Apex by such marks.

12. Applicant's APEX mark is confusingly similar to Apex's APEX service marks and is likely to cause confusion, deception or mistake to Apex's irreparable damage and injury, in violation of Section 2(d) of the Lanham Act, 15 USC §1052(d).

**COUNT II: DILUTION**

15. Apex repeats and incorporates herein reference the averments in the preceding paragraphs.

16. Apex is damaged and will continue to be damaged because Applicant's continued use and registration of the APEX mark dilutes the distinctive quality of Apex's APEX service marks.

**PRAYER FOR RELIEF**

WHEREFORE, Apex respectfully requests that this Opposition be sustained and that registration to Applicant for the APEX mark in International Class 12 be denied.

The filing fee of \$300 for this Notice of Opposition is being submitted electronically with this Notice.
