NOTICE OF OPPOSITION

The Net-A-Porter Group Limited (“Opposer”), a limited company organized and existing under the laws of the United Kingdom, having a place of business at Westfield, Ariel Way 1, The Village Offices, London W12 7GF, United Kingdom, believes that it will be damaged by the issuance of a registration for the mark CLÉ-À-PORTER, applied for in Application Serial No. 85/634,514, and therefore opposes the same. As grounds for the opposition, Opposer, by its attorneys Fross Zelnick Lehrman & Zissu, P.C., alleges as follows:

1. Opposer is a premier online fashion retailer.
2. Since at least as early as June 2000, Opposer has used the mark NET-A-PORTER in connection with its business and ancillary products and services.
3. Opposer owns U.S. Registration No. 2,661,220 for NET-A-PORTER for use in connection with “retail store services featuring clothing, shoes, handbags, fashion goods namely, hats, jewelry, accessories, scarves and purses, fashion accessories; computerized on line retail services featuring clothing, shoes, handbags, fashion goods, namely, hats, jewelry, accessories, scarves and purses, fashion accessories” in International Class 35, which issued on December 17, 2002.

4. Opposer owns U.S. Registration No. 4,128,047 for NET-A-PORTER.COM for use in connection with “retail store services featuring clothing, fashion accessories including key fobs and umbrellas, textiles including towels, hair accessories, accessory scarves, gloves, belts, footwear, headwear, handbags, purses, cosmetics, toilet preparations, cosmetic bags sold empty, eyewear including sunglasses, jewelry, watches, leather goods including leather-bound notebooks and leather cases for mobile telephones, laptops and personal devices; and online retail store services featuring clothing, fashion accessories including key fobs and umbrellas, textiles including towels, hair accessories, accessory scarves, gloves, belts, footwear, headwear, handbags, purses, cosmetics, toilet preparations, cosmetic bags sold empty, eyewear including sunglasses, jewelry, watches, leather goods including leather-bound notebooks and leather cases for mobile telephones, laptops and personal devices” in International Class 35, which issued on April 17, 2012.

5. The foregoing registrations of Opposer (hereinafter collectively referred to as the “NET-A-PORTER Marks”) are valid, subsisting, and in full force and effect. These registrations constitute evidence of the validity of the registered marks and of the registrations thereof, of Opposer’s ownership of the marks, and of Opposer’s exclusive right to use the marks in commerce in connection with the identified goods and services pursuant to Section 7(b) of the Lanham Act, 15 U.S.C. § 1057(b).

6. Opposer’s registrations place others on constructive notice of Opposer’s claim of ownership thereof pursuant to Section 22 of the Lanham Act, 15 U.S.C. § 1072.

7. A printout from the United States Patent and Trademark Office’s online database reflecting the current status and title of the above registrations is attached as **Exhibit A**.

8. Opposer has made a substantial investment in its services bearing the NET-A-PORTER Marks, and through sales, advertising, and promotional efforts, said marks have become substantially important and valuable to Opposer.

9. On information and belief, Linda Nagamine (“Applicant”) is an individual who can be contacted at c/o Law Offices of Keith D. Fraser, 355 S. Grand Avenue, Suite 2450, Los Angeles, CA 90071.

10. On May 24, 2012, Applicant filed Application Serial No. 85/634,514 to register the mark CLÉ-À-PORTER for “leather key chains” in International Class 18. The Application is currently pending based on Applicant’s first use of the CLÉ-À-PORTER mark in commerce on December 1, 2010.

11. The above Application (hereinafter, the “Application” and the mark listed therein the “Applicant’s Mark”) was filed on a date that is long after Opposer began using the NET-A-PORTER Marks.

12. Upon information and belief, Applicant had actual knowledge of Opposer’s prior rights to and interest in the NET-A-PORTER Marks in connection with retail services featuring leather accessories before seeking to register Applicant’s Mark for closely related goods. At a minimum, as a matter of law Applicant was on constructive notice of Opposer’s rights in its registered NET-A-PORTER Marks based on Opposer’s registrations therefor.

13. The registration of Applicant’s Mark for the goods listed in the Application would be inconsistent with Opposer’s prior rights in its NET-A-PORTER Marks.

14. Opposer’s NET-A-PORTER Marks are exclusively associated with Opposer and have been used continuously by Opposer since a date prior to any date on which Applicant can rely.

15. Applicant's Mark as applied for in the Application so resembles Opposer's NET-A-PORTER Marks in sight, sound and commercial impression as to be likely, when used on or in connection with Applicant's goods, to cause confusion and mistake and to deceive the trade and public into believing that Applicant's goods or services are from the same source as Opposer's services, emanate from Opposer, or are otherwise authorized, sponsored, or licensed by Opposer, in violation of Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d).

16. By reason of the foregoing, Opposer is likely to be harmed by registration of the Application for Applicant's Mark.

WHEREFORE, it is respectfully requested that this opposition be sustained and that the registration sought by Applicant in Application Serial No. 85/634,514 be denied.


