NOTICE OF OPPOSITION

Opposer, Rudolf Wild GmbH & Co. KG, a limited liability partnership existing under the laws of Germany located at Rudolf-Wild-Strasse 107-115, D-69214 Eppelheim, Germany and its sister company and licensee, WILD Flavors, Inc., a corporation organized and existing under the laws of Delaware, located at 1261 Pacific Avenue, Erlanger, Kentucky 41018 (hereinafter collectively "Opposers") believe that they will be damaged by the registration of the application and hereby give notice of their intention to oppose the application for registration.

The grounds for opposition are as follows:

1. For many years prior to the date of filing by Applicant, Opposers have been using the trademarks WILD, WILD & Design and composite marks containing the term “WILD” therein in foreign commerce with the United States and interstate commerce within the United States in connection with flavors, aromas, essences and distillates used in the preparation of foods and soft drinks and beverages of various kinds and for fruit based liquid ingredients for use in the preparation of other foods and beverages.

2. WILD Flavors uses the WILD and WILD & Design marks for, inter alia, flavors and ingredients for non-alcoholic and alcoholic beverages and foods, including flavoring and coloring for sauces and seasonings for flavorings for, inter alia, popcorn, pretzels, peanuts and potato chips.

3. Rudolf Wild is the owner of U.S. Registration No. 1,296,602 issued on September 18, 1984 for the mark WILD for fruit based liquid ingredient for use in the preparation of other foods. This registration is valid and subsisting, in full force and effect and incontestable. A copy of the TSDR record of Registration No. 1,296,602 is annexed hereto as Exhibit 1.

4. Rudolf Wild is the owner of U.S. Registration No. 1,586,995 issued on March 13, 1990 for the mark WILD & Design for food flavoring, namely, flavors, aromas, essences, and distillates not in the nature of essential oils and for flavors, aromas, essences and distillates not in the nature of essential oils for the preparation of soft drinks. This registration is valid and subsisting, in full force and effect and incontestable. A copy of the TSDR record of Registration No. 1,586,995 is annexed hereto as Exhibit 2.

5. By reason of extensive distribution, sale and promotion of Opposers' goods in and throughout the United States, Opposers' marks WILD and WILD & Design have acquired substantial goodwill, distinctiveness, secondary meaning and fame as indicating a line of flavors, aromas, essences, and distillates used in the preparation of soft drinks and foods, sauces and seasonings for flavoring potatoe chips, popcorn, pretzels and peanuts, and fruit-based liquid ingredients for use in foods having their origin exclusively with Opposers.

6. On October 30, 2012, Buffalo Wild Wings, Inc. filed an application for BUFFALO WILD WINGS WINGS. BEER. SPORTS & Design for, inter alia, sauces (Serial No. 85/462,787) (hereinafter referred to as "BUFFALO WIND WINGS Mark").

7. Applicant's BUFFALO WILD WINGS Mark is likely to cause confusion with Opposers' marks. The mark sought to be registered, namely, BUFFALO WILD WINGS WINGS. BEER. SPORTS & Design contains the word "WILD." Thus, Opposers' entire mark is subsumed in Applicant's BUFFALO WILD WINGS Mark. Further, as the words "BUFFALO" and "WINGS" and "BEER" and "SPORTS" in Applicant's Mark have been disclaimed, the word "WILD" is the dominant portion thereof.

8. The goods in the application for the BUFFALO WILD WINGS Mark are closely related to Opposers' goods. Applicant's BUFFALO WILD WINGS Mark is for sauces. Opposers' goods consist of ingredients and flavors used to flavor foods and non-alcoholic and alcoholic beverages, including flavorings and colorings for sauces and seasonings for flavoring potato chips, popcorn, pretzels and peanuts. Thus, Applicant's goods are closely related to

Opposers' goods, as Opposers' goods are the type that could be used to create Applicant's goods. Therefore, consumers are likely to be confused because the goods are sold under confusingly similar marks.

COUNT I

LIKELIHOOD OF CONFUSION

9. Opposers repeat and re-allege the allegations in Paragraphs 1 through 8 as fully set forth herein.

10. In view of the confusing similarity of Applicant's BUFFALO WILD WINGS Mark and goods, Applicant's use and registration of the BUFFALO WILD WINGS Mark is likely to create confusion, mistake and deceive the trade and public into believing that Applicant's goods originate with or are otherwise licensed, sponsored or authorized by Opposers.

11. The use and registration of the BUFFALO WILD WINGS Mark by Applicant is likely to damage and destroy the distinctiveness, goodwill, reputation, secondary meaning and fame created and established by Opposers in their WILD and WILD & Design marks by virtue of the confusion, mistake and deception likely to occur between the respective marks in derogation of Opposers' exclusive right to continue to use the registered marks for its present goods and to expand the use of its marks to related goods and services.

12. By reason of all the foregoing, Opposers will be gravely damaged by the registration of the BUFFALO WILD WINGS Mark for the goods identified in the Application.

COUNT II

DILUTION

13. Opposers repeat and re-allege the allegations contained in Paragraphs 1-8 and 10-12 as fully set forth herein.

14. Opposers' WILD and WILD & Design marks are famous and the use and registration of Applicant's BUFFALO WILD WINGS Mark is likely to dilute the distinctive quality of Opposers; famous marks pursuant to 15 U.S.C. §1125(c), which is applicable in an opposition proceeding.


15. By reason of all the foregoing, Opposers will be gravely damaged by the registration of the BUFFALO WILD WINGS Mark for the goods identified in the applications therefor.

WHEREFORE, by reason of the confusing similarity of Applicant's and Opposers' marks and the likelihood that Applicant's BUFFALO WILD WINGS Mark will dilute Opposers' mark, Opposers respectfully request that the opposition be sustained and that registration of the marks BUFFALO WILD WINGS WINGS. BEER. SPORTS & Design (Serial No. 85/462,787) be refused.
