NOTICE OF OPPOSITION

Soluxury HMC (“Opposer”) is a Société à Responsabilité Limitée organized in France and located at 110 Avenue de France, F-75013 Paris, France.

To the best of Opposer’s knowledge, Monreale USA Group LLC (“Applicant”) is a Delaware limited liability company located at c/o Akerman Senterfitt, 335 Madison Avenue, 26th Floor, New York, New York 10017 and owns U.S. Trademark Application Serial No. 85/665,773 (the “Application”).

Opposer believes that it is and will continue to be damaged should the Application register and opposes it as set forth below.

Factual Background

1. Since at least as early as 1974, Opposer and its predecessors-in-interest have continuously used the mark SOFITEL (“Opposer’s Mark”) in connection with hotel and restaurant services and services (“Opposer’s Services”) as well as various printed, furniture, houseware, textiles, and clothing (collectively, “Opposer’s Goods”).

2. Nearly 40 years ago, on July 9, 1973, Opposer’s predecessor-in-interest filed a U.S. trademark application for the mark SOFITEL for use with Opposer’s Services, which on October 15, 1974 matured to the now-incontestable Registration No. 995,968.

3. Opposer has registered Opposer's Mark for use in connection with Opposer's Goods and Opposer's Services at least 8 other times including (collectively with Registration No. 995,968, these are "Opposer's Registrations" and TSDR printouts are attached as Exhibit A):

4. Opposer's Registrations are prima facie evidence of the validity of Opposer's Marks and Opposer's ownership and exclusive right to use those marks in commerce and provide constructive notice of Opposer's ownership of the marks, all as provided by §§ 7(b) and 22 of the Federal Trademark Act of 1946, as amended.

5. Opposer's registration for SOFITEL, Registration No. 995,968 is incontestable under 15 U.S.C. §1065, and as such, is conclusive evidence of the validity of that registered mark, of Opposer's ownership of that mark and of Opposer's exclusive right to use that mark with Opposer's Services.

6. On June 29, 2012, well after the filing dates of the applications that became Opposer's Registrations, Applicant filed the Application for SONOTEL ("Applicant's Mark") for use with *hotel services* ("Applicant's Services"), based on an intent to use that mark in commerce.

7. The Application was published for opposition on November 27, 2012 and Opposer obtained an extension of time to Oppose the Application through May 26, 2013.

Likelihood Of Confusion

8. Applicant's Mark is highly similar to Opposer's Mark.

9. Applicant's Services are identical to Opposer's Services and would be marketed to the same consumers through the same trade channels.

10. Opposer has priority over the adoption, after July 9, 1973, of marks that are the same as or similar to Opposer's Mark and are used with goods or services that are the same as, or are related to, Opposer's Goods or Opposer's Services.

11. Allowing the Application to register would damage Opposer by interfering with Opposer's exclusive right to use Opposer's Marks in connection with Opposer's Goods or Opposer's Services.

12. Because of the similarity between Opposer's Marks and Applicant's Mark, and the relatedness of Opposer's Goods and Opposer's Services on the one hand and Applicant's Services on the other, Applicant's Mark is likely to cause confusion, cause mistake or deceive the public, and cause the public to believe, incorrectly, that Applicant's Services emanate from, are authorized or endorsed by, or are otherwise connected with Opposer in violation of Section 2(d) of the Lanham Act, 15 U.S.C. §1052(d).

THEREFORE, Opposer respectfully requests that the Trademark Trial and Appeal Board sustain this Notice of Opposition to Application Serial No. 85/665,773 for SONOTEL.

Please recognize Cory M. Amron, William H. Oldach III, and Christopher M.
