

NOTICE OF OPPOSITION

Disney Enterprises, Inc. (“Opposer”), a corporation of the State of Delaware, having a principal place of business at 500 South Buena Vista Street, Burbank, California, 91521, believes that it is being and will be damaged by the registration of the mark shown in Application Serial No. 85484419, and hereby opposes the same in all classes. As grounds for its opposition, Opposer alleges that, upon actual knowledge with respect to itself and its own acts, and upon information and belief as to other matters:

Opposer and its THE JUNGLE BOOK Mark

1. Opposer, through its related companies and licensees (collectively “Opposer” or “Disney”), is one of the world’s leading producers and providers of entertainment, films, music, amusement parks, retail services, and a wide variety of consumer products.
2. Since at least 1967, Opposer has used its mark THE JUNGLE BOOK in commerce in connection with entertainment services and motion picture films.
3. Opposer released two animated films based on Rudyard Kipling’s

work, Opposer's original film, *The Jungle Book* (1967), and a second film, *The Jungle Book 2* (2003). Both films were released theatrically and on DVD/video, and Opposer has regularly re-released its films in theatres and on DVD/video, including *The Jungle Book* (1978, 1984, 1990, 1991, , 1997, , 1999, , 2007,) and *The Jungle Book 2* (2003, , 2008,). Opposer's original film, *The Jungle Book* (1967), was nominated for an Academy Award for music, and the American Film Institute nominated this film among the 100 Greatest Musicals.

4. Opposer has a long history of merchandising its film titles and marks in connection with a wide variety of products ranging from books and ornamental pins to toys, figurines, and mugs, just to name a few.



5. In addition to its films, and at least as early as 2002, Opposer commenced use of its mark THE JUNGLE BOOK shown below in connection with, among other things, jewelry (Class 14), greeting cards and books (Class 16), and toys (Class 28), among other things.



6. Further, since long before Applicant filed its trademark application for THE JUNGLE BOOK mark, Disney has used its mark THE JUNGLE BOOK in commerce in connection with a wide variety of merchandise, including but not limited to DVDs, music CDs, and video games (Class 9), ornamental pins (Class

14), books and greeting cards (Class 16), and toy figures (Class 28).

7. Many of the products and services set forth in Paragraphs 2-6 above and in this Paragraph below are available on Opposer's DISNEY STORE website at www.disneystore.com, as well as www.amazon.com, www.walmart.com, wwwbarnesandnoble.com, and other popular stores and websites. A representative sample of products bearing Disney's THE JUNGLE BOOK mark are shown below and attached as Exhibit A. (Collectively the marks and products and services set forth in Paragraphs 2-6 and below in this Paragraph are referred to, respectively, as "Opposer's THE JUNGLE BOOK Mark" and "Opposer's Goods and Services.")



8. Disney's THE JUNGLE BOOK products and services, including its sequel film, DVDs, CDs, and wide array of collateral merchandise, have been an enormous success over the years. Through decades of use and public recognition, Opposer's THE JUNGLE BOOK Mark has become distinctive and identified with Opposer and Opposer's Goods and Services.

Applicant and THE JUNGLE BOOK & Design Mark

9. DQ Entertainment (Ireland) Limited ("Applicant"), the listed owner of Application Serial No. 85484419, is a corporation of Ireland with an address of Mazars

Place, Salthill, Galway, Ireland.

10. On November 30, 2011, Applicant filed Application Serial No. 85484419 under Section 1(b), 15 U.S.C. § 1051(b), to register THE JUNGLE BOOK & Design mark (“Applicant’s THE JUNGLE BOOK Mark”) for “video game software; computer game software” in class 9, “jewellery; imitation jewellery” [sic] in Class 14, “postcards; greeting cards; note cards; business cards” in Class 16, “school bags; leather bags and imitation leather bags; ruck sacks” in Class 18, “ropes; string; tents” in Class 22, “household linen” in Class 24, “carpets, rugs, mats and matting, linoleum for covering existing floors; non-textile wall hangings” in Class 27, “children's multiple activity toys” in Class 28, “jellies and jams; milk products excluding ice cream, ice milk and frozen yogurt; coffee creamer” in Class 29, “cocoa; beverages made of tea; beverages with a chocolate base; beverages with a coffee base; cocoa-based beverages; coffee-based beverages containing milk” in Class 30, “advertising, marketing and promotion services” in Class 35, “multimedia publishing of books, magazines, journals, software, games, music, and electronic publications” in Class 41 and “cosmetic body care services” in Class 44. (Collectively referred to as “Applicant’s Goods and Services”).

11. On February 5, 2013, Applicant’s THE JUNGLE BOOK Mark was published for opposition in the *Trademark Official Gazette* (TMOG), and Opposer filed timely extensions of time to oppose on March 1, 2013 and May 31, 2013.

Likelihood of Confusion. 15 U.S.C. § 1052(d)

12. Opposer repeats and realleges each and every allegation set forth above.

13. Opposer has priority based on its prior use in commerce of Opposer’s THE JUNGLE BOOK Mark before the filing date of the opposed Application Serial No. 85484419, and any date of first use that may be alleged by Applicant.

14. Applicant's THE JUNGLE BOOK Mark is identical or virtually identical in sound, appearance, and connotation to Opposer's THE JUNGLE BOOK Mark.

15. Applicant's Goods and Services are identical and/or closely related to Opposer's Goods and Services advertised, promoted, offered, and/or sold by Opposer in connection with Opposer's THE JUNGLE BOOK Mark.

16. Through its long use and substantial advertising and promotion, Opposer has developed valuable goodwill in Opposer's THE JUNGLE BOOK Mark.

17. Accordingly, Applicant's THE JUNGLE BOOK Mark shown in Application Serial No. 85484419 so resembles Opposer's THE JUNGLE BOOK Mark set forth above as to be likely, when used in connection with Applicant's Goods and Services, to cause confusion, or to cause mistake, or to deceive under Section 2(d) of the Lanham Act, as amended, 15 U.S.C. § 1052(d).

WHEREFORE, Opposer believes that it is being damaged, and will be damaged, by the registration of the mark shown in Application Serial No. 85484419, and requests that the opposition be sustained, and that registration to Applicant be refused.

There is little doubt that **The Jungle Book** remains one of the most delightful and warmly received of all of the Disney animated films. This re-telling of the classic Rudyard Kipling tale is the last film that Walt Disney was involved with both in terms of production and writing before his death in 1966. "Let's have fun with it," Walt was often quoted as saying to his animation staff about their efforts on the film. And that is exactly what the talent pool of The Walt Disney Studios did with the story of Mowgli, the Indian jungle boy raised by wolves, befriended by bears and panthers and stalked by pythons and tigers. And at the center of it all is Mowgli the man cub, the evil tiger Shere Khan, the wise panther Bagheera and Baloo, the lovable if lazy Poppa Bear. Set in a verdant jungle and highlighted by flowers, waterfalls and palms, one can almost smell the canopied gardenias, sense the rushing of the water and hear the chatter of the monkeys in the trees. Indeed, the magic of Walt Disney as interpreted by Thomas Kinkadee Studios has never been more likely to transport the collector to the experience of the cinematic moment. Let us all take that journey, "have fun with it" and "look for the bare necessities of life!"




