6. There is no paragraph numbered 6 in the Notice of Opposition.

7. Applicant denies the allegations contained in the paragraph numbered 7 of the Notice of Opposition.

8. Applicant denies the allegations contained in the paragraph numbered 8 of the Notice of Opposition.

9. Applicant denies the allegations contained in the paragraph numbered 9 of the Notice of Opposition.

10. Applicant denies the allegations contained in the paragraph numbered 10 of the Notice of Opposition.

WHEREFORE, Applicant prays that this opposition be denied and that registration of the mark in Application Serial No. 85/600,420 be granted.
