Status Report by Applicant

The Parties to the above captioned Oppositions have been requested to report the status of Case No. 1:13-cv-05478, which was pending in the United States District Court for the Northern District of Illinois. This constitutes Applicant's Status Report to the Board.

The case has been terminated. The final order of the court requires that any trademark registrations with regard to the use of the word CHAMPION as it pertains to roofing, roofing services and roofing installation be concurrent registrations by the parties, based on geographical boundaries set by the court in its final order. The court's order applies only services related to roofing, roofing services and roofing installation.

As a result of the court's order, Applicant will be dismissing the opposed applications and filing new applications to comply with the court order. Applicant will be filing trademark applications for marks that include the word CHAMPION for non-roofing related services as trademark applications Principal Register in the usual course. Roofing services will not be included. Applicant's applications for roofing related services will be

filed as concurrent registration applications using the geographical divisions set in the court's final order.

Applicant anticipates that the pending opposed Applications should be affirmatively dismissed within the next 2 weeks.
