NOTICE OF OPPOSITION

Hint, Inc., by and through its undersigned attorneys, believes that it will be damaged by the registration of the mark shown in U.S. Trademark Application Serial No. 85/587640 for the mark HINT in International Class 18 and hereby opposes the same. As grounds for opposition, it is alleged that:

1. Upon information and belief, Applicant Sunrise Apparel Group, LLC (hereinafter "Applicant"), is a California limited liability company with an address of 801 S. Figueroa Street, Suite 2500, Los Angeles, CA 90017.
2. Upon information and belief, Applicant seeks to register the mark HINT for goods identified as "handbags; wallets; key chains of leather or imitation leather" in International Class 18 (hereinafter "Applicant's Goods").

3. Upon information and belief, the subject application was filed on April 3, 2012 and was published for opposition on March 19, 2013.
4. Opposer Hint, Inc. (hereinafter "Opposer") is a corporation organized under the laws of California with an address of P.O. Box 29078, San Francisco, California 94129.
5. Opposer is the owner of various trademark registrations for the mark HINT alone and in combination with other terms, including:

6. Opposer offers clothing and other fashion items under its HINT brand, and is active in the fashion industry and at various fashion-related events.

7. Opposer adopted and commenced interstate use of the mark HINT for its beverage, clothing, fashion and lifestyle products and services long prior to any date which may be lawfully claimed by Applicant.
8. Upon information and belief, Applicant filed its application on April 3, 2012 and based its application upon a bona fide intention to use the mark in commerce. Upon information and belief, Applicant has not filed a use statement before the U.S. Patent and Trademark Office.
9. There is no issue as to priority. Opposer has used its HINT mark for many years prior to Applicant's April 3, 2012 filing date, and continues to use its HINT trademark.
10. Opposer has spent a considerable amount of money marketing its various HINT goods and services, and as a result, the mark is well-known among the purchasing public.
11. Opposer's HINT mark became famous prior to Applicant's commencement of use of its HINT mark for the subject goods and prior to the filing date of Applicant's application.
12. Opposer's HINT mark is of significant value to Opposer as an identifier of source in connection with the promotion and offering of its goods and services.
13. Applicant's use of the identical mark HINT in connection with the Applicant's Goods is likely to result in confusion, mistake, and/or deception in that the public will wrongly assume that Opposer has approved of Applicant, is affiliated with Applicant, or has otherwise sanctioned, sponsored or licensed the goods and services of Applicant.
14. Applicant's use of the mark HINT in connection with Applicant's Goods is likely to cause confusion with Opposer's HINT trademarks as used in connection with Opposer's good and services.

15. Opposer would be damaged by the registration of the mark HINT by Applicant as the registration will result in confusion, mistake, and/or deception, and Applicant will be able to trade on Opposer's goodwill and reputation.
16. The registration of Applicant's mark will cause the dilution of the distinctive quality of Opposer's marks, to Opposer's irreparable damage.

WHEREFORE, Opposer prays that this opposition be granted and that Applicant's Application Serial No. 85/587640 for the mark HINT be abandoned.


