3. The PENN name and mark enjoy a rich history in tennis dating back over a century to when Opposer's predecessor-in-interest first began manufacturing tennis balls in the U.S. in 1910.

4. Opposer, through its predecessors-in-interest and related companies (collectively "Opposer"), has continuously used the PENN name and mark in connection with tennis balls, racquetballs, and tennis equipment since at least as early as 1972. Opposer has also used the PENN mark in connection with athletic apparel, sports bags, luggage, backpacks, and travel bags since at least as early as 2004.

5. Opposer's PENN tennis balls are a leading tennis ball in the U.S. According to data compiled by the Tennis Industry Association (TIA), PENN tennis balls have held over 50% market share for over 15 years.

6. Opposer's PENN tennis balls have received numerous accolades over the years, including being the #1 Choice of ATP Pros, the #1 Choice of USPTA Teaching Pros, and the #1 Choice of USTA League Participants.

7. Opposer's PENN racquetballs have likewise been a great success. PENN racquetballs are the top selling racquetballs worldwide and are the official racquetball of

many major international tournaments. As shown below, the PENN mark is applied directly to racquetballs (among other products).



8. Opposer's PENN mark has been the subject of decades of advertisement and promotion through a wide variety of media, including being prominently featured at tennis tournaments, tennis stores, and through many other means. A representative sampling of print advertisements over the years appear below:

9. As a result of decades of advertisement, promotion, and commercial success, Opposer's PENN mark has long been famous in the tennis industry, including since well before the filing dates of the opposed applications.

10. Opposer owns the following valid and subsisting United States trademark registrations for the mark PENN:

11. Printouts of these registrations from the PTO TESS and TSDR databases, including Assignment information, are attached as Exhibit A (individually and collectively referred to as the "PENN Marks").

12. Opposer also owns Application Serial No. 85371181 for the mark PENN for “golf clubs, golf balls, golf bags, golf club covers, golf ball markers, divot repair tools, manual non-motorized golf carts, golf gloves, and golf ball tees” filed on July 14, 2011.

Applicant’s TENN Applications

13. Applicant Perfect Pick Up Inc. (“Applicant”) is a New York corporation with an address of 3G 235 West End Ave., New York, New York 10023.

14. On September 28, 2012, Applicant filed a trademark application for the mark TENN (and Design) shown below for “athletic shirts; combinations; socks; tops; women's clothing, namely, shirts, dresses, skirts, blouses; wrist bands” in Class 25; “sport balls; sporting goods, namely, a sports training device to improve strength, toning, conditioning, balance, and proprioception; sporting goods, namely, carriers specially adapted for sport balls; sports equipment, namely, telescoping caddy for bucket for carrying, storing and transporting tennis balls and other sports equipment; table tennis balls; tennis ball retrievers; tennis balls” in Class 28; and “on-line retail store services featuring tennis equipment, athletic equipment, clothing, accessories, training equipment, sport balls, ball retrievers, gift mugs, office items, coaching material” in Class 35. The application was assigned Application Serial No. 85741620.




15. Applicant filed Application Serial No. 85741620 based on an alleged intent to use the TENN (and Design) mark in commerce pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. § 1051(b).

16. On March 12, 2013, Applicant filed a trademark application for the stylized mark TENN shown below for “athletic apparel, namely, shirts, pants, jackets, footwear, hats and caps, athletic uniforms; footwear for men and women; headbands for clothing; pants; shirts; shorts; socks; women's clothing, namely, shirts, dresses, skirts, blouses” in Class 25; “sport balls; sporting goods, namely, carriers specially adapted for sport balls; sports equipment, namely, telescoping caddy for bucket for carrying, storing and transporting tennis balls and other sports equipment; table tennis balls; tennis ball retrievers; tennis balls” in Class 28; and “on-line retail store services featuring tennis equipment, athletic equipment, clothing, accessories, training equipment, footwear, sport balls, ball retrievers, gift mugs, office items, coaching material” in Class 35. The application was assigned Application Serial No. 85873857.

17. Applicant filed Application Serial No. 85873857 based on an alleged intent to use the stylized TENN mark in commerce pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. § 1051(b).

18. Applicant is actively promoting tennis balls under the applied-for TENN marks, as shown below:

19. Opposer repeats and realleges each and every allegation set forth in the preceding paragraphs.

20. Opposer has used in commerce, registered, and/or applied to register the PENN Marks before Applicant's September 28, 2012 and March 12, 2013 filing dates and any first-use dates that may be alleged by Applicant.

21. Applicant's applied-for TENN marks so resemble Opposer's prior used, filed, and/or registered PENN Marks, as to be likely, when applied to Applicant's goods, to cause confusion, to cause mistake, or to deceive under Section 2(d) of the Lanham Act, as amended, 15 U.S.C. § 1052(d).

WHEREFORE, Opposer believes that it will be damaged by the registration of the marks shown in Application Serial Nos. 85873857 and 85741620, and respectfully requests that the consolidated opposition be sustained and that registration to Applicant be refused.


