6. Applicant alleged an intent-to-use filing basis under Section 1(b) of the Lanham Act, 15 U.S.C. §1051(b) in the above application.

7. Opposer's rights in Opposer's Marks and its common law rights in its **BORN** trademarks are prior in time to Applicant's date of alleged intent to use Applicant's Mark as established by the filing date of Applicant's application.

8. Opposer's Registrations Nos. 1,947,333, 3,512,409, and 3,542,937 issued long prior to the filing dates of Applicant's Marks.

9. The goods identified in Application Serial No. 85/908,788 include identical goods and goods which are closely related to the goods identified in Opposer's Registrations Nos. 1,947,333, 3,512,409, and 3,542,937.

10. In view of the similarities between Opposer's Marks and Applicant's Mark and the fact that Applicant's goods are identical or closely related to Opposer's goods, there is a likelihood that Applicant's goods will be perceived as being sponsored by or affiliated with Opposer.

11. Applicant's Marks so resemble Opposer's Marks, as to be likely to cause confusion, or to cause mistake, or to deceive as to the source of the Applicant's goods within the meaning of Section 2(d) of the Lanham Act, 15 U.S.C. §1052(d).

12. The use and registration of Applicant's Mark in connection with the goods identified in the above application will damage Opposer in the advertising and sale of its goods by causing a likelihood of confusion.

WHEREFORE, Opposer prays that the Trademark Trial and Appeal Board deny registration on Application Serial No. 85/908,788 and otherwise sustain this opposition.

Payment in the amount of the required filing fee for opposition in one class is submitted with this Notice of Opposition.


