VOLUNTARY SURRENDER OF REGISTRATION NO. 4,495,282
FOR CANCELLATION


Pursuant to Lanham Act §7(e), 15 U.S.C. §1057(e), Villanueva Holding Company, LLC (“Villanueva”) hereby voluntarily surrenders Registration No. 4,495,282 for the mark RESERVA DE EL JAGUAR for cancellation.

Villanueva expressly denies that there was any fraud on the Trademark Office or intentional misstatements made to the Trademark Office in connection with its efforts to obtain the subject registration. However, Villanueva notes that the Statement of Use filed in connection with the subject registration was inadvertently filed in the name of the prior owner of the mark, Mexcor, Inc. Moreover, TMEP §1201.03(c) states that Villanueva cannot rely upon the filing of the Statement of Use by an arguably related company. Additionally, it appears that the time in which this inadvertent error may have been cured by filing a corrective Statement of Use has passed, and there does not appear to be another means to cure.

Accordingly, Villanueva requests that the above-referenced registration be cancelled in the records of the Patent and Trademark Office.
