NOTICE OF OPPOSITION

Opposer Diageo North America, Inc. (“Opposer”) believes that it will be damaged by the registration of the mark TANDUAY (“Applicant’s Mark”) for “rum” in International Class 33, as shown in the above-noted application, Serial No. 85/834,409, and hereby opposes the same pursuant to Section 13(a) of the Trademark Act of 1946, as amended (the “Lanham Act”), 15 U.S.C. § 1063(a).

As grounds for the opposition, Opposer alleges that:

1. Opposer Diageo Brands B.V. is a Netherlands limited company with its principal place of business located at Molenwerf 10-12, Amsterdam, 1014 BG, Netherlands.
2. Opposer and its predecessors-in-interest have owned and used various marks consisting of or including TANQUERAY (collectively, “Opposer’s Marks”) in commerce in the United States in connection with alcoholic beverages and related goods and services since at least as early as 1892 – more than a century before the January 28, 2013 filing date of the application herein opposed, the March 29, 2012 first use date claimed in the application, or any other date upon which Applicant can rely in this proceeding.

3. During its continuous use of Opposer's Marks, Opposer and its authorized wholesalers, distributors, and retail accounts have expended considerable time, effort and money in advertising and publicizing the sale of alcoholic beverages and related goods and services bearing those marks in the United States.

4. During its continuous use of Opposer's Marks, Opposer has directly and indirectly sold, and offered for sale, alcoholic beverages and related goods and services bearing those marks throughout the United States.

5. Opposer's Marks are strong and famous and have been so from a date prior to Applicant's application date, Applicant's claimed first use date, or any other date upon which Applicant can rely in this proceeding.

6. In addition to Opposer's strong common law rights in Opposer's Marks, Opposer owns incontestable U.S. Reg. No. 120,024 for TANQUERAY for "dry gin" in International Class 33, registered January 1, 1918 based on use and use in commerce since 1892; incontestable U.S. Reg. No. 1,438,675 for TANQUERAY for "gin" in International Class 33, registered May 5, 1987 based on use and use in commerce since 1986; incontestable U.S. Reg. No. 3,369,110 for TANQUERAY for "distilled spirits" in International Class 33, registered January 15, 2008 based on use and use in commerce since 1986; and incontestable U.S. Reg. No. 2,874,913 for TANQUERAY for "alcoholic beverages, namely vodka" in International Class 33, registered August 17, 2004 based on use and use in commerce since 1989, among others. Copies of the certificates and electronic status records for these registrations, which are valid, subsisting, and in full force and effect, are attached hereto as Exhibit A.

7. Upon information and belief, Applicant Midway Trading Corp. ("Applicant") is a California corporation with an address of 130 Battery Street, San Francisco CA 94111.

8. By the application herein opposed, Serial No. 85/834,409, Applicant seeks to register the above-noted TANDUAY mark for “rum” in International Class 33.

9. Applicant filed its application for Applicant’s Mark on January 28, 2013 based on purported use since March 29, 2012, long after Opposer commenced use of Opposer’s Marks and registered those marks in the United States, and long after Opposer’s Marks became famous.

10. Applicant’s Mark is confusingly similar to Opposer’s Marks.

11. The goods for which Applicant seeks registration are closely related to or identical to those in connection with which Opposer uses Opposer’s Marks in the United States.

12. Upon information and belief, the products sold in connection with Opposer’s Marks and the products set forth in Applicant’s Application Serial No. 85/834,409 are intended to be directed to similar or identical classes of purchasers and to be distributed through similar or identical channels of trade in the United States.

13. Opposer will be damaged by the registration sought by Applicant because such registration will support and assist Applicant in the confusing and misleading use of the mark sought to be registered, and will give color of exclusive statutory rights to Applicant in violation and derogation of the prior and superior rights of Opposer.

14. Opposer also will be damaged by the registration sought by Applicant because such registration will dilute the distinctive qualities of the famous Opposer’s Marks.

15. Registration should be refused pursuant to Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d), on the grounds that Applicant’s Mark so closely resembles Opposer’s Marks as to be likely, when used on or in connection with the goods identified in the Application, to cause confusion, or to cause mistake, or to deceive, with the consequent injury to Opposer and to the public.

16. Registration should be refused pursuant to Section 43(c) of the Lanham Act, 15 U.S.C. § 1125(c), on the grounds that Applicant's Mark will cause dilution of the distinctive qualities of Opposer's Marks.

WHEREFORE, Opposer believes it will be damaged by the registration of Applicant's TANDUAY mark for the goods identified in Application Serial Number 85/834,409 and respectfully requests that the opposition be sustained and registration of said mark be denied.

Pursuant to 37 C.F.R. §2.6(a)(17), Opposer respectfully requests that the \$300.00 statutory filing fee for filing a Notice of Opposition in one international class, and any additional amount, be charged to Deposit Account No. 083120.
