trade name HENNESSY has been widely and continuously sold in the United States. This Cognac, which is produced by an affiliated company in France called Jas Hennessy & Co., is among the most highly regarded and popular of Cognacs sold in the United States and has been for many years.

3. HENNESSY Cognac has been widely promoted in the United States in a variety of ways, including through television and print advertising.

4. Based on the success of its Cognac sold under the HENNESSY Marks, Opposer has expanded use of its HENNESSY Marks to encompass goods complementary to its business, including Cognac-based cocktails.

5. Through long and extensive use, advertising and promotion, the HENNESSY Marks and trade name have become extremely valuable and symbolize a reputation and goodwill belonging in the United States to Opposer exclusively.

6. In addition to the common law rights accruing to Opposer in the HENNESSY Marks, Opposer owns numerous federal registrations for the HENNESSY Marks, including the following:

7. Printouts from the United States Patent and Trademark Office's TSDR database showing the current status and title of Opposer's Registrations are attached as Exhibit A. These registrations are valid, subsisting and in full force and effect, and constitute evidence of the validity of the marks and of Opposer's exclusive right to use them on the goods identified in the registrations. In addition, Registration No. 868468 for HENNESSY, Registration No. 2130620 for RICHARD HENNESSY, and Registration No. 2372680 for HENNESSY PRIVILEGE, among others, are incontestable pursuant to 15 U.S.C. § 1065, and thus constitute conclusive evidence of Opposer's exclusive rights for the HENNESSY marks for the recited goods.

8. Opposer also owns a number of pending applications, including Application Serial No. 85/469,802, filed November 10, 2011, to register the mark HENNESSY V.S.O.P (stylized) in International Class 33 for "Alcoholic beverages except beers."

Applicant's Application

9. Upon information and belief, Applicant is a California limited liability company located and doing business at 87 E. San Fernando Street, San Jose, California 95113.

10. Upon information and belief, Applicant filed the Application opposed herein on March 27, 2013 to register the mark HENNCHATA for use in connection with "Alcoholic beverages, namely, cognac mixed with Horchata" in International Class 33, claiming first use of the mark in commerce on January 10, 2012.

11. Opposer's rights in the HENNESSY Marks are prior and superior to any rights Applicant may claim in the HENNCHATA mark.

12. HENNESSY is famous and has been famous long prior to any rights Applicant may claim.

13. Applicant is not connected to Opposer in any way, and has not been authorized by Opposer to use the mark HENNCHATA.

14. At the time that Applicant filed the Application herein opposed, Applicant was on constructive notice of Opposer's prior and exclusive rights in the HENNESSY Marks by virtue of Opposer's federal registrations, pursuant to Section 22 of the Lanham Act, 15 U.S.C. § 1072.

15. Upon information and belief, at the time that Applicant filed the Application herein opposed, Applicant had actual knowledge of Opposer's prior and exclusive rights in the HENNESSY Marks as a result of Opposer's extensive use of the HENNESSY Marks and because, as shown in the Specimen of Use submitted with Applicant's Application, Applicant uses the famous HENNESSY brand Cognac in connection with the goods named in the Application.

16. Applicant's HENNCHATA mark incorporates the distinctive prefix HENN from Opposer's HENNESSY Marks, and is highly similar to the marks comprising Opposer's HENNESSY Marks in sight, sound, and commercial impression.

17. Applicant's HENNCHATA mark, when used on the goods named in the Application, is so similar to the HENNESSY Marks and trade name of Opposer as to be likely to cause confusion, mistake or deception as to the source of Applicant's goods, to the damage of the Opposer and public.

18. Registration to Applicant of the HENNCHATA mark would be inconsistent with Opposer's prior exclusive rights in the HENNESSY Marks, and would threaten destruction of Opposer's investment and goodwill in its longstanding and valuable HENNESSY Marks..

COUNT I

19. Opposer incorporates by reference paragraphs 1 through 18 as if fully set forth herein.

20. Opposer's HENNESSY Marks have been used continuously since a date prior to any date upon which Applicant can rely.

21. Applicant's HENNCHATA mark is similar in sight, sound, meaning and commercial impression to Opposer's HENNESSY Marks.

22. Based on the similarity of the parties' respective marks, consumers are likely to be deceived into falsely believing that the goods offered by Applicant under the HENNCHATA mark originate with or are approved or authorized by Opposer, or that there is some relationship between Applicant and Opposer. Any use of the HENNCHATA mark by Applicant in connection with the goods specified in the Application is therefore likely to cause confusion, cause mistake or to deceive consumers in violation of Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d).

23. As a result of the foregoing, Opposer will be injured by registration of the HENNCHATA mark to Applicant.

COUNT II

24. Opposer repeats and alleges the allegations set forth in paragraphs 1 through 23 as though fully set forth herein.

25. Opposer's HENNESSY is a highly distinctive trademark.

26. Opposer's HENNESSY trademark, through long and extensive use, has become famous and was famous long prior to any rights Applicant may claim in the mark here opposed.


27. Applicant's mark is likely to dilute the distinctive quality of Opposer's trademark and cause damage to said trademark and to Opposer.


