REQUEST FOR CORRECTION OF OCTOBER 9, 2015 ORDER

On October 9, 2015, the Board issued an Order acknowledging receipt of Applicant's Change of Address¹ and allowing Applicant 20-days from the mailing date of the order in which to file a response to Opposer's combined motion to compel and motion for sanctions (filed August 7, 2015) ("Opposer's Combined Motion").


The Board's October 9th Order is inconsistent with Board's previous orders of August 14, 2015 and September 28, 2015 as neither called for, nor permitted, any further response by Applicant on Opposer's Combined Motion.

In addition, Opposer takes this opportunity to inform the Board that, consistent with Applicant's past failures to comply with Board rules, and despite the Board's reminders that Applicant is obligated to comply with such rules, Opposer was **never** served with the Applicant's recent Change of Address filing. While Applicant's filing attests that Applicant was served "by Facsimile or email (by agreement only)" (a selection that Applicant had to affirmatively choose at the time of filing), no communication was received. Opposer learned of the filing through a status check of the Board's online records.

For these reasons, Opposer respectfully requests that the Board issue a corrected order retracting the allowance of additional time for Applicant to respond to Opposer's Combined Motion.


