4. Opposer extensively advertises its SMARTFOOD products in various media directed to retail consumers as well as distributors, retailers, and wholesalers.

5. Opposer sells its SMARTFOOD products through retail and wholesale channels in both traditional brick-and-mortar stores and online outlets.

6. Opposer's SMARTFOOD products are marketed and sold in significant quantities on a nationwide basis. In fact, SMARTFOOD white cheddar popcorn was the best-selling brand of white cheddar popcorn nationwide in 2012.

7. Opposer also owns and operates a website located at the URL <http://smartfood.com> and a Facebook page located at the URL <http://facebook.com/smartfood> through which Opposer advertises its SMARTFOOD products on a continuous basis. In addition to advertising the products themselves, the website provides information on places where consumers can obtain SMARTFOOD products online and elsewhere.

8. As a result of the continuing and extensive advertising of snack foods in connection with the mark SMARTFOOD and the name SMARTFOODS, INC., Opposer's mark SMARTFOOD and name SMARTFOODS, INC. have acquired substantial goodwill and consumer recognition throughout the United States such that the general consuming public recognizes both as associated with Opposer.

9. In addition to its aforementioned and substantial rights at common law in the mark SMARTFOOD, Opposer is the owner of U.S. Reg. No. 1367966, issued on October 29, 1985 on the principal register, for the mark SMARTFOOD for "popped popcorn" in International Class 30.

10. U.S. Reg. No. 1367966 is valid and subsisting and has become incontestable pursuant to Section 15 of the Lanham Act, 15 U.S.C. § 1065. A true and correct printout from the

Trademark Status and Document Retrieval database of the United States Patent and Trademark Office showing the current status and title of U.S. Reg. No. 1367966 is attached as Exhibit A.

11. On December 26, 2013, Applicant Trucker Treats, LLC filed Application Serial No. 85/810,715 (the "Application") to register the mark SMARTFOODZ ("Applicant's Mark") for "On-line wholesale store services featuring food; Wholesale ordering services in the field of food" in International Class 35 ("Applicant's Services").

12. In the Application, Applicant alleged that it first used Applicant's Mark on June 1, 2011.

13. Opposer's first use and registration of the mark SMARTFOOD, and its first use of the trade name SMARTFOODS, INC., predates Applicant's first use of Applicant's Mark.

14. Applicant's Mark is almost identical to Opposer's mark SMARTFOOD and name SMARTFOODS, INC. in sight, sound, connotation, and commercial impression.

15. Applicant's Services are strongly related to the goods that Opposer offers through its mark SMARTFOOD and its trade name SMARTFOODS, INC.

16. Applicant's Mark so resembles Opposer's mark SMARTFOOD and trade name SMARTFOODS, INC. as to be likely, when used on or in connection with the identified services of Applicant, to cause confusion, or to cause mistake, or to deceive. Purchasers and prospective purchasers are likely to mistakenly believe that the services Applicant offers under Applicant's Mark are produced, sponsored, endorsed, or approved by Opposer, or are in some way affiliated, connected, or associated with Opposer or Opposer's mark SMARTFOOD. Registration of Applicant's Mark should therefore should be refused under 15 U.S.C. § 1052(d).

17. Registration of Applicant's Mark would be inconsistent with Opposer's rights and would be damaging to Opposer.

ACCORDINGLY, Opposer requests that the Trademark Trial and Appeal Board enter judgment sustaining this opposition and refusing registration of Applicant's Mark.

This Notice of Opposition is being filed electronically, along with the filing fee required by 37 C.F.R. § 2.6(a)(17).
