**RESPONSE TO BOARD ORDER**

On November 30, 2015, Applicant filed Motions on Consent to amend the identification of goods in Application Serial Nos. 85602658 and 85607883. Said motions included the express consent of Opposer Horizon Hobby, Inc.

On January 8, 2016, the Board entered an Order requiring that Applicant also file consent to the amendments by Speculative Products Design, LLC DBA Speck Products ("Speck"), the Opposer in Opposition No. 91214700.

However, the consent of Speck to the amendment to the identification of goods with respect to Application No. 8602658 is already of record in Opposition No. 91214700 (See Board Order in Proceeding 91214700 dated January 21, 2016, a copy of which has been made of record by the Board in this proceeding). In fact, pursuant to such Order, the Board has already granted the proposed amendment in Proceeding 91214770.

Additionally, on February 5, 2016, Speck filed a "Stipulation On Motion to Dismiss Without Prejudice" in Opposition No. 91214698, a copy of which is attached as Exhibit A hereto. Thus, Speck's consent is no longer needed with respect to the amendment to the identification of goods in Application No. 85607883. Since Opposer herein as already consented to the amendment to the identification of goods in Application No. 85607883, the Board should now grant the Motion on Consent to Amend Application No. 85607883.


Accordingly, Applicant respectfully requests that both applications be amended accordingly.


