**NOTICE OF OPPOSITION**

Emilio Pucci International BV, a besloten vennootschap (b.v.), organized under the laws of the Netherlands, having a business address at Oude Utrechtseweg 22-24, KN Baarn, NL-3743, Netherlands (“Opposer” or “Pucci”), believes that it is being and will be damaged by the registration of the mark ST. PUCCHI in Application Serial No. 85913782 for “evening dresses; evening gowns; veils; wedding dresses; wedding gowns; women’s clothing, namely, shirts, dresses, skirts, blouses” in Class 25 owned by Rani Sachdev (“Applicant” or “Sachdev”) and hereby opposes the same. As grounds for its opposition, Opposer alleges that, upon actual knowledge with respect to Opposer’s own acts, and upon information and belief as to other matters:

**Opposer and its PUCCI and EMILIO PUCCI Name and Marks**

1. Opposer Emilio Pucci International BV, is a besloten vennootschap (b.v.), organized under the laws of the Netherlands, having a business address at Oude Utrechtseweg 22-24, KN Baarn, NL-3743, Netherlands.
2. Over the past sixty years, Opposer has been in the business of designing, producing, marketing, distributing, and selling luxury goods, including clothing, scarves,

hats, jewelry, and handbags in connection with its EMILIO PUCCI trademark and trade name.

3. Opposer has used its trademark and name EMILIO PUCCI in commerce for clothing, scarves, and hats since at least as early as January 1950.

4. Opposer has used its trademark and name EMILIO PUCCI in commerce for leather goods including ladies' handbags, tote bags, and wallets since at least as early as January 1965.

5. Further, Opposer has used its EMILIO PUCCI name and mark in commerce in connection with ladies' tailored apparel; namely, dresses, scarves, lingerie, hats, bathing suits, skirts, blouses, slacks; and leather goods; namely, ladies' handbags, tote bags and other related goods, since well prior to the April 24, 2013 filing date of the opposed application and the April 15, 1985 first use date alleged by Applicant.

6. Opposer owns the following valid and subsisting federal registrations for the PUCCI and EMILIO PUCCI name and marks (collectively "PUCCI Names and Marks") (printouts from the PTO TESS/TARR and Assignment database are attached as Exhibit A) (collectively the goods and services set forth below and in Paragraphs 2-8 above are referred to as "Opposer's Goods and Services"):

7. The foregoing registrations are valid and subsisting and constitute *prima facie* evidence of the validity of the marks and registrations, and of Opposer's ownership of and exclusive right to use the marks in commerce.

8. The PUCCI Names and Marks are among the most famous fashion brands in the world. For nearly sixty years, the PUCCI Names and Marks have received extensive unsolicited attention from the local, national, and international media, including but not limited to nationally circulated publications and broadcast media such

as *Newsweek*, *Vogue*, *Vanity Fair*, *House & Garden*, *Women's Wear Daily*, *The New York Post*, *The Washington Post*, *The Los Angeles Times*, *The International Herald Tribune*, and *The San Francisco Chronicle*, and CNN, "The Today Show" on NBC, "The Early Show" on CBS, and "Good Morning America" on ABC. Many of these publications and television programs specifically recognize the fame of Emilio Pucci, the designer, and/or his eponymous fashion label. In addition, nationally circulated magazines such as *Vogue*, *Esquire*, *Glamour*, *Elle*, *Harper's Bazaar*, *Time Style & Design*, and *The New York Times Magazine*, have featured and identified Emilio Pucci's products and the EMILIO PUCCI mark in unsolicited editorial advertisements. Similarly, for many years, national publications have used and recognized PUCCI per se as synonymous for EMILIO PUCCI.

9. Over the years, Emilio Pucci (both the designer and the company) have received numerous fashion industry awards which have put the EMILIO PUCCI name and mark in the public spotlight. Emilio Pucci won the prestigious Neiman-Marcus Award (1954) and Sports Illustrated Design Award (1961), the latter voted on by retailers and fashion journalists. In 1991, Emilio Pucci was honored with the Council of Fashion Designers of America award, and in 2000, Emilio Pucci earned the Fashion Excellence Award at the Dallas Fashion Awards (voted on by retailers), which is awarded to a company that has "made an indelible mark on the industry." All of these awards highlight the substantial recognition of the PUCCI Names and Marks over several decades.

10. For nearly six decades, Emilio Pucci's branded products have been endorsed by Hollywood's most famous celebrities, giving the PUCCI Names and Marks significant consumer exposure. Emilio Pucci's products received endorsements from

Marilyn Monroe, Jackie Kennedy, Grace Kelly, Lauren Bacall, Elizabeth Taylor, Audrey Hepburn, Sophia Loren, Rita Hayworth, Catherine DeNeuve, Brigitte Bardot, and Greta Garbo, just to name a few. Further, celebrities who are known to wear EMILIO PUCCI apparel include Isabella Rossellini, Madonna, Nicole Kidman, Jennifer Lopez, Kylie Minogue, and Elizabeth Hurley.

11. All of the Opposer's retail stores have exterior signage displaying one or more of the PUCCI Names and Marks. The company's stores are located in high-traffic, high-visibility locations in premier shopping areas across the country (e.g., Fifth Avenue in New York City, the Forum Shops at Caesar's Palace in Las Vegas, the Bal Harbour shops in Miami, etc.), exposing millions of consumers to the PUCCI Names and Marks each year. A representative sample of the prominent use of the PUCCI Names and Marks on store signage is shown below.



12. As a result of extensive use, advertising, and promotion, Opposer's PUCCI Names and Marks have achieved such widespread public recognition that they have become well known and famous among the general public for the goods and services set forth above.

13. Indeed, the Trademark Trial and Appeal Board in *Emilio Pucci Int. B.V. v. El Corte Ingles, S.A.*, (Opposition Nos. 91169638 and 91177724) (TTAB April 1, 2010) recently held that Opposer's EMILIO PUCCI mark enjoys "substantial renown" and fame among the general public as to at least apparel and accessories.

**Applicant and The ST. PUCCHI Application**

14. Upon information and belief, Rani Sachdev is an individual citizen of the United States having an address of 4930 Los Feliz Blvd., Los Angeles, California 90027.

15. Applicant is the listed owner of Application Serial No. 85913782, filed April 24, 2013 under Section 1(a), 15 U.S.C. § 1051(a), for the mark ST. PUCCHI for "evening dresses; evening gowns; veils; wedding dresses; wedding gowns; women's clothing, namely, shirts, dresses, skirts, blouses" in Class 25, alleging a date of first use in commerce of April 15, 1985 ("the Application").

16. On or about April 24, 2013, Rani Sachdev, as "Owner," signed a declaration under 18 U.S.C. Section 1001 in support of the Application stating, *inter alia*, that he believes that he is entitled to use the mark in commerce and that no other person, firm, corporation, or association, to the best of its knowledge and belief, has the right to use such mark in commerce either in the identical form or in such near resemblance thereto as to be likely to cause confusion, or to cause mistake, or to deceive, and that all statements are true.

17. In the subject application, filed on April 24, 2013, Sachdev claims ownership of Registration No. 1841898 for the mark ST. PUCCHI. However, PTO records list St. Pucchi, Inc. as the owner of Registration No. 1841898.

18. A review of the PTO records reflects that a total of five applications have been filed for the marks ST. PUCCHI and PUCCHI for nearly identical goods since 1993. Three of the applications listed St. Pucchi, Inc. of Dallas, Texas as the owner. The remaining two applications list individuals Rani Totman and Montree Rajkitkul as the owners. The table below lists the relevant details for all five applications.

19. Notably, in an office action issued on May 19, 2010 in Application Serial No. 85011284 filed by Montree Rajki for a ST. PUCCHI stylized mark *identical* to the ST. PUCCHI mark opposed here, the Examining Attorney refused the application citing a likelihood of confusion, under Trademark Act Section 2(d), with Opposer's Registration 3252030. In that Office Action, the Examining Attorney notes "the only appreciable difference in the marks is the addition of the term 'ST.' to the applicant's mark. The slight difference in spelling does not alter the commercial impression in any

serious manner. There is no correct pronunciation of a mark because it is impossible to predict how the public will pronounce a particular mark.” The applicant failed respond to that office action, and Application Serial No. 85011284 was abandoned.

**Likelihood of Confusion, 15 U.S.C. § 1052(d)**

20. Opposer repeats and realleges each and every allegation set forth above.

21. Opposer has priority based on its prior valid and subsisting registrations for its PUCCI Names and Marks set forth above. Further, Opposer has priority based on its use of the PUCCI Names and Marks since well before the filing date of the opposed application and the first use date alleged by Applicant.

22. Applicant seeks registration of the ST. PUCCHI (stylized) mark in connection with goods that are identical and/or closely related to Opposer’s Goods and Services.

23. Applicant’s ST. PUCCHI mark encompasses the entirety of Opposer’s PUCCI name and mark, and it is similar in overall sound, appearance, connotation, and commercial impression to Opposer’s PUCCI Names and Marks.

24. In view of the similarity of the parties’ marks, and the relatedness of the parties respective goods and services, Applicant’s ST. PUCCHI mark so resembles Opposer’s previously used and registered PUCCI Names and Marks, as to be likely to cause confusion, or to cause mistake, or to deceive in violation of Section 2(d), 15 U.S.C. § 1052(d).

**Dilution, 15 U.S.C. § 1125(c)(1)**

25. Opposer repeats and realleges each and every allegation set forth above.

26. Opposer's PUCCI Names and Marks became famous well before the filing date of Application No. 85913782, and the April 15, 1985 first use date alleged by Applicant.

27. Applicant's ST. PUCCHI mark so resembles Opposer's previously used and registered PUCCI Names and Marks, as to be likely to cause dilution of the distinctive quality of Opposer's famous marks and trade name in violation of Section 43(c), 15 U.S.C. § 1125(c).

**Lack of Ownership/Entitlement to Use**

28. Pucchi repeats and realleges each and every allegation set forth above.

29. On or about April 24, 2013, Rani Sachdev, as "Owner," signed a declaration under 18 U.S.C. Section 1001 in support of the Application stating, *inter alia*, that he believes that he is entitled to use the mark in commerce and that no other person, firm, corporation, or association, to the best of its knowledge and belief, has the right to use such mark in commerce either in the identical form or in such near resemblance thereto as to be likely to cause confusion, or to cause mistake, or to deceive, and that all statements are true.

30. In the subject application, filed on April 24, 2013, Sachdev claims ownership of Registration No. 1841898 for the mark ST. PUCCHI. PTO records list St. Pucchi, Inc. as the owner of Registration No. 1841898.

31. Upon information and belief, Applicant is not now and has never been the owner of the ST. PUCCHI mark or entitled to use or register the ST. PUCCHI mark.

32. Accordingly, the Application is void ab initio because Applicant was not the owner of the mark or entitled to use, or register the mark in commerce for the identified goods at the time it was signed and filed and continuing to date.

WHEREFORE, Opposer is being and will be damaged by the registration of the ST. PUCCHI mark, and respectfully requests that this opposition be sustained, and that the mark shown in Application Serial No. 85913782 be refused registration.
