Opposer Chapter 4 Corp. d/b/a Supreme (“Opposer” or “Supreme”), a corporation organized under the laws of the State of New York, with its principal place of business at 121 Wooster Street, 2F, New York, NY 10012, believes that it will be damaged by registration of the mark shown in Application Serial No. 86/137,851 and hereby opposes the same. The grounds for Opposition are as follows:

1. Supreme is a fashion company created in 1994 in downtown Manhattan specializing in the sale of high-end street/skater fashion. Over its 18 year history, Supreme became the home of New York City skate culture.
2. Supreme has worked with groundbreaking designers, artists, photographers and musicians – all of whom have helped continue to define Supreme’s unique identity and attitude.
3. Supreme’s fashion articles, skateboards and accessories, including, but not limited to, bags, key chains, stickers and cell phone accessories are produced in very small and limited

quantities and sold solely through its website (www.supremenewyork.com) and its boutiques in the U.S., the U.K. and Japan.

4. Supreme is admired by fans across the world and has garnered tremendous amounts of unsolicited publicity for its cutting-edge clothing, headwear, footwear, bags, skateboards and accessories, being featured in several prominent magazines, many of which several times.

5. Supreme is promoted throughout the United States, via the Internet, and through the website <www.supremenewyork.com>, Facebook, Twitter, MySpace as well as other social media.

6. Opposer has continuously used the mark SUPREME in interstate commerce since at least as early as 1994.

7. Opposer is the owner of the following federal trademark registrations and pending trademark applications (hereinafter referred to as the “SUPREME Marks”):

8. A copy of Supreme's valid and subsisting registrations and applications, along with copies of TSDR printouts for each of the SUPREME Marks, are attached hereto as Exhibit A. Opposer hereby gives notice in accordance with Trademark Rules of Practice 2.122(d)(2) that it will rely upon these registrations and applications as evidence in this proceeding, and a status copy showing present title will be introduced into evidence on its behalf during Opposer's testimony period. Furthermore, these registrations and applications are valid, subsisting and in full force and effect and serve as evidence of Opposer's exclusive right to use the mark in

commerce on or in connection with the goods identified in the registrations and applications, as provided by 15 U.S.C. § 1155(a).

9. Opposer has spent substantial time, effort and money promoting its goods under the SUPREME Marks. As a result of Supreme's dominance of the fashion industry and the solicited and unsolicited publicity it has received, the SUPREME Marks have become well-known by the general public and in the relevant industries, are recognized and relied upon as identifying Opposer's goods and as distinguishing them from the goods of others, and have come to represent and symbolize extremely valuable goodwill belonging exclusively to Opposer. Through these efforts, the SUPREME Marks have become famous within the meaning of Section 43(c) of the Lanham Act, as amended 15 U.S.C. § 1125(c).

10. Upon information and belief, Applicant Gregory C. Blissman is an individual with an address 1764 Naser Road, North Versailles, Pennsylvania 15137.

11. Upon information and belief, on December 8, 2013, Applicant filed an intent-to-use application for the mark SUPREME STYLE covering Class 18 "handbags" ("Applicant's Mark").

12. Opposer has continuously and exclusively used the SUPREME Marks in connection with its goods prior to the date on which Applicant filed its intent-to-use application on December 8, 2013. As such, Opposer has priority.

13. The dominant feature of Applicant's Mark is the term SUPREME. Applicant's SUPREME MARK is nearly identical to Opposer's SUPREME Marks in sight, sound, meaning and commercial impression. The inclusion of the generic term "style" does not distinguish

Applicant's Mark visually, aurally or in meaning. In fact, Applicant acknowledges that the term "style" is generic by specifically including a disclaimer of the term in the Application.

14. Applicant's Mark is intended to be used in connection with similar and/or identical goods with which Opposer uses its famous SUPREME Marks.

15. Neither the SUPREME STYLE application nor Opposer's SUPREME Marks are limited with respect to channels of trade, therefore, the parties' goods will presumably travel through the same channels of trade.

16. Upon information and belief, Opposer and Applicant will market and promote their respective goods to the general consuming public without regard to sophistication.

17. Applicant's use of the SUPREME STYLE mark is likely to cause confusion, mistake or deception with consequent injury to Opposer and the public. Such use and registration of the SUPREME STYLE mark is likely to cause consumers to mistakenly believe that Applicant's goods emanate from Opposer or that Applicant is in some way associated with or connected to Opposer, when, in fact, no such relationship exists.

18. If Applicant is granted registration for the SUPREME STYLE mark, it would obtain, thereby, at least a prima facie exclusive right to use the mark. Such registration would be a source of damage and injury to Opposer.

19. Registration should be refused pursuant to Section 2(d) of the Trademark Act of 1946, as amended, 15 U.S.C. § 1052(d), on the grounds that the SUPREME STYLE mark so resembles Opposer's SUPREME Marks as to cause confusion, mistake and/or deception, all to the damage of Opposer.

20. Opposer's SUPREME Marks became famous before the filing date of Applicant's Application Serial No. 86/137,85.

21. Opposer will be damaged by registration of Application Serial No. 86/137,851 because such registration will support Applicant's dilution of Opposer's famous SUPREME Marks and will give color of exclusive statutory right to Applicant in violation and derogation of the prior and superior rights of Opposer.

22. Applicant's SUPREME STYLE mark is likely to cause dilution by blurring of Opposer's famous, distinctive and federally-registered SUPREME Marks within the meaning of 15 U.S.C. § 1125(c), and registration of Applicant's Mark should therefore be refused.

23. Applicant's SUPREME STYLE mark and Opposer's SUPREME Marks are sufficiently similar, and therefore, Applicant's Mark impairs and is likely to impair the distinctiveness of Opposer's SUPREME Marks.

WHEREFORE, Opposer, by its undersigned attorneys, requests that its opposition to Application Serial No. 86/137,851 be sustained and that the Trademark Trial and Appeal Board grant any and all further relief to Opposer that the Board finds necessary and just in the circumstances.


