NOTICE OF OPPOSITION

Carl's Jr. Restaurants LLC, a Delaware limited liability company, located and doing business at 6307 Carpinteria Avenue, Suite A, Carpinteria, CA 93013 ("Opposer") believes that it will be damaged by the registration of U.S. Service Mark Application Serial No. 86/091945 for the mark ORBITZ REWARDS SUPERSTAR in International Class 35 (the "Application"), filed on October 15, 2013 by Orbitz, LLC, a Delaware limited liability company with an address of 500 W. Madison St., Chicago, IL 60661 (hereinafter referred to as "Applicant") and therefore opposes the same.

As grounds for opposition, it is alleged:

1. Since at least as early as June 18, 1975, and long before Applicant filed the Application, Opposer has been using and has registered the mark SUPER STAR in connection with restaurant services. In addition, since at least as early as June 2013, and before Applicant filed the Application, Opposer has been using and has applied to register

the mark SUPER STAR REWARDS in connection with computer software and arranging and conducting incentive programs. The use of the SUPER STAR and SUPER STAR REWARDS marks (“Opposer’s Marks”) has been valid and continuous and has not been abandoned.

2. Opposer, through substantial use and promotion, has acquired significant goodwill and consumer recognition in Opposer’s Marks. In addition, by virtue of their substantial use and promotion, Opposer’s Marks have become famous in the minds of consumers. Opposer’s Marks became famous in the minds of consumers long before Applicant filed the Application.

3. Opposer is the owner of and relies upon incontestable United States Service Mark Registration No. 1099039 for the mark SUPER STAR[®] for “preparing and serving hamburgers as part of restaurant services” in International Class 42. The application for this mark was filed on May 9, 1977 and registered on August 8, 1978. Opposer first used this mark and obtained its registration over 35 years before Applicant filed the Application.

4. Opposer is the owner of and relies upon United States Service Mark Application No. 85/921991 for the mark SUPER STAR REWARDS for “computer application software for mobile devices, namely, software for use with incentive programs to promote the sale of food and beverage items for consumption on or off the premises” in International Class 9 and “arranging and conducting incentive programs to promote the sale of food and beverage items for consumption on or off the premises” in International Class 35. The application for this mark was filed on May 2, 2013. Opposer has used the mark since at least as early as June 2013. Opposer applied for this mark and first used this mark before Applicant filed the Application.

5. Opposer’s registration as specified in Paragraph 3 is incontestable. As such, it constitutes conclusive evidence of the validity of the registered mark and of the registration of

the mark, of Opposer's ownership of its mark, and of Opposer's exclusive right to use the registered mark in commerce as provided in Section 33 of the Lanham Act, 15 U.S.C. § 1115.

6. Opposer's registration as specified in Paragraph 3 is valid, subsisting, unrevoked, uncanceled, and not abandoned. As such, it constitutes prima facie evidence of the validity of the registered mark and of the registration thereof, Opposer's ownership of the mark shown therein, and Opposer's exclusive right to use its mark in commerce in connection with the services named therein, without condition or limitation. Said registration also constitutes notice to Applicant of Opposer's claim of ownership of the mark shown therein, all as provided in Sections 7(b), 22 and 33(a) of the Trademark Act of 1946, as amended. True and correct copies of printouts from the electronic database records (TSDR) of the U.S. Patent and Trademark Office showing the current status and title of the registration for the mark discussed in Paragraph 3 and the application for the mark discussed in Paragraph 4 are attached hereto.

7. Opposer's dates of first use and filing dates for the above registration and application precede the filing date of the Application.

8. In view of the substantial similarity between Opposer's Marks for SUPER STAR and SUPER STAR REWARDS for restaurant services and arranging and conducting incentive programs and the Application for ORBITZ REWARDS SUPERSTAR for providing incentive awards programs, it is alleged that Applicant's mark so resembles Opposer's Marks as to be likely to cause confusion or to cause mistake or deceive under Section 2(d) of the Trademark Act. In view of Opposer's prior statutory and common law trademark rights, Applicant is not entitled to registration of the Application pursuant to Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d) in Class 35.

9. By reason of the foregoing, Opposer will be damaged by the registration of U.S. Service Mark Application Serial No. 86/091945 for the mark ORBITZ REWARDS

SUPERSTAR in Class 35.

WHEREFORE, Opposer requests that U.S. Service Mark Application Serial No. 86/091945 for the mark ORBITZ REWARDS SUPERSTAR be rejected and stricken in Class 35, that no Class 35 registration be issued thereon to Applicant, and this opposition be sustained in favor of Opposer.
