**APPLICANT MONSTER HOOKS, INC.'S  
AMENDED NOTICE OF RELIANCE**

Pursuant to 37 C.F.R. § 2.122 and Chapter 700 of the TBMP, Applicant Monster Hooks, Inc. intends to rely on the documents submitted through this Amended Notice of Reliance in support of its position in these consolidated proceedings. The Applicant is resubmitting its Notice of Reliance in the form of this Amended Notice to cure the defects to the materials submitted in Exhibits B and F in Applicant Monster Hooks, Inc.'s First Notice of Reliance filed on February 19, 2019.

**Exhibit A:** Screenshots from Applicant's website and social media sites. These screenshots show the dissimilarity of Opposer's and Applicant's goods, the dissimilarity of the marks, the dissimilarity of Applicant's and Opposer's target markets, the manner in which Applicant's goods are advertised to consumers, and the unlikelihood of confusion. The websites are publicly

available and were last visited on February 19, 2019.

**Exhibit B:** Screenshots from <http://www.monster.com> and <http://www.monsterstore.com>, both owned by third parties unrelated to Opposer. The existence of these third-party companies prove that Opposer is not the exclusive, nor even the primary, user of the term “MONSTER” in connection with commercial goods, and that the public’s primary association with “MONSTER” is with entities other than Opposer. The websites are publicly available and were last visited on September 12, 2019.

**Exhibit C:** Screenshots from Encyclopedia Britannica’s entries for the word “monster.” These screenshots confirm that the general public associates “MONSTER” with Monster.com, which is not related to nor owned by Opposer. The list, which was last visited on January 26, 2019 and is publicly available, also reveals that Opposer Monster Energy Company does not appear in the first 100 Encyclopedia entries for “MONSTER.” This undermines Opposer’s claim of fame and shows that Opposer does not enjoy exclusivity or even dominance over the common “MONSTER” portion of its mark.

**Exhibit D:** Screenshots from Opposer’s website at <https://www.monsterenergy.com> and Opposer’s Google homepage. This exhibit shows that Opposer is not in the business of selling aftermarket motor vehicle towing accessories generally, nor metal tow hooks specifically. Opposer’s website also shows that Opposer is primarily a purveyor of energy drinks, and that consumers primarily associate Opposer with energy drinks. This exhibit further demonstrates that Opposer does not use the term “MONSTER” alone as a source identifier, but instead uses the term in conjunction with the additional term “ENERGY,” as shown in its domain name ([www.monsterenergy.com](http://www.monsterenergy.com)), website headers, footers, favicons, icons, Google homepage, and social media handle (@monsterenergy). These facts support the unlikelihood of consumer confusion between Opposer and Applicant. The websites are publicly available and were last

visited on February 19, 2019.

**Exhibit E:** Evidence showing a complete line of energy drinks currently offered for sale in commerce by third-party company Cytosport under “MONSTER” formative marks, showing that even in Opposer’s primary class of energy drinks and nutritional supplements, Opposer is not the exclusive user of “MONSTER.”

**Exhibit F:** E-commerce websites showing the term “MONSTER” in use by various third parties in specific connection with automotive parts, supplies, trucks, and vehicles, showing that numerous “MONSTER” marks can successfully co-exist in the marketplace, that the field is crowded and thus that “MONSTER” is a weak formative, and that Opposer is not the exclusive owner of the term. All websites are publicly available and show the URL and date visited.

**Exhibit G:** Printouts from the USPTO’s Trademark Search and Document Retrieval database, generated between January 26 and February 19, 2019, showing current Registration Certificates for dozens of “MONSTER” formative trademarks, none of which are owned by Opposer. These third-party registrations show that Opposer does not own the exclusive right to use the word “MONSTER,” that the field of “MONSTER” marks is a crowded one, and that multiple “MONSTER” marks can co-exist even within a single class, let alone in unrelated classes such as Opposer’s and Applicant’s. The exhibit shows the unlikelihood of confusion between the marks and undermines Opposer’s claim of fame.
