

NOTICE OF OPPOSITION

Chanel, Inc., a New York corporation organized and existing under the laws of the state of New York, located and doing business at 9 West 57th Street, New York, New York 10019 (“Opposer”), believes that it will be damaged by the issuance of a registration for the mark COCOTIQUE shown in Application Serial No. 85/876,565 for goods including “Hair care, bath and cosmetic products, namely, eye shadow, eye liner, liquid eye liner, mascara, blush, lip liner, eyebrow pencils, lipstick, lip gloss, lip balms, cotton puffs for makeup, cosmetic and lip color palettes, under eye concealers, foundations, face powders, soaps, bath oils, skin moisturizers, fragrances for personal use, perfumes, deodorants for personal use, talcum powder, shampoos, conditioners, hair styling oils, hair styling gels, non-medicated hair styling treatment preparation

for cosmetic purposes and hair styling sprays, nail polish, skin bronzers, sun tan lotions, sun screens, facial cleansers, and facial toners; non-medicated hair removal and hair growth preparations, non-medicated skin care preparations and treatments for cosmetic purposes, skin moisturizer, nail care preparations, emery boards; cosmetic preparations; cosmetics; eyebrow cosmetics; cosmetic rouges, soaps, cosmetic masks, facial masks, hair and body masks, eye pencils, eyebrow pencils, make-up pencils, cosmetic pads,” in International Class 3, and therefore opposes the same. As grounds for its opposition, Opposer, alleges as follows:

FACTS COMMON TO ALL COUNTS

1. Opposer is a premier manufacturer and seller of a wide variety of luxury goods and is a recognized leader in the field of fragrance, beauty and fashion. Chanel’s products, renowned for their high quality, are sold throughout the United States.
2. Chanel’s founder was Gabrielle “Coco” Chanel. In recognition of and in reference to Coco Chanel, Chanel has been using COCO and marks that include the term COCO (collectively the “COCO Marks”) as trademarks for decades. The COCO Marks have been used on and in connection with a wide range of products and the promotion thereof including clothing, bags, jewelry, cosmetics, fragrances.
3. Decades ago, and prior to any date upon which the Applicant can rely, Chanel introduced its COCO line of fragrances including parfum, eau de parfum and eau de toilette. Chanel has sold tens of millions of dollars worth of COCO branded fragrance and lotion products in the United States since its launch. The COCO line of fragrance products was extended in 2001 when Plaintiff introduced COCO MADEMOISELLE for parfum, eau de parfum, eau de toilette and other products. Since 2001, Chanel has sold tens of millions of

dollars worth of COCO MADEMOISELLE products in the United States. Most recently, the COCO line of fragrances was further extended in August 2012 with the launch of COCO NOIR.

4. In addition to its range of fragrance and lotion products under the COCO, COCO MADEMOISELLE and COCO NOIR marks, Chanel has used COCO for a line of lipsticks sold under the mark ROUGE COCO, and has also used COCO to designate shades including COCO RED and COCO PINK for lipsticks.

5. Chanel owns numerous federal trademark registrations for the COCO Marks including but not limited to:

All of the listed registrations are valid, subsisting and in full force and effect, and constitute prima facie evidence of the validity of the mark and of Opposer's exclusive right to use the mark on the goods identified in the registration. In addition, those registrations marked with an

asterisk are incontestable, meaning that they serve as conclusive evidence of Opposer's exclusive right to use the identified COCO Mark in connection with the identified products. Printouts from the United States Patent and Trademark Office's online database reflecting the registrations identified above are attached as Exhibit A and are made part of the record in these proceedings.

6. The COCO Marks are reproduced on millions of dollars worth of consumer goods and are seen in advertising that reaches hundreds of millions of consumers. As a result of Opposer's efforts, the COCO Marks have become extremely well known and products bearing the marks are highly desirable.

7. As a result of Opposer's use for decades of the COCO Marks, its sales of millions of dollars of goods under the marks, and its advertising of goods bearing the marks, the COCO Marks have become famous and well-known to the consuming public and the trade as identifying and distinguishing goods exclusively from, or authorized by, Opposer.

8. Upon information and belief, Applicant is a Delaware corporation with an office located in Maryland.

9. Upon information and belief, and according to the records of the United States Patent and Trademark Office ("PTO"), on or about March 14, 2013, Applicant filed Application Serial No. 85/876,565 to register COCOTIQUE for, among other goods and services, a wide variety of cosmetics, beauty care, skincare, fragrance, and personal care products International Class 3, as more specifically detailed more specifically above.

10. The opposed application is based on an intent to use, thus the earliest date that Applicant can assert for purposes of priority is its filing date March 14, 2013, which is decades after Opposer began use of its various COCO Marks and after Opposer had obtained numerous registrations for its COCO Marks.

11. Based on Opposer's federal trademark registrations for its COCO Marks, Applicant was deemed on constructive notice of Opposer's rights in those marks.

12. There has never been any relationship between Applicant and Opposer and Opposer has never authorized or consented to Applicant's use or application to register the mark opposed herein.

13. The COCOTIQUE application incorporates in its entirety Opposer's long used and federally registered COCO Mark.

COUNT I: CLAIM FOR RELIEF UNDER SECTION 2(d)

14. Opposer repeats the allegations contained in paragraphs 1 through 13 as if fully set forth herein.

15. Opposer's rights in its COCO Marks were established long prior to any date on which Applicant may rely.

16. The COCOTIQUE mark opposed herein is substantially similar to both Opposer's famous and federally registered COCO Mark, and to Opposer's various COCO formative marks. Opposer has long used COCO in or as part as a variety of marks including but not limited to COCO MADEMOISELLE, COCO CHANEL, COCO NOIR and ROUGE COCO. The mark opposed herein, COCOTIQUE, continues Opposer's long tradition of using its COCO Mark together with another term. As such consumers will believe COCOTIQUE to be yet another of Chanel's COCO Marks.

17. Applicant seeks to register the COCOTIQUE mark for goods that are identical to those Opposer offers under its COCO Marks and that are the subject of Opposer's federal trademark registrations as well as for goods highly related to those provided under Opposer's COCO Marks.

18. As a matter of law it is presumed that Applicant's International Class 3 goods including fragrances, lotions, and other items are or will be sold in all channels of trade through which such goods generally are sold. Such channels of trade are or would be identical to the channels of trade through which Opposer offers its identical or related products under its COCO Marks. In addition, the consumers for goods offered under Applicant's mark are presumed to be identical to Opposer's consumers since both Applicant and Opposer are offering, under their respective marks, identical or highly related products.

19. By virtue of Opposer's use and registration of the COCO Marks and the goodwill and fame associated with those marks, the registration by Applicant of a mark that incorporates the COCO trademark and is highly similar to Opposer's prior used COCO formative marks for goods identical or highly related to those provided by Opposer, sold through the same channels of trade and to the same consumers as Opposer's goods, is likely to create the erroneous impression that Applicant's goods bearing the COCOTIQUE mark originate from, come from, or are otherwise associated with Opposer or that Applicant's goods are endorsed, sponsored, or in some way connected with Opposer. Registration of the COCOTIQUE mark is likely to cause confusion, cause mistake, or to deceive the public in violation of Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d).

20. Registration of Applicant's mark would be inconsistent with Opposer's prior rights in the COCO Marks, would be inconsistent with Opposer's statutory grant of exclusivity of use of the registered COCO Marks, and would destroy Opposer's investment and good will in its COCO Marks.

COUNT II: CLAIM FOR RELIEF UNDER 15 U.S.C. § 1063 – DILUTION

21. Opposer incorporates by reference paragraphs 1 through 13 as if fully set forth herein.

22. Pursuant to 15 U.S.C. § 1063, any person who believes he would be damaged by registration of a mark, including as a result of dilution, may oppose an application.

23. Opposer's COCO Marks are famous and well-known throughout the United States, having been used, advertised and publicized extensively throughout this country for over forty years. The COCO Marks are inherently distinctive, and have become associated exclusively with Opposer by reason of Opposer's extensive advertising and use of the mark for decades on or in connection with a wide variety of products, is the subject of numerous federal trademark registrations, is widely recognized by the general consuming public as a designation of source of Opposer's goods and services.

24. Opposer's rights in the COCO Marks were established long prior to any date upon which the Applicant can rely.

25. Applicant's applied-for mark COCOTIQUE is nearly identical to Opposer's famous, registered, and long used COCO Marka and calls to mind Opposer's famous COCO Marks. As a result, registration of COCOTIQUE to Applicant would dilute or would be likely to dilute Opposer's COCO Marks by impairing the distinctiveness of Opposer's COCO Marks to identify exclusively goods and services from Opposer. Accordingly, registration of the mark shown in the application herein opposed violates the Lanham Act.

26. By reason of the foregoing, Opposer is likely to be harmed by registration of the opposed application for the COCOTIQUE mark shown in Application Ser. No. 85/876,565.




