**STIPULATED MOTION TO SUSPEND PROCEEDINGS FOR SETTLEMENT**

Pursuant to Board Rule 510.03(a), IGT, with Double Down, Inc.’s consent, submits this motion requesting that the Board further suspend this consolidated proceeding for thirty (30) days (until November 9, 2015) to allow the parties time to conclude settlement negotiations.

The parties conducted an in-person settlement meeting on Thursday, August 27, 2015; and, since then, the parties have been in discussions to determine if an amicable resolution may be reached without further burdening the Board. Settlement discussions have been delayed due to IGT’s attendance at the Global Gaming Expo, which concludes October 2, 2015. Good cause therefore exists for this motion.

On September 9, 2015, the Board granted IGT’s consented motion (filed August 28, 2015) to suspend all deadlines for thirty days to allow the parties time to conclude their

settlement negotiations, and further deferred Double Down, Inc.'s motion for additional discovery pursuant to Fed. R. Civ. P. 56(d).

The parties respectfully request that the Board further suspend these proceedings until November 9, 2015 (for an additional thirty (30) days) and reset IGT's deadline for responding to Double Down, Inc.'s motion for additional discovery to November 11, 2015. All other deadlines shall remain suspended in accordance with the Board's July 23, 2015 order.
