**STIPULATED MOTION TO SUSPEND PROCEEDINGS FOR SETTLEMENT**

Pursuant to Board Rule 510.03(a), IGT, with Double Down, Inc.’s consent, submits this motion requesting that the Board further suspend this consolidated proceeding by nine (9) days (until November 18, 2015) to allow the parties time to conclude settlement negotiations.

The parties conducted an in-person settlement meeting on Thursday, August 27, 2015; and, since then, the parties have exchanged multiple settlement offers and have been in continuous discussions to determine if an amicable resolution may be reached without further burdening the Board. The parties believe that a further, short extension will allow them sufficient time to conclude their discussion. Good cause therefore exists for this motion.

The Board granted two previous consented motions (filed August 28, 2015 and September 30, 2015) to suspend all deadlines by a total of sixty days, and further deferring Double Down, Inc.'s motion for additional discovery pursuant to Fed. R. Civ. P. 56(d).

The parties respectfully request that the Board further suspend these proceedings until November 18, 2015 (for an additional nine (9) days) and reset IGT's deadline for responding to Double Down, Inc.'s motion for additional discovery to November 20, 2015. All other deadlines shall remain suspended in accordance with the Board's July 23, 2015 order.
