NOTICE OF OPPOSITION

PIZZERIA UNO CORPORATION (Opposer), a Delaware corporation with an office at 1209 Orange Street, Wilmington, Delaware 19801, believes that it will be damaged by registration of the mark VINO UNO & Design, which mark is the subject of Application Serial No. 85/963,551 filed by Pollington Sirjani Beverly of Irvine, California, and which mark was published for opposition in the *Official Gazette* of July 8, 2014.

The grounds for the opposition are as follows:

1. Applicant seeks to register the mark VINO UNO, in the design form shown immediately below [VINO disclaimed], as a trademark for “alcoholic beverages except beers” (in international class 33).

Vino Uno

2. The opposed Application was filed on June 18, 2013, based upon alleged use of the mark in commerce since June 3, 2013.

3. In 1943, Opposer's predecessor in interest adopted the marks and names UNO and PIZZERIA UNO, and Opposer and its predecessors have since used said marks and names, and variations thereof, continuously and extensively in interstate commerce in connection with restaurant services and food products, including the serving of beverages, both alcoholic (including wine) and non-alcoholic. Among the beverages served in Opposer's restaurants have been liquid refreshments offered under the marks UNO AMBER ALE®, CAFE UNO®, UNO COLADA, SANGRIA PUNCHERUNO, UNO RASPBERRY LIME RICKEY, UNO SOUTHSIDE LEMONADE, THE UNO BLOODY MARY, and UNOMARTINI. Furthermore, Opposer currently licenses the mark UNO to a third-party for use in connection with the marketing and sale of wines under the mark PURO UNO.

4. There are presently in operation more than one hundred and forty UNO restaurants throughout the United States, which collectively serve millions of customers each year. In addition, Opposer has extensively and continuously used its marks and names UNO and PIZZERIA UNO and variations thereof for many years in connection with the sale of food products in retail stores. Through extensive advertising, promotion, and use of the marks and names UNO and PIZZERIA UNO and variations thereof, Opposer has built a strong national reputation for high quality restaurant services and food and beverage products sold under its marks. The marks and names UNO and PIZZERIA UNO have, long prior to Applicant's filing date and alleged first use date, come to be famous, and they uniquely and distinctively identify Opposer and its products and services.

5. Opposer is the owner of, *inter alia*, the United States Trademark and Service Mark Registrations listed immediately below. Pursuant to Trademark Rule 2.122(d), attached hereto for each listed registration is the current printout of information from the electronic database records of the USPTO showing the registration's current status and title.

6. The goods set forth in Application Serial No. 85/963,551 are closely related, or identical, to the goods and services in connection with which Opposer has used and is using its UNO, PIZZERIA UNO, and related marks. On information and

belief, Applicant's goods will be offered to the same general class of customers who purchase the goods and services in connection with which Opposer has used and is using its various UNO and PIZZERIA UNO marks.

7. The applied-for mark sought to be registered by Applicant incorporates Opposer's registered mark UNO and is substantially similar to Opposer's marks set forth above.

8. Consequently, if Applicant's mark is used in connection with the goods identified in Application Serial No. 85/963,511, it would be likely to cause confusion, mistake, or deception of the relevant trade and public. Customers and potential customers are likely to believe that Applicant's goods offered under the mark VINO UNO & Design emanate from, or are licensed or approved by, Opposer, when that is not the case. Such confusion would be a source of damage to Opposer.

9. If Applicant is granted the registration herein opposed, it would thereby obtain a *prima facie* exclusive right to use of the mark VINO UNO & Design, which would be a further source of damage to Opposer.

WHEREFORE, Opposer believes that it will be damaged by registration of said mark, and prays that this Opposition be sustained, that Application Serial No. 85/963,551 be rejected, and that the mark applied for therein be refused registration.


