Notice of Opposition

Selle Royal S.p.A. (“Opposer”), a Joint stock Company organized and existing under the laws of Italy, and having a principal place of business at Via Vittorio Emanuele, 119, 36050 Pozzoleone (VI) Italy, believes that it will be damaged by, and hereby opposes, the grant of the application of TW International, Inc. (“Applicant”) to register the mark “ROYALRIDER” shown in the application Serial Number 86/310,783 filed June 16, 2014 for “Scooters; Bicycles; Tricycles; Electric cars” in International Class 012. Pursuant to 15 U.S.C. Section 1052, by and through its attorneys, Opposer hereby opposes the same.

As grounds therefor, it is alleged that:

1. By the application Serial No. 86/310,783 herein opposed, Applicant is seeking to obtain registration on the Principal Register of ROYALRIDER (hereinafter “Applicant’s intended mark”) for goods in class 012, and particularly, for “Scooters; Bicycles; Tricycles; Electric cars” in Class 012.

2. Applicant's application Serial No. 86/310,783 for ROYALRIDER is an Intent to Use application filed on June 16, 2014 and such mark was published for opposition on November 11, 2014. This Notice of Opposition is timely filed.

3. Opposer is the owner of the following federal trademark registrations:
- a. No. 2,439,813 registered on the Principal Register on April 3, 2001, for the trademark SELLEROYAL (Design mark) for "Saddles and seats for bicycles, motor bicycles and motorcycles" in International Class 012 (hereinafter "SELLEROYAL '813).
 - b. No. 4,127,453 registered on the Principal Register on April 17, 2012, for the trademark SELLE ROYAL (Word mark) for "Saddles for bicycles, motorcycles and mopeds; bicycles, motorcycles and mopeds; accessories for bicycles, motorcycles and mopeds, namely, lamps, bells, brakes, frames, grip tape, kickstands, baskets and pannier bags, handlebar grips, horns, pumps, saddle covers, mudguards, rear view mirrors, saddlebags, safety pads, tires of two-wheeled motor vehicles or bicycle, water bottle holders, wheels, pedals, handlebars, stems, seatposts, forks, drive trains, trailers, luggage carriers, front and rear rack packs - all adapted for bicycles, motorcycles and mopeds; delivery bicycles; racing bicycles; road racing bicycles; tandem bicycles; touring bicycles; mountain bicycles; accessories for bicycles, namely, velomobile bodies, namely, specially adapted for weather protection shells for use on bicycles" in International Class 012 (hereinafter "SELLE ROYAL '453).
 - c. No. 4,335,446 registered on the Principal Register on May 14, 2013 for the trademark SR SELLE ROYAL (Design mark) for "Saddles for bicycles; Accessories for bicycles, namely, lamps, handlebar grips, saddle covers, saddlebags" in International Class 012 (hereinafter "SR SELLE ROYAL '446).

Printouts of information from the Trademark Status and Document Retrieval electronic database records of the USPTO showing the current status and title of the registrations listed above are attached hereto as **EXHIBIT A.**

4. Opposer's Registrations listed above have not been cancelled, are valid, and are now in full force and effect.

5. Opposer's Registration No. 2,439,813 is incontestable under Section 15 of the Lanham Act, 15 U.S.C. §1605. Consequently, at least this registration is conclusive evidence of the validity of the registered mark and of the registration of this mark, of Opposer's ownership of the mark, and of Opposer's exclusive right to use the registered mark in commerce under Section 33 of the Lanham Act, 15, U.S.C. §1115.

6. The Opposer has been continuously and prominently using its SELLEROYAL '813, SELLE ROYAL '453 and SR SELLE ROYAL '446 trademarks (collectively, "SELLE ROYAL trademarks") in connection with the bicycles, saddles and accessories for bicycles, motorcycles and mopeds goods that they manufacture and distribute and has been actively promoting and expanding its use of the marks.

7. As a result of the longtime and widespread use in commerce by the Opposer of the aforesaid SELLE ROYAL trademarks in connection with their respective goods, the marks have acquired extensive goodwill, have developed a high degree of distinctiveness, are assets of the Opposer, and are well known and recognized as identifying at least the listed goods which have their origin with or have been authorized by the Opposer. In addition, Opposer's SELLE ROYAL trademarks have reached the good reputation they enjoy, long prior to the filing date of Applicant's application.

8. Opposer has priority with respect to the mark at issue in this Opposition. Opposer adopted and commenced use of its SELLE ROYAL marks as trademarks long before Applicant filed its Intent to Use application. Opposer's first usage of its SELLE ROYAL '813 trademark commenced at least as early as 1994, at least twenty (20) years prior to the filing date of Applicant's application.

9. Applicant's mark ROYALRIDER is confusingly and deceptively similar to

Opposer's previously used and duly registered SELLE ROYAL trademarks in sound, appearance, meaning and commercial impression. In particular, the dominant parts of both parties' marks are identical, namely the distinctive term ROYAL.

10. Applicant's goods in Class 012 are closely related and/or identical to the goods in Class 012 sold and provided in connection with Opposer's SELLE ROYAL trademarks, and such goods would travel and/or be promoted through the same channels of trade for sale to, and use by, the same class of purchasers.

11. Due to the similarity between Applicant's intended mark and Opposer's previously used and duly registered SELLE ROYAL trademarks, including the closely related nature of the respective goods of the parties, Applicant's mark ROYALRIDER is likely to cause confusion, mistake or deception as to the source of origin of Applicant's goods in that the public, the trade and others are likely to believe that Applicant's goods are: (a) the same goods as Opposer's; and/or (b) endorsed, provided, sponsored, approved, licensed by, affiliated with or in some other way legitimately connected to Opposer and/or its goods or licensed products.

12. The use and registration by Applicant of its ROYALRIDER mark for Applicant's goods in Class 012 is likely to cause confusion or to cause mistake or deception in the trade and among purchasers and potential purchasers with Opposer's previously used and duly registered SELLE ROYAL trademarks, resulting in damage to Opposer.

13. Applicant's use and registration of its ROYALRIDER mark is likely to dilute the distinctive quality of Opposer's SELLE ROYAL trademarks, again resulting in damage to Opposer.

14. Registration of the mark shown in the Application Serial No. 79/121,992 will result in damage to Opposer under the provisions of Section 2(d) of United States Trademark Act, 15 U.S.C. 1052(d), pursuant to the allegations stated above.

WHEREFORE, Opposer respectfully requests that the Opposition be sustained and Application Serial Number 86/310,783 be refused registration.

Accompanying this Notice of Opposition is the required fee of \$300.00.
