NOTICE OF OPPOSITION

Opposer KELIN SRL (“KELIN”), is an Italian limited liability company with offices located at Via Carducci Giosuè, 32, I-20123 Milan, Italy.

Applicant, LANE BRYANT PURCHASING CORP. (“LBPC”), is an Ohio corporation with offices located at 3344 Morse Crossing Road, Columbus, Ohio 43219.

KELIN believes that it will be damaged by registration of the mark “LIVI” in standard characters as depicted in pending U.S. Application Serial No. 86210322 for goods identified in International Class 18 and hereby opposes registration of the same.

The grounds for opposition are as follows:

1. KELIN Srl., which does business under the name GIVI, is an internationally recognized motorcycle accessories company, was established more than 35 years ago and provides a full line of accessories, case accessories, helmets, mounting

hardware, luggage, parts, windshields and other goods related to motorcycle and cycle riding and other outdoor sporting activities nationally and internationally. More information about its U.S. activities, the company, products, U.S. distributors, media reports, product reviews, and downloads are available on its website located at www.giviusa.com.

2. Since at least as early as 1992 and, in any event, long prior to the filing date of the application herein opposed, KELIN adopted and commenced use of the term “GIVI,” used both with or without a design or other elements, in U.S. commerce as its trade name and/or trademark for various goods and services including but not limited to bags, luggage, cases, suitcases, trunks and/or other related goods, and has made continuous use of its mark in commerce since that time.
3. The goods and services provided or rendered in connection with KELIN’s GIVI Marks have been extensively advertised and promoted and are provided in commerce throughout the United States.
4. By virtue of the long, continued advertising, promotion and/or sale of its goods provided under the GIVI Marks, as well as the high quality of those goods, KELIN’s GIVI Marks are relied upon by the trade and public as specifically identifying KELIN’s goods and distinguishing them from others. As a result, KELIN’s GIVI Marks have developed valuable good will that belongs exclusively to KELIN.

5. In addition to its common law rights, KELIN is the owner of the following incontestable trademark registrations (“the GIVI Registrations”) in the United States Patent and Trademark Office:

Copies of the registration certificates and electronic status records for these registrations, which are valid, subsisting, and in full force and effect, are attached hereto as Exhibit A.

6. By the application herein opposed, Serial No. 86210322, Applicant seeks to register the designation “LIVI” as a trademark for the following goods: “Handbags, purses, tote bags, gym bags, travel baggage, and wallets” in International Class 18.
7. Upon information and belief, Applicant did not use the mark “LIVI” in commerce on or in connection with the applied for goods before the dates of use referenced for KELIN’s GIVI Marks in paragraphs 2 and 5 above, or before the priority dates, filing dates, or registration date accorded to the GIVI Registrations referenced in paragraph 5 above. Priority is not an issue.
8. Applicant’s Mark “LIVI” is confusingly similar in appearance, sound, connotation and commercial impression to KELIN’s GIVI Marks and/or the GIVI Registrations. For example, the wording in KELIN’s GIVI Marks are stylized using a unique font and the letter “G” in “GIVI” could be perceived by the relevant consumer as a stylized “L, which may cause even higher confusing similarity between the marks.

9. The goods for which Applicant seeks registration are closely similar to, overlapping with, identical to, and/or otherwise related to the goods provided by KELIN through KELIN's GIVI Marks and/or the GIVI Registrations.
10. Upon information and belief, the goods provided on or in connection with KELIN's GIVI Marks and/or the GIVI Registrations and the goods covered by Application Serial No. 86210322 are intended to be directed to similar, overlapping or related classes of purchasers and/or are to be distributed through similar or related channels of trade in the United States.
11. Applicant's use of the mark depicted in Application Serial No. 86210322 interferes with KELIN's use of KELIN's GIVI Marks and/or the marks shown in the GIVI Registrations and is likely to cause the public to believe that the goods of Applicant originate with KELIN, or vice versa, or that Applicant is owned or controlled by or in some manner affiliated or associated with KELIN, or vice versa, and is otherwise likely to cause confusion, cause mistake or deceive.
12. Any defect, inadequacy or deficiency found in Applicant's goods marketed, sold or otherwise provided under the mark depicted in Application Serial No. 86210322 would reflect negatively upon and seriously injure the reputation and goodwill associated with the goods provided by KELIN and provided in connection KELIN's GIVI Marks and the marks covered by the GIVI Registrations.

13. If Applicant were granted a registration based on Application Serial No. 86210322, Applicant would thereby obtain at least a *prima facie* exclusive right to use the mark LIVI mark depicted in Application Serial No. 86210322. Any such registration would be a source of damage and injury to KELIN and its customers.

WHEREFORE, KELIN prays that Application Serial No. 86210322 be rejected, that no registration be issued thereon to Applicant, and that this opposition be sustained in favor of KELIN.


