**NOTICE OF OPPOSITION**

Sir:

Henkel AG & Co. KGaA (hereafter "Henkel"), of 67 Henkelstrasse, Düsseldorf, Germany, believes that it will be damaged by registration of the mark shown in the above-referenced application, which was published in the Official Gazette of December 30, 2014, and hereby opposes issuance of the registration.

As grounds for opposition, Opposer alleges as follows:

1. Opposer and/or its predecessor and related companies have used the trademark IGORA in Commerce since at least as early as November 3, 1975 in association with hair coloring products ("Opposer's Goods").

2. Since at least as early as November 3, 1975, Opposer and/or its predecessor and related companies have engaged in the manufacture, distribution and sale of hair coloring and related products in Commerce, in conjunction with the IGORA trademark, and the mark has been in continuous use by Opposer and/or its related companies since that time.

3. Opposer is the owner by assignment of United States Trademark Registration No. 1940425, which was filed on December 7, 1993 and which issued on December 12, 1995, for the trademark IGORA for "Hair dyes, cream hair coloring, semi-permanent foam color for the hair, hydrogen peroxide for bleaching the hair, hair bleaching preparations, reduction dye remover, skin cleansing-lotion" in International Class 003. The mark was first used in commerce on November 3, 1975. A copy of the TARR database record for this Registration, as well as the Assignment record for the Registration, is attached hereto as Exhibit A.

4. The above referenced registration is valid and incontestable.

5. Opposer is also the owner by assignment of United States Trademark Registration No. 3302899, which was filed on February 23, 2006 and which issued on October 2, 2007, for the trademark IGORA ROYAL (Stylized) for "preparations for tinting, dyeing, bleaching of hair" in International Class 003. A copy of the TARR database record

for this Registration, as well as the Assignment record for the Registration, is attached hereto as Exhibit B.

6. Opposer is also the owner of United States Trademark Application Serial No. 85/766436, which was filed on October 29, 2012 and allowed on March 19, 2013, for the trademark IGORA VIBRANCE for "Hair coloring preparations for use in the professional hair care industry, not in the retail hair industry" in International Class 003. A copy of the TARR database record for this Application is attached hereto as Exhibit C.

7. Opposer has invested considerable effort and resources in advertising and promoting its mark IGORA and the goods sold under the marks, with the result that the relevant purchasing public has come to know, rely upon, and recognize the goods of Opposer by that mark. Opposer has established valuable goodwill in its mark IGORA and the mark has become well known to the relevant purchasing public.

8. Upon information and belief, Applicant is a California limited liability corporation, with an address of 4712 Admiralty Way, #354 Marina Del Rey, California 90292.

9. On August 8, 2014, Applicant filed application Serial No. 86/361581 for the mark IVORA under Section 1(b) for "Cosmetics, namely, creams, lotions, powder and gels for the face, the body and the hands; makeup preparations; cosmetic products in the nature of non-medicated sun care preparations; shampoos; hair conditioners; hair care preparations; hair styling preparations; non-medicated hair treatment preparations for cosmetic purposes; hair coloring and decolorant preparations" in International Class 003 ("Applicant's Goods").

10. Application Serial No. 86/361581 was published for opposition in the USPTO Official Gazette of December 30, 2014. This Notice of Opposition is timely.

11. There is no issue as to priority. Opposer has priority based on its use and registration of the mark IGORA in the United States. Opposer and its predecessors in interest used and registered the mark IGORA long before the Applicant's application date.

12. Applicant's proposed trademark IVORA is visually and phonetically virtually identical to Opposer's mark IGORA, and Applicant's mark creates a commercial impression which is highly similar to that of Opposer's mark.

13. The goods identified in Applicant's application are identical and highly similar to the goods with which Opposer's mark IGORA is used and for which it is registered, and Applicant's Goods may be offered for sale to the same customers and through the same channels of trade.

14. Applicant's proposed trademark IVORA so resembles Opposer's trademark IGORA as to be likely, when applied to Applicant's Goods, to cause confusion or to cause mistake or to deceive within the meaning of 15 U.S.C. §1052(d), in view of Opposer's prior use, ownership and registration of its trademark IGORA.

16. Registration should therefore be refused under 15 U.S.C. §1052(d).

17. Registration of Applicant's proposed mark on the Principal Register would be inconsistent with Opposer's rights under the aforementioned registration, and its common-law rights, and would be damaging to Opposer.

WHEREFORE, Opposer prays that its opposition be sustained and that the registration sought by Applicant in be refused.
