Brighton Collectibles, LLC, a Delaware limited liability company, whose address is 14022 Nelson Avenue, City of Industry, California 91746, believes that it will be damaged by registration of the mark BRIGHTON SQUARE and Design shown in application Serial No. 86/277,516 and hereby opposes the same.

As grounds for opposition, Opposer alleges that:

1. Opposer is engaged in the distribution and sale of a wide variety of consumer and household products and the operation of retail stores and a website associated with same.
2. Since long prior to Applicant's priority date, Opposer has continuously and extensively used in commerce the mark BRIGHTON, alone and in combination with other terms (hereinafter the "BRIGHTON Marks") in connection with a wide variety of consumer and household goods and the operation of retail stores and a website associated with the foregoing.
3. Opposer is the owner of Registration No. 2,209,973 of the mark BRIGHTON, issued December 15, 1998 on the Principal Register for goods in Classes 14, 18 and 25. Said registration is valid and subsisting and has become incontestable under the provisions of Section

15 of the Trademark Act. Attached hereto as Exhibit 1, and made of record herein, is a current printout of information from the electronic database records of the United States Patent and Trademark Office showing the current status and title of the registration.

4. Opposer is the owner of Registration No. 2,288,239 of the mark BRIGHTON, issued October 19, 1999 on the Principal Register for retail store services featuring clothing, jewelry, leather goods, fashion accessories and toiletries in Class 35. Said registration is valid and subsisting and has become incontestable under the provisions of Section 15 of the Trademark Act. Attached hereto as Exhibit 2, and made of record herein, is a current printout of information from the electronic database records of the United States Patent and Trademark Office showing the current status and title of the registration.

5. Opposer is the owner of Registration No. 2,401,412 of the mark BRIGHTON, issued November 7, 2000 on the Principal Register for goods in Class 9. Said registration is valid and subsisting and has become incontestable under the provisions of Section 15 of the Trademark Act. Attached hereto as Exhibit 3, and made of record herein, is a current printout of information from the electronic database records of the United States Patent and Trademark Office showing the current status and title of the registration.

6. Opposer is the owner of Registration No. 2,665,118 of the mark BRIGHTON, issued December 24, 2002 on the Principal Register for a variety of goods in Classes 04, 09, 11, 16 and 21. Said registration is valid and subsisting and has become incontestable under the provisions of Section 15 of the Trademark Act. Attached hereto as Exhibit 4, and made of record herein, is a current printout of information from the electronic database records of the United States Patent and Trademark Office showing the current status and title of the registration.

7. Opposer is the owner of Registration No. 2,835,909 of the mark BRIGHTON YOUR HOME, issued April 27, 2004 on the Principal Register for a variety of goods in Classes 04, 06, 09, 11, 14, 18, 20 and 21. Said registration is valid and subsisting and has become incontestable under the provisions of Section 15 of the Trademark Act. Attached hereto as

Exhibit 5, and made of record herein, is a current printout of information from the electronic database records of the United States Patent and Trademark Office showing the current status and title of the registration.

8. Opposer is the owner of Registration No. 3,148,447 of the mark BRIGHTON, issued September 26, 2006 on the Principal Register for goods in Class 03. Said registration is valid and subsisting. Attached hereto as Exhibit 6, and made of record herein, is a current printout of information from the electronic database records of the United States Patent and Trademark Office showing the current status and title of the registration.

9. Opposer is the owner of Registration No. 3,488,251 of the mark BRIGHTON, issued August 19, 2008 on the Principal Register for services in Class 35. Said registration is valid and subsisting. Attached hereto as Exhibit 7, and made of record herein, is a current printout of information from the electronic database records of the United States Patent and Trademark Office showing the current status and title of the registration.

10. Opposer is the owner of Registration No. 3,993,012 of the mark BRIGHTON issued July 12, 2011 on the Principal Register for a variety of goods in Classes 03, 06, 09, 14, 16, 18, 20, 21 and 25. Said registration is valid and subsisting. Attached hereto as Exhibit 8, and made of record herein, is a current printout of information from the electronic database records of the United States Patent and Trademark Office showing the current status and title of the registration.

11. Through the widespread use and advertising of its BRIGHTON Marks over a long period of time and by virtue of the goods sold and services rendered under the marks, Opposer has built up a valuable goodwill and reputation in connection with said marks which would be jeopardized by Applicant's use and registration of the mark BRIGHTON SQUARE and Design.

12. The goods for which Applicant seeks to register the mark BRIGHTON SQUARE and Design in Serial No. 86/277,516 in Classes 16, 20, 21 and 24 are related to Opposer's goods and services distributed, sold or rendered under or in connection with the BRIGHTON Marks.

13. Applicant's mark BRIGHTON SQUARE and Design so resembles Opposer's BRIGHTON Marks, previously used in commerce and/or registered with the United States Patent and Trademark Office, and not abandoned, as to be likely, when applied to the goods of Applicant, to cause confusion, or to cause mistake or to deceive.

14. Opposer is informed and believes that Applicant did not use the mark BRIGHTON SQUARE and Design for any of the goods in application Serial No. 86/277,516 prior to May 1, 2014.

Opposition No.

15. WHEREFORE, Opposer prays that this opposition be sustained, and that registration of application Serial No. 86/277,516 be refused.
