**DEFENDANTS RESPONSE IN OPPOSITION TO PLAINTIFF’S MOTION TO COMPELL
APPLICANT’S RESPONSES TO DOCUMENT REQUESTS AND INTERROGATORIES**

Amersfoort, The Netherlands, Tuesday, April 12, 2016

I. Introduction

On the 6 of April 2016 MISS MULTIVERSE (“Defendant”) was served with a copy of Miss Universe L.P., LLLP. (“Plaintiffs”) motion to compel applicant’s responses to document requests and interrogatories, pursuant to § TBMP 523.

On the 8 of April 2016 MISS MULTIVERSE (“Defendant”) was served with a copy of Miss Universe L.P., LLLP. (“Plaintiffs”) Opposer’s reply in further support of its motion to join party pursuant to § TBMP 512.

Defendant hereby respond to opposers moving papers as follow;

Please *see* (Exhibit B14) Defendant was informed via email send by the Plaintiff, dated April 6, 2016, *that IMG Universe will be the party answering discovery questions served by the Defendant.* In view that IMG (**the TV company**) *see* (Exhibit A) and not, Miss Universe (The Pageant company) is the party seeking discovery information, Defendant argues that discovery served by the Defendant are not tailored for a TV production company and further claims that Defendants sensitive proprietary TV concept that are vulnerable to intellectual copy and divulgation, vulnerable to professional and artistic replication should be protected by the board from IMG the TV production company. *see* (Exhibit A)

Plaintiff has withheld during the discovery process, the fact that ING has been the owner of the trademark since September 2015. By withholding IMG from the Defendant and compelling discovery questions related to Defendants sensitive proprietary TV concepts at the same time, demonstrates that Plaintiff has been misleading the Defendant in to thinking she is providing information to Miss Universe the pageant company but the truth is that her private information is being served directly to a TV production company to be examined by the TV producers of ING who can replicate her concepts. Plaintiff is thereby abusing the trademark rules to engage in fishing expeditions and company espionage. Defendant hereby request the board to apply discovery restrictions and sanctions.

Defendant further claims to have informed the Plaintiff in writing by email, that the Mark Miss Universe is highly diluted in the USA and worldwide and that plaintiff has not contested many marks using the words Miss and Universe that are trademarked in the USTPO and such marks using Miss and Universe are clearly endorsed and created by Plaintiffs former contestants residing in the USA and in business within the USA and worldwide. *see (exhibit C)* Therefore, in view of Plaintiff withholding IMG the TV company to engage in fishing TV concepts and the evidence that mark confusion is being used as justification, to bully and harm fair competition provided that other beauty pageant marks are using the word Universe in the USA with no objections by the Plaintiff. Defendant brings to the attention of the board, that Plaintiff has laser focused on the Defendant as competitor and is utilizing all possible trickeries and technicalities as an attempt to find any loophole that can justify their frivolous and unsubstantiated opposition to affect and terminate defendant's business. To what Defendant hereby request the board to apply restrictions and sanctions.

In relation to the Motion to Compel dated 6 of April 2016, the Plaintiff has filed this motion prematurely, prior to the conclusion of defendants 30-day period and in contradiction to the boards instructions set forth on the 10th of March 2016

II. Boards Instructions

On the 10th of March Interlocutory Attorney Geoffrey M. McNutt, granted Opposers motion to extend time and delivered the following instructions:

- a) The discovery dates are accordingly rescheduled and modified to close on May 29, 2016 (the Board noting that in lieu of a motion to compel, a motion to extend time to allow the parties to engage in an effort to settle the discovery dispute would have been a proper approach).
- b) The Board expects parties to cooperate with one another in the discovery process. See TBMP § 408.01
- c) The Board notes that Applicant is representing herself in this proceeding. Although Patent and Trademark Rule 11.14 permits Applicant to represent herself, it is strongly advisable for a party who is not acquainted with the technicalities of the procedural and substantive law involved in inter partes proceedings before the Board to secure the services of an attorney who is familiar with such matters.

III. Follow-up to boards instructions and advice to date.

Defendant has followed the boards advice with regards to seek services of an attorney who is familiar with the technicalities of the procedural rules and regulations. *See (Exhibit B7)* Defendant has properly and timely conferred with the Plaintiffs to mutually agree with an extension of time to allow Defendant to consult with attorneys and to allow sufficient time for an attorney to become familiar with the case and properly advice. Pursuant to TBMP 405.04(a), 406.04(a) Defendant has 30 days to serve discovery answers but the plaintiff has prematurely filed a motion to compel within the Defendants lawful time frame to respond.

The Board allowed 60 days' discovery time whereas Plaintiff imposed 15 days' deadline for Defendant to serve responses and objections to Interrogatories answer. Defendant properly and amicably responded and informed the Plaintiff that in accordance with procedural rules Defendant has 30 days to comply Pursuant to TBMP 405.04(a), 406.04(a) and 407.03(a) Defendant further informed that she will exercise her rights and use the 30 days' period to allow sufficient time for an attorney to become familiar with the case and properly advice. *See (Exhibit B7 and B12)* Plaintiff did not collaborate with Defendants inquiries to extend time which is improper and non-collaborative, pursuant to TBMP § 408.01 and therefore not in accordance with the Board recommendations and expectations with regards to parties cooperating with one another in the discovery process.

On March 21, 2016 Defendant was served with a motion to join/substitute party, *see (exhibit B-6)* whereas party to join is IMG Universe, a company in the business of modeling agency and TV production. *(exhibit A)* Such information is relevant to the case, to the extend that Defendant is also TV producer and Modeling Agency. This new information that has been withheld since September 10, 2015 is of high important for the Defendants to further substantiate her rights to protect her confidential TV production concepts, document and things that are sensitive to replication by her competitors during the discovery process. Plaintiff has withheld IMG Universe during the foregoing discovery period, while applying pressure at the same time with regards to discovering Defendants TV concepts and trade secrets that can be examined by the TV production team of ING; therefore, defendant wishes to further exercise her rights to protect her confidential information & TV concept. Furthermore, Defendant has equal rights to be informed in order to prepare her defense and for this reasons she has requested amicably for both parties to agree with an extension of time to meet and confer with regards to discovery questions related to IMG Universe, LLC. *see (exhibit B-9)*

IV. Argument

Plaintiff motion to compel vs extension of time is contradicting.

On the 29th of January 2016, Plaintiff filed a motion to extend time to allow the parties to engage in an effort to settle the discovery dispute emphasizing on the exchange of discovery documents as the priority and better option to avoid filing a motion to compel. The Plaintiff has now changed position,

amicable discovery is no longer the priority; Plaintiff has filed a motion to compel in a hurry, to the extend that their motion is filed 10 days prior to Defendants deadline to comply with discovery obligations. Plaintiff has then served an additional paper in further support of the motion to compel, but this time contradicting them selves by stating that there is sufficient time to meet and confer with regards to ING Universe, this double standard position makes no sense, if plaintiff can acknowledge that there is sufficient discovery time left to examine ING Universe documents and therefore deny an extension of time; then one can argue, that there is also sufficient time to examine Defendants response to discovery documents and therefore a premature motion to compel is not necessary and accordingly can be denied, but both probabilities with regards to the same topic and period of time is not possible, the hastiness to compel the board before the deadlines and contradicting change of position raises Defendants suspicion with regards to ING Universe.

Plaintiff has taken advantage of Defendants proposal to meet and confer.

Defendant received Plaintiffs motion to joint IMG Universe On the 6 of April 2016. As reaction, Defendant served Plaintiff with a written request in good faith, requesting to mutually consent and agree to an extension of time that would allow a reasonable period for Defendant to prepare and submit discovery questions related to IMG Universe. *see (exhibit B-12)* To her surprise, the Plaintiff, as counter reaction, instead of first responding to Defendants proposal for additional time, Plaintiff took advantage of this information to promptly serve a motion to compel with the purpose of frustrating discovery. *see (exhibit B-13)* The improper actions are clear; Plaintiff has submitted their motion to compel in a hasty rush before answering to Defendants amicable request and even before Defendants 30 days' deadline to comply Pursuant to TBMP 405.04(a), 406.04(a) and 407.03(a) this cannot be more evident of non-cooperative and improper conduct. See TBMP § 408.01

V. Denouncement

Defendant has sufficient reasons to suspect that Plaintiff has withheld the involvement of IMG Universe since September 10, 2015 because the new owners of the trademark, are companies in the business of TV production. *see (exhibit A)* Defendant hereby brings to the attention of the board that Plaintiff has withheld such information during the disclosure and discovery period with the intention to discover Defendants confidential TV production concepts in order to provide defendants sensitive information to the creative and TV production team of ING, where such information after examined can then be absorbed and presented to the board on a later stage, as if they already had the TV concept in mind, and potentially producing the concept in the future and therefore taking Defendants intellectual property by means of abusing the legal system.

Defendant has continuously brought to the Plaintiff attention that there is no reason to reveal Defendants confidential TV concepts that are sensitive to replication and have nothing to do whatsoever with the forgoing case of dilution and brand confusion; therefore Defendant has not understood why Plaintiff has continued to apply pressure during discovery with such force specifically with the topic of disclosure of Defendants TV concept until now that it becomes evidently

clear that the petitioner of Defendants confidential TV concept, is not Miss Universe LLPP, the pageant company, but the TV production company ING, whom now owns the Plaintiffs trademark, and therefore the recipient of all sensitive material will be ING TV-creative team and ING TV-developers whom will examine Defendants concept in detail; therefore, withholding the fact that ING is the owner of the mark since September 10, 2015 and during that time also inquiring defendants confidential information, becomes clear intent of fishing and company espionage and manipulation of the system to take advantage of the foregoing case in order to abuse, distress competitors and absorb their intellectual property, all under the excuse of brand confusion.

No justification for Plaintiff to withhold information

Plaintiff has no justification to why they have withheld such relevant information. For the avoidance of doubt, selling, transferring and changing ownership of the trademark is a paramount subject that has significant importance for all parties involved in any trademark litigation case; therefore, by all means regarded as relevant information that must be supplemented and provided to the opposite party. Withholding the involvement of a TV production company such as ING since September 10, 2015 where the plaintiff themselves stipulated as discovery conditions that all requests and discovery information are continuing in nature (sic) *These Requests are continuing in nature. If any document or information comes into your possession subsequent to responding hereto, you must supplement your responses accordingly.* See Page 4 of Opposers First Set for Production of Documents and things. Served November 10, 2015. Meaning that Opposer is clearly aware that this is a disruption of the rules and that Defendant has rights to be informed of new developments and must be supplemented with such information.

VI. Good Cause Exists to Deny Motion to Compel.

a) The discovery deadlines have not transpired.

On the 10th of March, 2016 the board granted 60 days' extension of time whereas, Pursuant to TBMP 405.04(a), 406.04(a) and 407.03(a), responses and objections to Interrogatories, Requests for Production and Requests for Admission, respectively, must be served within 35 days after the date of service if service of the requests is made by first-class mail. The 30 to 35 days have not expired meaning Defendant is within the legal boundaries of discovery deadlines.

b) Plaintiff has filed motion to compel prior to Applicants deadlines to respond.

On the 15th of March, 2016 Defendant was served with Plaintiffs discovery questions. Pursuant to the TTAB and Federal Rules, Defendants deadline to comply ends on the 15th of April 2016. Therefore, Plaintiff has filed motion to compel prior to Defendants deadline. This is unreasonable in view of the fact that the discovery period is set to close on May 29, 2016 which would allow an additional 45 days for Plaintiff to review Defendants discovery answers and file a motion to compel if Plaintiffs fails to comply.

VII. Good Cause Exists for Protective Order Limiting Discovery Pursuant to 412.06

Pursuant to Fed. R. Civ. P. 26(c)(1) Defendant has attempted to confer with Opposing party in an effort to resolve the dispute without court action. Defendant has made reasonable good efforts to produce discovery responses and documents reserving information related to the production of TV concept; subject to, the limitations imposed by Rule 26(b)(2)(C). Fed. R. Civ. P. 26(g) (B) [Note 3.] (i) While the scope of discovery is therefore somewhat broad, parties may not engage in “fishing expeditions” (ii) A number of plaintiffs requests include disclosure of defendants confidential TV concept that can be made available to the TV production team of ING by the plaintiff, such documents offer nothing to further the claims before the Board and are therefore not appropriately tailored and not relevant to the subject matter of confusion, fame and dilution (iii) Defendant has Pursuant to Fed. R. Civ. P. 26(c)(1) [note D] reasonably reserved sensitive proprietary TV concept and format, business trade secrets that are vulnerable to intellectual copy, divulcation of professional and artistic creation and/or replication by third parties such as ING. (iv) Defendant has respectfully expressed in good faith, Pursuant to Fed. R. Civ. P. 26(c)(1) [note G] that confidential information will be made readily available upon request of the board for review by outside counsel for the parties as deemed necessary by the board (v) Plaintiff has insisted and abused discovery by withholding ING and pressuring Defendant with unreasonable “fishing” demands for TV concept whereas such confidential documents is not relevant to the forgoing trademark confusion and dilution case and has filed a motion to compel discovery prior to the discovery deadline in order to interrupt and frustrate Defendants discovery rights. (vi) Both the Trademark Rules and the Federal Rules of Civil Procedure grant the Board discretion to manage the discovery process in order to balance the requesting party’s need for information against any injury that may result from discovery abuse.” *Phillies*, 107 USPQ2d at 2152 (quoting *FMR Corp. v. Alliant Partners*, 51 USPQ2d 1759, 1761 (TTAB 1999).

(vii) Plaintiff has withheld the involvement of IMG Universe since September 10, 2015 whereas ING is a company in the business of TV production. To expose Defendants confidential TV production concepts to ING will provide access of Defendants sensitive information to the creative and TV production team of ING, such information after examined can be repackaged and presented to the board as if they already had the TV concept and follow up with producing the concept and therefore taking Defendants intellectual property by means of abusing the legal system.

VIII. Good Cause Exists for an Extension of Time

a) Defendant is respectfully following up with the Boards ruling and recommendations

On the 10th of March, 2016 The board ordered both parties to amicably collaborate in order to facilitate a viable and efficient discovery process. The Board expects parties to cooperate with one another in the discovery process. See TBMP § 408.01. Each party has a duty to make a good faith effort to satisfy the legitimate discovery needs of its adversary. Defendant has been in continuous

communication with the plaintiff to reach an amicable process of discovery including the clarification of new information that has been withheld from the Defendant. *see (exhibit B)*

The Board notes that Applicant is representing herself in this proceeding. In view of Defendants pro-se status, the board recommended that Defendant seeks legal guidance of an attorney who is familiar with the foregoing matters. Defendant has followed the boards advice to see professional advice. Attorneys require reasonable time to read the documentation in order to be brought up to date with the foregoing case and properly advise. Defendant has respectfully informed to the opposing party that she is unable to respond within the imposed 15 days and that she will exercise her rights to 30 days Pursuant to TBMP 405.04(a), 406.04(a) and 407.03(a).

b) Defendant has properly and in due time replied to plaintiff's motion to join.

On the 6th of April, in due time under rule 37 CFR 2.119(c) Defendant has replied to Opposers motion to join party. (sic), *Defendant hereby responds and does not dispute Plaintiffs Motion to Join Parties under Rule §TBMP 512 but does oppose party's non-compliance with their duty to cooperate and disclose discoverable information that is relevant to the foregoing proceedings under rule §TBMP 408.* Opposing party has withheld information since September 2015, meaning such information could have been provided during the disclosure period and early stages of discovery pursuant to §TBMP 403.05. The untimely disclosure of the subject matter results in substantial alterations that puts Defendant on a disadvantage to the extend that Defendant has not included discovery questions related to IMG Universe, LLC and is unable to properly prepare Defendants case before the board.

IX. CONCLUSION

For the foregoing reasons, the Defendant respectfully requests the Board to deny Plaintiffs Motion to Compel and Motion for Sanctions in its entirety. Defendants further submit that they would be receptive to the appointment of a Court Appointed Monitor for the remaining discovery matters should the Court decide that additional oversight of the discovery process is warranted. Plaintiffs herby requests Protective Order Limiting Discovery Pursuant to 412.06

Plaintiff has not shown any evidence to substantiate mark confusion, in comparison Defendant has brought to the attention of the Plaintiff and the board, numerous instances marks registered in the USTPO with the words Miss and Universe that are not contested by the Plaintiff, whereas plaintiff has opted to relentlessly pursue Defendants Mark in view of Defendants TV concept and meaning of the word Multiverse, in connection to Defendants Mark competitive advantage and not confusion. Defendant thereby requests the board to apply discovery restrictions and sanctions thereto in addition to compelling defendant to submit their evidence to substantiate their claims of mark confusion.

Defendant requests for an additional sixty-day extension of time pursuant to §TBMP 509.01(a) To Allow Time for "Follow-up" Discovery and to Facilitate Introduction of Produced Documents in connection to ING Universe pursuant to §TBMP 403(a)
