TBMP 513.01 MOTION TO WITHDRAW AS REPRESENTATIVE

Pursuant to TBMP 513.01 and further to the December 12, 2015 order denying the undersigned's motion to withdraw filed December 7, 2015, the undersigned moves to withdraw as representative for Opposer, Valery Sigal.

The December 12, 2015 order requires the following five requirements for compliance with a request to withdraw as counsel of record:

- (1) a specification of the basis for the request;
- (2) a statement that the practitioner has notified the client of his or her desire to withdraw from employment, and has allowed time for employment of another practitioner;
- (3) a statement that all documents and property that relate to the proceeding and to which the client is entitled have been delivered to the client;

(4) if any part of a fee paid in advance has not been earned, a statement that the unearned part has been refunded; and

(5) proof of service of the request upon the client and upon every other party to the proceeding.

Regarding item (1), the request is based on: (A) the Opposer instructing the undersigned to discontinue providing legal services on or about October 21, 2015. See Attachment 1, which is a copy of the undersigned's written confirmation of receipt of the Opposer's instruction; and (B) the **Opposer's written consent to the undersigned withdrawing representation**. See Attachment 2.

Regarding item (2), on October 22, 2015, the undersigned confirmed receipt of the Opposer's stand down instruction and advised the Opposer that the undersigned was standing down in the matter, which allowed the Opposer time for employment of another practitioner. On December 15, 2015, the undersigned advised the Opposer that the undersigned will be formally withdrawing as the Opposer's attorney and the Opposer confirmed/requested the undersigned withdraw. See Attachment 2.

Regarding item (3), the undersigned states that all documents and property that relate to the proceeding in the possession of the undersigned and to which the Opposer is entitled have been delivered to the Opposer.

Regarding item (4), the undersigned is not in possession of any fee paid in advance by the Opposer.

Regarding item (5), the undersigned includes proof of service of the request to withdraw upon the client and upon every other party to the proceeding.
