1. Applicant seeks registration of the mark  , through its trademark Application Serial No. 86/213,968 filed with the U.S. Patent and Trademark Office (“USPTO”) on March 7, 2014 that includes Opposer’s famous Red Cross Emblem (defined, *supra*), consisting of a Greek cross in the color red, and filed pursuant to Section 1(a) of the Trademark Act (15 U.S.C. § 1051) in connection with the following services of Class 36: *Charitable fundraising services by means of selling clothing and accessories for infants, children, men, women and pets namely, t-shirts, tank tops, jackets, sweatshirts, pants, leggings, shorts, jackets, aprons, swimwear, lingerie, loungewear, pajamas, blankets, towels, bath robes, gloves, photo frame, coffee mugs, tote bags, bags, cosmetic bags, lunch bags, hats, caps, headwear, headbands, sun visors, shoes, stationery, greeting cards, jewelry, bath and body products, pillows, journals and stickers to raise funds for Donkey Rescue services* (the “Application”). The Application claims a date of first use in commerce of February 14, 2014.
2. The Application was published for opposition on December 2, 2014. On December 10, 2014, Opposer electronically filed a Request for Extension of Time to Oppose the Application, requesting a 90-day extension until April 1, 2015. Such request was granted by the Trademark Trial and Appeal Board (the “Board”) on December 10, 2014.
3. Opposer has obtained the necessary extension of time in which to file this Notice of Opposition.
4. The International Red Cross and Red Crescent Movement is one of the world’s oldest and largest humanitarian organizations, founded in 1863.

5. The American National Red Cross, a non-profit, charitable institution, was founded on May 21, 1881 as the American Association of the Red Cross. The American Red Cross was modeled upon the International Red Cross and Red Crescent Movement to serve the United States during times of peace and war by providing disaster relief, emergency aid, first aid training programs, humanitarian assistance, and other charitable support. The United States Congress chartered the Red Cross in 1905 to, *inter alia*, “carry out a system of national and international relief in time of peace and apply that system in mitigating the sufferings caused by pestilence, famine, fire, floods, and other great national calamities, and to devise and carry out measures for preventing those calamities.” For over a century, the American Red Cross has responded to disasters and assisted in rescue operations, both domestic and internationally, and provided education and training for preparedness thereto. The American Red Cross is also a leader in health and safety education and training, including but not limited to CPR, first aid, and water safety. To further its chartered purposes, the American Red Cross is and has at all relevant times been engaged in charitable fundraising efforts. The Red Cross brands are among the most recognized in the United States and around the world.
6. The distinctive emblem of the Red Cross consists of a Greek cross in the color red (Opposer’s Greek red cross being sometimes herein referred to as the “Red Cross Emblem”).
7. Opposer has a long and continuous history of use of its world famous Red Cross Emblem, dating back to 1881 in connection with various services and goods, including, without limitation, health and safety services, charitable services, fundraising, nursing, rescue services, blood collection, disaster relief services and training. Consumers in the

United States associate the Greek red cross with Opposer and the foregoing services and goods.

8. Opposer considers the Greek red cross to be among its most valuable assets. The Greek red cross, or Red Cross Emblem, serves as the most important trademark in Opposer's family of trademarks.
9. In 1905, the United States Congress recognized the importance of protecting the Greek red cross from unauthorized use and granted the Red Cross (along with its duly authorized employees and agents and the sanitary and hospital authorities of the armed forces of the United States) the exclusive right to use the Red Cross Emblem under 18 U.S.C. § 706, which is known as the "Red Cross Statute." The Red Cross Statute protects the Greek red cross from unauthorized third-party use and states, in part:

Whoever, whether a corporation, association or person, other than the American National Red Cross and its duly authorized employees and agents and the sanitary and hospital authorities of the armed forces of the United States, uses the emblem of the Greek red cross on a white ground, or any sign or insignia made or colored in imitation thereof or the words "Red Cross" or "Geneva Cross" or any combination of these words —

Shall be fined under this title or imprisoned not more than six months, or both.

10. The USPTO reinforced this grant of protection with U.S. Serial No. 89/000,081, a special designation of Opposer's ownership of the mark  within the records of the USPTO setting forth the identification that the Greek red cross is protected from unauthorized third parties in connection with all classes of goods and services, pursuant to federal statute, namely, 18 U.S.C. § 706.

11. Opposer is also owner of various U.S. Trademark registrations for the Red Cross Emblem, or Greek red cross, including the following, which are all valid, subsisting and in full force and effect:

12. In addition, Opposer owns significant, common law rights to the Red Cross Emblem in conjunction with various services and goods, including retail store services and information about ways for businesses, individuals or groups to fundraise in support of the Red Cross' mission. Opposer has used and continues to use the Red Cross Emblem

with the aforesaid services/goods for many years, since long before Applicant selected and filed to register the Application.

13. The Red Cross Emblem, or the Greek red cross, and the services/goods thereunder as set forth in Paragraphs 10 - 12 shall hereinafter be referred to collectively as the “Opposer’s Marks.” Copies of the Trademark Status and Document Retrieval (“TSDR”) system records for each of the aforesaid, referenced registrations are set forth herein as **Exhibit A**.
14. Opposer’s continuous, active and consistent use and promotion in interstate commerce of at least its charitable services and goods set forth in the Opposer’s Marks under its Greek red cross emblem for well over a century have led U.S. consumers to associate Opposer’s Marks with Opposer. Through its long, extensive and continuous use of the Greek red cross, Opposer has established significant goodwill with respect to the Greek red cross that inures to the benefit of Opposer. Opposer has used in U.S. commerce, and has established prior rights in and to, the Red Cross Emblem in connection with at least the services and goods set forth within the Opposer’s Marks, including “charitable fundraising.”
15. Despite Opposer’s long-standing rights into its famous Greek red cross, which includes both trademark and Congressional protection, Applicant filed its Application to register a mark which includes a Greek red cross. A principal and dominant element of Applicant’s Mark, the Greek red cross, is identical to the Red Cross Emblem of Opposer. Indeed, Applicant has claimed the color red as a feature of the mark, describing the mark, in part, as “an image of a red cross.”

16. In addition to attempting to register a mark which includes Opposer's protected Greek red cross, Applicant submitted, in support of use of Applicant's Mark in interstate commerce, a specimen of use which clearly shows the Greek red cross used on a white background.
17. Applicant is not one of the parties, as enumerated in the Red Cross Statute, that is authorized to use Opposer's Red Cross Emblem.

COUNT I – PROHIBITION BY RED CROSS STATUTE

18. Opposer repeats and incorporates by reference the allegations in the preceding paragraphs as though fully set forth herein.
19. The Red Cross Statute, under 18 U.S.C. § 706, prohibits use of the Greek red cross by any entity or individual other than the Opposer and or those designees specifically referenced in The Red Cross Statute.
20. Additionally, the Trademark Manual of Examining Procedure recognizes the heightened degree of protection afforded the Greek red cross: "Use of the Greek red cross other than by the American National Red Cross is proscribed by statute." TMEP § 1205.01.
21. Applicant is not a listed individual or entity under the Red Cross Statute authorized to use the Red Cross Emblem nor has Opposer granted it with any such authority.
22. The USPTO has long upheld the rights of Opposer by refusing registration of third-party trademarks incorporating a Greek red cross without significant alteration or stylization. Opposer attaches hereto as **Exhibits B and C** applications printed from the USPTO database which were refused registration by the USPTO and either subsequently abandoned or amended so as not include the Greek red cross. Applicant's Mark clearly consists of a Greek red cross on a white ground with a donkey simply imposed thereon,

and is no way altered in keeping with TMEP § 1205.01(c)(iii). The drawing Applicant submitted in support of Applicant's Mark unequivocally shows the symbol in red, and Applicant has submitted a specimen showing use of the Red Cross Emblem on a white background.

23. Accordingly, the Application should be refused registration based upon Trademark Act Sections 1, 45 and 2(a).
24. As Applicant's mark is contrary to the statutory protection afforded Opposer in the Red Cross Statute, the registration of the Application will cause injury and damage to Opposer.

COUNT II – DILUTION

25. Opposer repeats and incorporates by reference the allegations in the preceding paragraphs as though fully set forth herein.
26. The Greek red cross has been in use by Opposer for various services and goods throughout the United States since 1881, long before 2014, the year Applicant has claimed as its date of first use in interstate commerce. Opposer has continually used the Greek red cross in connection with its services and products and spends a considerable amount of time and resources promoting and protecting the Red Cross Emblem.
27. As a result of the extensive use and advertising by Opposer, and the high quality of Opposer's services and goods, Opposer's Greek red cross and name have become well known and built up valuable and substantial goodwill. The Red Cross Emblem is closely and uniquely associated with Opposer along with the goods and services offered by Opposer and has become "famous" among the public within the meaning of 15 U.S.C. § 1125(c).

28. The Red Cross Emblem has become famous, within the meaning of Section 43(c) of the Trademark Act, 15 U.S.C. § 1125(c), prior to the filing date of the Application and the February 14, 2014 claimed date of first use in the Application or any other date upon which Applicant can rely for actual or constructive use of Applicant's Mark.
29. Applicant's Mark is confusingly similar to the Red Cross Emblem and Opposer's Marks.
30. If Applicant is permitted to register the Application, actual dilution of the famous Red Cross Emblem by blurring and/or tarnishment is likely to occur.
31. Registration and use of Applicant's Mark is likely to cause severe injury to Opposer by causing confusion, mistake, and/or deception as to the respective rights of the parties and as to the source of the services offered by Applicant. In addition, any failure or fault with respect to Applicant's services provided under Applicant's Mark would erode the valuable goodwill associated with Opposer and its Red Cross Emblem. Registration of Applicant's Mark is likely to impair the distinctiveness of the Red Cross Emblem that is the subject of Opposer's Marks. Such registration and use would weaken the ability of Opposer's Marks to identify and distinguish the goods and services of Opposer from Applicant and others.
32. Applicant's Mark so resembles the famous Red Cross Emblem as to be likely, when applied to the services set forth in the Application, to result in dilution of the distinctive quality of Opposer's Red Cross Emblem within the meaning of Section 43(c) of the Trademark Act, 15 U.S.C. § 1125(c), to the detriment of Opposer.
33. Based on the foregoing, the registration of the Application will cause injury and damage to Opposer.

COUNT III – FALSE ASSOCIATION

34. Opposer repeats and incorporates by reference the allegations in the preceding paragraphs as though fully set forth herein.
35. Opposer alleges and asserts that Applicant's Mark is unregistrable because Applicant's Mark so closely resembles Opposer's Greek red cross, or Red Cross Emblem, that use and registration of Applicant's Mark would falsely suggest to consumers a connection with Opposer and Opposer's Marks within the meaning of 15 U.S.C. § 1052(a).
36. Neither Applicant nor the services Applicant provides under Applicant's Mark is related or connected with Opposer or with any services/goods provided by Opposer under Opposer's Marks.
37. In light of Opposer's extensive and long-standing use of its Greek red cross in the areas of humanitarian and disaster response, charitable services, fundraising, first aid and health and safety, among others, Applicant's choice to utilize the Greek red cross in connection with its business suggests that Applicant intends to trade off of the substantial goodwill and recognition that Opposer has built up in the Greek red cross.
38. Opposer's name, identity, and its Red Cross Emblem are of sufficient fame and reputation that the Applicant's use and registration of the Applicant's Mark on the services in the Application will likely suggest, or are currently suggesting, a connection with Opposer within the meaning of Section 2(a) of the Trademark Act, 15 U.S.C. § 1052(a).
39. Based on the foregoing, the registration of the Application will cause injury and damage to Opposer.

COUNT IV – LIKELIHOOD OF CONFUSION

40. Opposer repeats and incorporates by reference the allegations in the preceding paragraphs as though fully set forth herein.
41. The Applicant's Mark is confusingly similar to the Opposer's Marks.
42. Upon information and belief, the services listed in the Application are the same or related to the various services and goods provided by or associated with Opposer at least in connection with Opposer's Marks.
43. Opposer has established prior rights, including registration, statutory and common law rights, in and to the Red Cross Emblem long before the filing date of the Application or any other date on which Applicant can rely for actual or constructive use of the Opposed Mark.
44. Applicant's Mark so resembles Opposer's Red Cross Emblem and Opposer's Marks that consumers, upon encountering the famous Red Cross Emblem used in connection with the services set forth in the Application, are likely to mistakenly believe or be deceived into thinking that such use is connected to, associated with, or licensed, sponsored or approved by the American Red Cross. Thus, registration and use of Applicant's Mark in connection with the services of the Application are likely to cause confusion, mistake and/or deception within the meaning of Section 2(d) of the Trademark Act, 15 U.S.C. § 1052(d), all to the detriment of Opposer.
45. Based on the foregoing, the registration of the Application will cause injury and damage to Opposer.

WHEREFORE, the American National Red Cross submits that Applicant's mark which includes the Red Cross Emblem is not entitled to registration, and the American National Red Cross prays that registration of said Application Serial No. 86/213,968 be denied and this Opposition be sustained in favor of Opposer.
