

COMBINED NOTICE OF OPPOSITION

PRL USA Holdings, Inc., believing that it will be damaged by the registration of the above-identified trademarks, and having previously been granted extensions of time to oppose the same, hereby opposes the registration thereof and alleges as follows:

FACTS

Applicant

1. Upon information and belief, Applicant Polo Gear LLC (“Applicant”) is a limited liability company, organized under the laws of the State of Delaware, with its principal place of business at 3500 Fairlane Farms Road, Wellington, Florida 33414.

2. On October 2, 2014, Applicant filed Application Serial No. 86/412,883 on an

intent-to-use basis, seeking to register POLOGEAR for use on or in connection with all of the following goods:

International Class 24: Bed sheets, comforters, blankets, dust ruffles, duvet covers, pillow cases, pillow shams, bed shams, bed spreads.

3. On October 2, 2014, Applicant filed Application Serial No. 86/412,886 on an intent-to-use basis, seeking to register POLOGEAR& Design, depicted as follows:



for use on or in connection with all of the following goods:

International Class 24: Bed sheets, comforters, blankets, dust ruffles, duvet covers, pillow cases, pillow shams, bed shams, bed spreads.

4. On December 22, 2014, Applicant filed Application Serial No. 86/488,070 (hereinafter, together with Ser. Nos. 86/412,883 and 86/412,886, referred to as “Applicant’s Marks”) on an intent-to-use basis, seeking to register POLOGEAR for use on or in connection with all of the following goods:

International Class 24: Bath Towels

(hereinafter, together with “Bed sheets, comforters, blankets, dust ruffles, duvet covers, pillow cases, pillow shams, bed shams, bed spreads,” referred to as “Applicant’s Goods”).

5. Applicant is also the owner of Application Ser. No. 85/458,112, which is the subject of Opposition No. 91207805.

6. Application Ser. No. 85/458,112 covers Class 18 goods “all for use in equestrian

activities,” as well as “clothing for wear in equestrian activities” in Class 25.

Opposer

7. PRL USA Holdings, Inc., (which, together with its corporate parent, Ralph Lauren Corporation, and its predecessors-in-interest, collectively are “RL” or “Opposer”), is a corporation organized and existing under the laws of the State of Delaware, having a place of business at 625 Madison Avenue, New York, New York 10022.

8. RL is engaged in the manufacture, promotion, and distribution of premium lifestyle products and services, including apparel, accessories, household items, restaurants, media, retail stores, and other goods and services worldwide.

9. For more than forty (40) years, RL’s reputation and distinctive image have been consistently developed across an ever-expanding array of products.

10. As a result, RL has become one of the largest and most successful apparel companies in the United States.

11. RL has extensively used the trademark POLO to identify and distinguish its goods and services in the marketplace, along with various other terms such as POLO RALPH LAUREN, POLO BY RALPH LAUREN, POLO SPORT, POLO GOLF, and POLO TENNIS, among others (collectively, the “POLO Mark”).

12. RL has also extensively used the following fanciful representation of a polo



player mounted on a horse, holding a diagonal polo mallet: (the “Polo Player Symbol”) to identify and distinguish its goods and services in the marketplace, (the POLO Mark and the Polo Player Symbol, collectively, are the “POLO Marks”).

13. The POLO Marks have become synonymous with RL in the marketplace.

14. RL began using the POLO Marks as early as 1967 for wearing apparel.

15. Today, the POLO Marks are being used for a wide variety of goods, including, but not limited to, apparel, footwear, fragrances, jewelry, accessories, bedding and home furnishings.

16. RL is the owner of numerous valid and subsisting trademark registrations on the Principal Register with the USPTO for the POLO Marks, many of which are incontestable. A chart containing a representative sampling of the POLO Marks, among others, is attached hereto as **Exhibit A**.

17. Status and title copies of all of the registrations listed in Exhibit A are attached hereto as **Exhibit B**.

18. RL, itself and through its licensees, markets and sells goods bearing the POLO Marks throughout the world and in the United States, from approximately 200 RL retail stores, as well as in most major department and fine retail stores, including, but not limited to, Bloomingdale's, Saks, Macy's, Lord & Taylor, Belk, Dillard's, and Neiman Marcus.

19. RL, itself and through its licensees, also sells its goods bearing the POLO Marks on its website, located at <www.ralphlauren.com>, and through other online retailers, including, but not limited to, Macys.com, LordandTaylor.com, and Bloomingdales.com.

20. In the course of becoming one of the most recognized brands in the United States, RL has expended significant resources to protect the strength, goodwill, and value of the POLO Marks.

21. RL has also expended significant time, effort, and money in advertising and promoting the goods and services sold under the POLO Marks in magazines, print and television advertisements, billboards, and online, as well as through sports event sponsorships and authorized retailers.

22. RL's goods and services, marketed under the POLO Marks have enjoyed widespread and unsolicited media coverage in print, on television, and on the internet. RL and its founder, Ralph Lauren, have received consistent recognition for the exceptional quality and design of the goods that bear the POLO Marks, which has heightened consumer awareness of RL's goods and their quality.

23. As a result, the POLO Marks are famous as denoting the source of high-quality goods.

24. RL's use of the POLO Marks long predates Applicant's use of Applicant's Marks in commerce.

COUNT I
LIKELIHOOD OF CONFUSION

25. Opposer repeats and realleges the allegations set forth in the preceding paragraphs.

26. RL has prior rights in the POLO Marks dating from well before Applicant filed the applications for Applicant's Marks and/or commenced use of Applicant's Marks in United States commerce.

27. Applicant's Marks are similar in sight, sound, connotation, and overall commercial impression to the POLO Marks.

28. Applicant's Marks incorporate the POLO Marks.

29. Applicant's Goods are identical or similar to the goods for which RL is using the POLO Marks.

30. The polo player image adopted and used by Applicant is designed to be almost identical to the Polo Player Symbol used and registered by RL in connection with the POLO Marks.

31. Registration and/or use of Applicant's Marks are therefore likely to cause confusion, mistake, or deception as to the source of Applicant's Goods. Accordingly, Applicant's Marks should be refused registration pursuant to the provisions of 15 U.S.C. § 1052(d).

COUNT II
DILUTION

32. Opposer re-alleges and incorporates by reference the allegations set forth in the preceding paragraphs of this Notice of Opposition.

33. Through RL's extensive advertisement, promotion, and substantial sales, the POLO Marks have become famous.

34. Any use by Applicant of Applicant's Marks has occurred after the POLO Marks had already become famous.

35. Consumers are likely to make an association between Applicant's Marks and the POLO Marks.

36. Applicant's Marks are likely to dilute and impair the distinctiveness of the POLO Marks.

37. Thus, if Applicant is permitted to register and use Applicant's Marks, they are likely to cause dilution of the distinctive quality of the POLO Marks, and Applicant's Marks should therefore be refused registration pursuant to the provisions of 15 U.S.C. § 1125(c).

W H E R E F O R E Opposer prays that the Board sustain the Opposition and refuse registration of Applicant's Marks.




