NOTICE OF OPPOSITION

Compagnie des Montres Longines, Francillon S.A. (Longines Watch Co., Francillon Ltd.), 15 Rue Agassiz, St.-Imier, Switzerland, a Swiss corporation duly organized and existing under the laws of Switzerland, (“Longines” or “Opposer”), through its attorneys, believes that it would be damaged by the registration of the mark shown in the above-identified application (“Applicant’s Mark”), and hereby opposes same, pursuant to 15 U.S.C. § 1063 and 37 C.F.R. § 2.104.

As ground for the opposition, it is alleged that:

1. Longines has been engaged in the sale and marketing of highly related goods to those recited by Applicant in its application to register since prior to the filing of its application.

2. Longines is and has been engaged in the sale and marketing of a variety of goods, including watches, watch parts, jewelry, sunglasses, and eyeglasses, long preceding the filing date of Applicant's application.

3. Longines is the owner of the entire right, title, and interest in United States Trademark Registration No. 1,328,417 for the mark  (hereinafter referred to as the "Longines Mark"). (See Exhibit 1)

4. Registration 1,328,417 is incontestable, pursuant to Section 15 of the Trademark Act.

5. Longines has used the Longines Mark in commerce extensively and has acquired a considerable and valuable goodwill and wide scale recognition for its mark. The public has come to associate the Longines Mark with Opposer and Opposer's goods. The Longines Mark has acquired distinctiveness.

6. In addition, Opposer sells and has common law rights in the Longines Mark for goods other than those listed in the registrations. Such goods include caps, sun visors, umbrellas, travel bags, carry-on cases, suit bags, and leather purses and wallets. Longines has expended considerable time and energy to promote its Mark.

7. The Longines Mark has been made famous throughout the world, including within the United States.

8. Longines' registration is prima facie proof of ownership and use of the Longines Mark from at least as early as the original date of filing of the application, pursuant to 15 U.S.C. § 1057(b), and of the exclusive right to use the Longines Mark in commerce.

9. Applicant's mark is confusingly similar to Opposer's registered trademark and is likely, when applied to the goods and services of the Applicant, to cause confusion, or to cause mistake or to deceive. 15 U.S.C. § 1052(d). Applicant's mark makes a highly similar commercial impression to Opposer's Longines Mark due to its virtually identical appearance. The overall commercial impression of Applicant's mark, when applied to the same or similar goods, would cause confusion or be likely to cause confusion, mistake, or deception.

10. Opposer has used its Longines Mark in commerce extensively and has acquired a considerable and valuable goodwill and widescale recognition for its mark. The public has come to associate the Longines Mark with Opposer and Opposer's goods and services.

11. On information and belief, use of the Applicant's Mark by the Applicant for its goods in Class 14 will cause confusion, mistake, and deception with respect to those goods, by virtue of the Opposer's prior use and fame of its Longines Mark.

12. On information and belief, both Applicant's mark and the Longines Mark are applied to highly-related goods, if not identical goods, and are likely to be sold to the same or similar channels of distribution. Applicant's mark so resembles the Longines Mark, as used in the United States and not abandoned, as to be likely to cause confusion, or to cause mistake or to deceive.

13. Opposer has spent a significant amount of time and money in making its Longines Mark famous throughout the world.

14. Opposer has used the Longines Mark on highly related goods and services to those recited by Applicant in its application, since a time prior to Applicant's first use of its mark.


15. Applicant's actions would substantially harm the Opposer, by permitting registration in favor of Applicant for a mark which the Opposer used on its goods from an earlier date.

16. Opposer's Longines Mark is a famous mark.

17. Applicant's mark dilutes or is likely to dilute the distinctive character of Opposer's Longines Mark.

WHEREFORE, Longines therefore prays that Applicant's application (Serial No. 86/409,696) be refused, that no registration be issued thereon to Applicant and that this Opposition be sustained in favor of Longines.
