NOTICE OF OPPOSITION

Opposer, Columbia Insurance Company, a Nebraska Corporation having its principal place of business at 3024 Harney Street, Omaha, NE 68131 ("Opposer"), believes it will be damaged by the allowance and subsequent registration of the mark based upon the above-referenced application, and hereby opposes registration thereof pursuant to Section 13 of the Lanham Act, 15 U.S.C. §1063, alleging as grounds for opposition that:

1. Opposer currently uses the trademark **BORN** on or in connection with footwear and other goods.
2. Opposer, through its licensee, markets footwear and other goods in the United States and elsewhere under the trademark **BORN**.
3. Opposer is the owner of the below-listed U.S. Trademark Registrations for its **BORN** marks (attached hereto as the exhibits indicated below are printouts from the TSDR database of Opposer's registrations and made of record in this proceeding pursuant to 37 C.F.R. §2.122(d)(1); hereinafter "Opposer's Marks"):

4. The records of the USPTO indicate that Applicant, Flair Industries Pty Ltd, is a Proprietary Limited Company organized under the laws of Australia with an address of record of PO Box 263, Preston VIC 3072, Australia.

5. The records of the USPTO indicate that Applicant is the owner of Application Serial No. 79/151,220, filed May 27, 2014, for the following mark in connection with the following goods ("Applicant's Mark"):

6. Applicant filed its application under Section 66(a) of the Lanham Act, 15 U.S.C. §1141(f)(a), based upon International Registration No. 1214057 and claiming a priority date of May 8, 2014.

7. Opposer's rights in Opposer's Marks and its common law rights in its **BORN** trademarks are prior in time to any date Applicant is entitled to rely upon in this proceeding.

8. Opposer's Registrations Nos. 1,947,333, 3,512,409, and 3,542,937 issued prior to any date Applicant is entitled to rely upon in this proceeding.

9. The specific goods "socks," "articles of footwear," "shoes," "boots," "slippers" and "sandals" identified in Application Serial No. 79/151,220 ("opposed goods") are identical or closely related to the goods identified in Opposer's Registrations Nos. 1,947,333; 3,512,409; and 3,542,937.

10. In view of the similarities between Opposer's Marks and Applicant's Mark and the fact that Applicant's opposed goods are identical or closely related to Opposer's goods, there is a likelihood that Applicant's opposed goods will be perceived as being sponsored by or affiliated with Opposer.

11. Applicant's Mark so resembles Opposer's Marks, as to be likely to cause confusion, or to cause mistake, or to deceive as to the source of the opposed goods within the meaning of Section 2(d) of the Lanham Act, 15 U.S.C. §1052(d).


12. The use and registration of Applicant's Mark in connection with the opposed goods will damage Opposer in the advertising and sale of its goods by causing a likelihood of confusion.

WHEREFORE, Opposer prays that the Trademark Trial and Appeal Board deny registration on Application Serial No. 79/151,220 with respect to the opposed goods "socks," "articles of footwear," "shoes," "boots," "slippers" and "sandals" and otherwise sustain this opposition with respect to such goods.
