In response to the Order dated May 23, 2016, the civil action *Hyson USA, Inc., Leonid Tansky, Enna Gazaryan. vs. Hyson 2U, Ltd., Karolis Kaminskas, Inc., Karolis Kaminskas*, Case No. 14 cv 04320 (N.D. Ill. 2014) which occasioned the suspension of this proceeding remains pending.

On October 14, 2014, the Applicant appealed the judgment by the District Court dismissing its complaint – *Hyson USA, Inc., Leonid Tansky, Enna Gazaryan. vs. Hyson 2U, Ltd., Karolis Kaminskas, Inc., Karolis Kaminskas*, Case No. 14-3261 (7th Cir.).
