NOTICE OF OPPOSITION

Opposer, NIKE, Inc., whose address is One Bowerman Drive, Beaverton, Oregon 97005, believes it will be damaged by registration of the above-identified mark (hereinafter “Applicants’ Mark”) and opposes the same.

The grounds for the opposition are as follows:

1. Opposer is a leading sport and fitness company, and a leading provider of a broad range of clothing, footwear, sporting goods and related products and services.
2. Opposer is the owner of federal registrations and common law rights for the marks “JUST DO IT.” and “JUST DO IT” (collectively the “JUST DO IT Mark”).

3. Opposer has continuously used the JUST DO IT Mark in interstate commerce since at least as early as 1989, in connection with various clothing items.

4. Opposer has continuously used the JUST DO IT Mark in interstate commerce since at least as early as 2008, in connection with eyeglasses and sunglasses.

5. Opposer has continuously used the JUST DO IT Mark in interstate commerce since at least as early as 2010, in connection with various cell phone and hand-held computing device accessories.

6. Opposer is the owner of the following U.S. Trademark Registrations:

Opposer also owns pending U.S. trademark application SN 86/444,421 for JUST DO IT in International Classes 18 and 25. Over the years, Opposer has owned other registrations in the United States and throughout the world for the JUST DO IT Mark. Copies of the above registrations for the JUST DO IT Mark, including the USPTO TSDR records showing current status and title, are attached as Exhibit A. (As shown in the above registrations, the mark is registered both with and without a period after the words “JUST DO IT.”) A copy of the USPTO TSDR record for the pending application in Classes 18 and 25, showing current status and title, is attached as Exhibit B,

7. Registration No. 1,857,307 is incontestable pursuant to Section 15 of the Lanham Act, 15 U.S.C. § 1065, and thus serves as conclusive evidence of the validity of Opposer’s JUST DO IT. mark pursuant to 15 U.S.C. § 1115(b).

8. Opposer has made substantial sales of goods and services under its JUST DO IT Mark, and has used the JUST DO IT Mark as a slogan in highly successful advertising and promotional campaigns over the course of many years.

9. Opposer has brought numerous other successful oppositions based on the JUST DO IT Mark, including its opposition to the mark JUST JESU IT reported in *Nike, Inc. v. Peter Maher and Patricia Hoyt Maher*, 100 USPQ2d 1018 (TTAB 2011). In *Nike v. Maher*, the Board sustained Opposer's opposition on both the grounds of likelihood of confusion with the JUST DO IT Mark and dilution, and found that Opposer's JUST DO IT Mark was famous.

10. As a result of Opposer's long use and registration of its JUST DO IT Mark, Opposer has developed substantial goodwill in said mark, and the public has come to associate the JUST DO IT Mark with the goods and services of Opposer.

11. Applicant filed its application for Applicants' Mark on July 8, 2014, stating its intention to use the mark in connection with "Apparel for dancers, namely, tee shirts, sweatshirts, pants, leggings, shorts and jackets; Athletic apparel, namely, shirts, pants, jackets, footwear, hats and caps, athletic uniforms; Athletic shirts; Button down shirts; Button-front aloha shirts; Clothing for athletic use, namely, padded shirts; Collared shirts; Golf shirts; Graphic T-shirts; Hooded sweat shirts; Knit shirts; Long-sleeved shirts; Maternity clothing, namely, shirts; Night shirts; Open-necked shirts; Polo shirts; Rugby shirts; Shirts and short-sleeved shirts; Shirts for infants, babies, toddlers and children; Short-sleeved or long-sleeved t-shirts; Short-sleeved shirts; Sleeves worn separate and apart from blouses, shirts and other tops; Sport shirts; Sports shirts; Sports shirts with short sleeves; Sun protective clothing, namely, shirts; Sweat shirts; T-shirts; Tee shirts; Triathlon clothing, namely, triathlon tights, triathlon shorts, triathlon singlets, triathlon shirts, triathlon suits; Turtle neck shirts; Wearable garments and clothing, namely,

shirts; Yoga shirts” in International Class 25.

12. If Applicant is permitted to register its mark, the registration will give Applicant a *prima facie* exclusive right to the use of Applicants’ Mark for the goods set forth in the application. Such registration would damage and injure Opposer.

COUNT I

LIKELIHOOD OF CONFUSION

13. Opposer repeats and realleges paragraphs 1-12 as paragraph 13 of this Count I.

14. Opposer’s use and registration of its JUST DO IT Mark is long prior to the filing date of the opposed Application.

15. On information and belief, Applicants were aware of Opposer’s JUST DO IT Mark at the time that they filed their application.

16. Applicants’ Mark is confusingly similar to Opposer’s JUST DO IT Mark.

17. Applicants’ use and registration of Applicants’ Mark will inevitably lead to confusion, to mistake, or to deception of the public within the meaning of Section 2(d) of the Lanham Act, 15 USC §1052(d), all to Opposer’s grave and irreparable damage.

18. Registration of Applicants’ Mark should be denied based on a likelihood of confusion with Opposer’s prior JUST DO IT Mark, in violation of Section 2(d) of the Lanham Act, 15 USC §1052(d).

COUNT II

DILUTION

19. Opposer repeats and realleges paragraphs 1-18 as paragraph 19 of this Count II.

20. As a further ground for the opposition, Opposer's JUST DO IT Mark, which has been in use in commerce for more than twenty-five years, and registered for more than twenty years, is famous within the meaning of Lanham Act Section 43(c), 15 USC 1125(c).

21. Opposer's JUST DO IT Mark became famous prior to the filing date of the application for Applicants' Mark and prior to any date of first use or first use in commerce of Applicants' Mark.

22. Registration of Applicants' Mark is likely to cause dilution of Opposer's JUST DO IT Mark, to the injury of Opposer, by lessening the capacity of Opposer's JUST DO IT Mark to identify and distinguish Opposer's goods and services, in violation of Section 43(c) of the Lanham Act, 15 USC §1125(c) or by otherwise diluting or tarnishing Opposer's famous JUST DO IT Mark.

23. Registration of Applicants' Mark should be denied based on a likelihood of dilution of the distinctive quality of Opposer's famous JUST DO IT Mark, in violation of Section 43(c) of the Lanham Act, 15 USC §1125(c).

CLAIM FOR RELIEF/DAMAGE

24. By reason of the foregoing, Applicants' registration of the mark herein opposed will cause injury and damage to Opposer's rights to its registered JUST DO IT Mark and to its use thereof described above.

WHEREFORE, Opposer respectfully prays that the present opposition be sustained and that the registration sought by the Applicant be refused.
