NOTICE OF OPPOSITION

Opposer Cave Springs, Inc. and its related entities and affiliates (collectively, “Opposer” or “Cave Springs”) believes that it is or will be damaged by the registration of United States Trademark Application Serial No. 86/416,858, as filed with the United States Patent and Trademark Office (hereinafter “USPTO”), on October 7, 2014, by Kelly Grudt (hereinafter “Applicant”), for the mark GOT BOUNCEBACK in connection with: “clothing, namely, t-shirts, sweatshirts, hoodies, tanktops, woven shirts, denim, shorts, jackets, hats, beanies” in International Class 25 (hereinafter “Applicant’s Goods”). Cave Springs hereby opposes said application under the provisions of Section 13 of the Trademark Act of 1946 (hereinafter “Lanham Act”), 15 U.S.C. § 1063.

As grounds for the Opposition, Cave Springs alleges the following:

- (1) Cave Springs is a Delaware corporation with an address at 2751 Centerville Road, Wilmington, Delaware, 19808.

(2) Opposer is the world's largest designer and retailer of maternity apparel (the "Cave Springs Goods and Services") and owns the well-known trademarks MOTHERHOOD MATERNITY®, A PEA IN THE POD®, and DESTINATION MATERNITY®. Cave Spring's related entity, Destination Maternity Corporation, operates 1,875 retail locations, including 564 stores, predominately under the MOTHERHOOD MATERNITY®, A PEA IN THE POD®, and DESTINATION MATERNITY® trademarks. In addition, Destination Maternity has international store franchise and product supply relationships in the Middle East, South Korea, Mexico and Israel.

(3) In connection with the Cave Springs Goods & Services, Cave Springs uses in interstate commerce, among others, the trademarks "MOTHERHOOD", "MOTHERHOOD MATERNITY", "A PEA IN THE POD", and "A PEA IN THE POD COLLECTION" and owns United States Trademark Registration Nos. 1,055,611, 3,574,541, 1,898,334, 1,432,037, 1,427,963, and 3,768,280, among others, for the same. Attached hereto as *Exhibit A* and made part of the record are true and correct copies of the United States Certificates of Registration and TESS print-outs from the USPTO website for the trademarks MOTHERHOOD, MOTHERHOOD MATERNITY, A PEA IN THE POD, and A PEA IN THE POD COLLECTION.

(4) Furthermore, in connection with the Caves Springs Goods & Services, Cave Springs intends to use in interstate commerce the trademarks "MOTHERHOOD BOUNCEBACK COLLECTION" and "A PEA IN THE POD BOUNCEBACK COLLECTION" and owns two intent-to-use-based United States Trademark Applications Serial Nos. 86/412,894 (for the former mark) and 86/412,897 (for the latter mark) for use in connection with "Clothing, namely, jeans, pants, shirts, tops, blouses, t-shirts, tank tops, camisoles, sweaters, dresses,

blazers, shorts, skirts, jackets, coats, vests, loungewear, jumpers, sweat pants, yoga pants, sweat jackets, sleepwear, robes, bras, underwear, shapewear, namely, panties, shorts, camisoles, and tank tops, swimwear, swim and beach cover-ups, leggings, hosiery, tights, maternity garments, namely, elastic fabric band to be worn during and after pregnancy to retain unfastened pre-pregnancy pants and skirts or oversized maternity clothing; nursing apparel, namely, tops, shirts, t-shirts, tank tops, blouses, camisoles, dresses, bras, shapewear, namely, camisoles and tank tops, and sleepwear” in International Class 25 (collectively, hereinafter, the “BOUNCEBACK COLLECTION Marks”). These applications for the BOUNCEBACK COLLECTION Marks were awarded a filing date of October 2, 2014 (collectively, hereinafter, the “BOUNCEBACK COLLECTION Applications”). Attached hereto as *Exhibit B* and made part of the record are true and correct copies of TSDR and TESS print-outs from the USPTO website for the BOUNCEBACK COLLECTION Marks.

(5) On information and belief, Applicant is an individual having an address of 2319 Sierra Stone Lane, Las Vegas, Nevada 89119-4633.

(6) Notwithstanding Cave Springs’ exclusive rights in and to the BOUNCEBACK COLLECTION Marks, on October 7, 2014, Applicant filed an intent-to-use application under Section 1(b) of the Lanham Act, 15 U.S.C. § 1051(b), with the USPTO for registration of the mark GOT BOUNCEBACK (hereinafter the “GOT BOUNCEBACK Application”). The Application was assigned Serial No. 86/416,858. Attached hereto as *Exhibit C* and made part of the record are true and correct copies of TSDR and TESS print-outs from the USPTO website for the GOT BOUNCEBACK mark.

(7) Based on Cave Springs' BOUNCEBACK Collection Applications, Applicant knew or should have known of Cave Springs' BOUNCEBACK COLLECTION Marks when Applicant filed the GOT BOUNCEBACK Application. *Compare Exhibit B with Exhibit C.*

LIKELIHOOD OF CONFUSION
Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d)

(8) Cave Springs re-alleges the allegations contained in Paragraphs 1 through 7 of this Notice of Opposition.

(9) Applicant's alleged mark GOT BOUNCEBACK wholly incorporates the term BOUNCEBACK, which is uniquely distinctive for Cave Springs' BOUNCEBACK COLLECTION Marks, and thus so resembles Cave Springs' BOUNCEBACK COLLECTION Marks in appearance, sound, meaning, and commercial impression, such that use and registration thereof is likely to cause confusion, mistake, and deception as to the source or origin of Applicant's Goods in violation of Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d), and will injure and damage Cave Springs and the goodwill and reputation symbolized by Cave Springs' BOUNCEBACK COLLECTION Marks.

(10) Cave Springs filed its BOUNCEBACK COLLECTION Applications before Applicant filed the GOT BOUNCEBACK Application, and consequently there is no question of priority of rights, as such priority clearly belongs to Cave Springs.

(11) Applicant's Goods specified in the GOT BOUNCEBACK Application are so related to the goods offered in connection with Cave Springs' BOUNCEBACK COLLECTION Marks that the public is likely to be confused, deceived, and to assume erroneously that Applicant's Goods are those of Cave Springs' or that Applicant is in some way connected with, licensed, or sponsored by or affiliated with Cave Springs, all to Cave Springs' irreparable damage.

(12) Likelihood of confusion is enhanced by the fact that Applicant's alleged mark GOT BOUNCEBACK wholly incorporates the uniquely distinctive term BOUNCEBACK, such that the public is likely to be confused, deceived, and to assume erroneously that Applicant's Goods are those of Cave Springs or that Applicant is in some way connected with, licensed, or sponsored by or affiliated with Cave Springs, all to Cave Springs' irreparable damage.

(13) Likelihood of confusion is enhanced by the fact that Applicant filed the GOT BOUNCEBACK Application and intends to make use of the alleged mark GOT BOUNCEBACK, and other intellectual property substantially similar to that first filed for by Cave Springs in connection with BOUNCEBACK COLLECTION Marks, to market Applicant's Goods.

(14) Likelihood of confusion is further enhanced by the fact that Cave Springs and Applicant market their goods and services in the same or similar channels of trade. For example, Applicant advertises Applicant's Goods online, as does Cave Springs, to clothing consumers through her website at <*onlygodknowswhyclothing.com*>.

(15) Applicant is not affiliated or connected with Cave Springs and has not been endorsed or sponsored by Cave Springs, nor has Cave Springs approved any of the goods intended to be offered or sold by Applicant under the GOT BOUNCEBACK mark.

(16) Applicant has never sought or obtained Cave Springs' permission to use the GOT BOUNCEBACK mark, nor has Cave Springs agreed to allow Applicant to use any of the terms incorporated in the BOUNCEBACK COLLECTION Marks.

If Applicant obtains such rights as conferred under the Principal Register of the Lanham Act, she will obtain at least a *prima facie* exclusive right to use her trademark, and Cave Springs

will be subjected to great and irreparable damage, and Applicant will enjoy unlawful gain and advantage to which it is not entitled under the Lanham Act.

WHEREFORE, Cave Springs believes and alleges that it is being, and will continue to be, damaged by the registration of the GOT BOUNCEBACK Application, and respectfully requests that the GOT BOUNCEBACK Application be rejected, that no registration be issued thereon to Applicant, and that the Opposition be sustained in favor of Cave Springs.

Cave Springs hereby appoints Ann K. Ford, a member of the Bar of the District of Columbia; Thomas E. Zutic, a member of the Bar of the District of Columbia; Ryan C. Compton, a member of the Bar of the District of Columbia; John M. Nading, a member of the Bar of the District of Columbia; David M. Kramer, a member of the Bar of the District of Columbia; Eunice R. Chung, a member of the Bar of the District of Columbia; and Ashley H. Joyce, a member of the Bar of the District of Columbia; and all of the law firm of DLA Piper LLP (US), 500 8th Street, N.W., Washington, D.C. 20004, telephone number (202) 799-4000, to transact all business in the USPTO in connection with this Opposition Proceeding and hereby revokes all previous powers of attorney herein.
