4. Applicant lacks knowledge or information sufficient to form a belief with regard to the allegations of Paragraph 4 of the Notice of Opposition and therefore denies such allegations.

5. Applicant lacks knowledge or information sufficient to form a belief with regard to the allegations of Paragraph 5 of the Notice of Opposition and therefore denies such allegations.
6. Applicant admits that it filed Application Serial No. 86/327,529. Applicant submits that U.S. Trademark Application No. 86/327,529 speaks for itself. Applicant denies the remaining allegations of Paragraph 6 of the Notice of Opposition.
7. Applicant admits the allegations of Paragraph 7 of the Notice of Opposition.
8. Applicant denies the allegations of Paragraph 8 of the Notice of Opposition.
9. Applicant admits that the RIVE GAUCHE portion of the parties' respective marks is similar in appearance sound and commercial impression.
10. Applicant lacks knowledge or information sufficient to form a belief with regard to the allegations of Paragraph 10 of the Notice of Opposition and therefore denies such allegations.
11. Applicant admits that allegations of Paragraph 11 but states that Applicant, as the senior user of the RIVE GAUCHE mark, denies that it requires Opposer's consent.
12. Applicant lacks knowledge or information to form a belief as to the truth of the allegations contained in Paragraph 12.
13. Applicant lacks knowledge or information sufficient to form a belief as to the truth of the allegations contained in Paragraph 13.
14. Applicant denies the allegations of Paragraph 14 of the Notice of Opposition.

GENERAL DENIAL

Except as expressly admitted herein, Applicant denies each and every allegation contained in the Notice of Opposition, and denies that Opposer is entitled to any relief requested, and therefore demands strict proof thereof.

AFFIRMATIVE DEFENSES

FIRST AFFIRMATIVE DEFENSE

The Notice of Opposition fails to state a claim upon which relief can be granted.

SECOND AFFIRMATIVE DEFENSE

Applicant is and has been engaged in the sale and marketing of goods under the trademark RIVE GAUCHE, since at least as early as 1966. Applicant is the owner of the valid and subsisting U.S. Trademark Registration Nos. 1680439; 1770566; 1901788; and 2383556, and

others, for the marks , YVES SAINT LAURENT RIVE GAUCHE,

RIVE GAUCHE and  (See Exhibit 1, attached)(collectively, the RIVE GAUCHE Marks). Opposer adopted its RIVE GAUCHE mark decades after Applicant's first use of the RIVE GAUCHE Marks. Applicant is the senior user of the RIVE GAUCHE Marks, and Opposer does not have priority.

THIRD AFFIRMATIVE DEFENSE

Acquiescence.

FOURTH AFFIRMATIVE DEFENSE

Waiver.

FIFTH AFFIRMATIVE DEFENSE

Unclean hands.

Wherefore, Applicant seeks that the Opposition be dismissed, with prejudice, in favor of Applicant.
