MOTION FOR PARTIAL SUMMARY JUDGMENT

Pursuant to Rule 56(a), F.R.Civ.P., Opposer hereby moves the Board for an Order of Partial Summary Judgment denying Applicant's Counterclaim for cancellation of the Certificate of Registration of the NATURE'S BEAUTY trademark (Registration No. 2,512,306) on the ground the trademark has been abandoned. This Motion is made on the grounds that, since November 27, 2001, Opposer has continuously used the NATURE'S BEAUTY trademark on goods recited in Registration No. 2,512,306 distributed and sold in interstate commerce.

I

STATEMENT OF FACTS

A. Statement of Proceeding.

This is an opposition proceeding instituted by Garcoa, Inc. (hereinafter referred to as "Opposer") opposing registration of Applicant's application to register the trademark NATURE.BEAUTY.HARMONY. Applicant has asserted a Counterclaim seeking cancellation of Registration No. 2,512,306 for the NATURE'S BEAUTY trademark on the ground "The mark in Opposer's registration has been abandoned."

B. Statement of Facts.

The facts supporting Opposer's Motion for Partial Summary Judgment are evidenced by the Declaration of Gregory Rubin and the identified exhibits. It is submitted the following facts are without controversy:

1. Garcoa, Inc. is a manufacturer of extensive lines of skin care and hair care products that are sold on both a private label basis using trademarks and brand names owned by customers of Opposer and under proprietary trademarks owned by Garcoa, Inc. *Rubin Declaration*, ¶2.

2. The NATURE'S BEAUTY trademark which is the subject of Registration No. 2,512,306 has been and is used to identify skin care and/or hair care products sold to retailers throughout the United States. *Rubin Declaration*, ¶2.

3. Substantially all skin care and hair care products manufactured by Garcoa, Inc. are made available to customers for their sale under the NATURE'S BEAUTY trademark. *Rubin Declaration*, ¶¶3,4.

4. Any hiatus between sales of specific skin care or hair care products identified by the NATURE'S BEAUTY trademark is solely the result of the frequency a product has been selected by the customers of Garcoa, Inc. *Rubin Declaration*, ¶4.

5. Opposer has created labels employing the NATURE'S BEAUTY trademark that have been used and are currently available for use to identify both skin care products and hair care products. *Rubin Declaration*, ¶3; Exhibit 1.

6. Since November 27, 2001, Opposer has and continues to distribute and sell in interstate commerce skin care and hair care products identified by the NATURE'S BEAUTY trademark. *Rubin Declaration*, ¶6; Exhibit 2.

7. At no time since November 27, 2001 has Opposer ever ceased bona fide use of the NATURE'S BEAUTY trademark in interstate commerce. *Rubin Declaration*, ¶7.

8. On November 11, 2015, counsel for the Applicant was provided with all documents attached hereto as Exhibits 1 - 3, inclusive. *Rubin Declaration*, ¶8.

II

SUMMARY JUDGMENT MAY BE GRANTED ONLY WHERE

THERE IS NO GENUINE ISSUE OF MATERIAL FACT

A. Standard.

Pursuant to Rule 56(a), F.R.Civ.P., summary judgment shall be rendered only if there is no genuine issue as to any material fact and the moving party is entitled to judgment as a matter of law. *British Airways Bd. v. Boeing Co.*, 585 F.2d 946, 951 (9th Cir., 1978), cert. den. 440 U.S. 981 (1979). In the decision of *Pure Gold, Inc. v. Syntex (USA), Inc.*, 739 F.2d 624, 222 U.S.P.Q. 741 (Fed. Cir., 1984), the Federal Circuit affirmed the Board's grant

of summary judgment in an opposition proceeding stating that the basic purpose of summary judgment is that of judicial economy and that it is against the public interest to conduct useless trials when they can be avoided by the summary judgment procedure. As to materiality, the substantive law identifies which facts are material. Entry of summary judgment must be denied if there is a genuine dispute over facts that will affect the outcome of the suit under governing law. *Anderson v. Liberty Lobby, Inc.*, 477 U.S. 242, 248, 106 S.Ct. 2505, 2510, 91 L.Ed.2d 202 (1986). Consequently, where the record, taken as a whole, would lead a reasonable trier of fact to find for the non-moving party, there is a genuine issue for trial. *Matsushita Electric Industrial Co. v. Zenith Radio Corp.*, 475 U.S. 574, 106 S.Ct. 1348, 1456, 89 L.Ed.2d 538 (1986).

B. Burden of Moving Party.

The initial burden is on a movant for summary judgment. In general, the movant must establish the absence of genuine issues of material fact and thereby establish entitlement to judgment as a matter of law. Rule 56(c), F.R.Civ.P. The standard used to determine motions for summary judgment mirrors the standard for a directed verdict under Rule 50(a), F.R.Civ.P., which is that "the trial judge must direct the verdict if, under the governing law, there can be but one reasonable conclusion as to the verdict." *Anderson v. Liberty Lobby, Inc.*, *supra*, 477 U.S. at 250, 106 S.Ct. at 2511. The moving party must make a showing sufficient to the trier of fact of fact could find other than for the moving party. *Calderone v. United States*, 799 F.2d 254, 259 (6th Cir., 1986).

C. Shifting the Burden of Proof to Non-Moving Party.

The burden imposed on a movant for summary judgment requires it to make a prima facie showing of the absence of genuine issues of material fact. *Drexel v. Union Prescription Centers, Inc.*, 582 F.2d 781, 790 (3rd Cir., 1978). Only after the moving party has sustained its initial burden does the burden shift to the non-moving party which must then come forward with evidence. The quantum of proof the non-moving party must produce is not precisely measurable, but it must produce enough evidence so that a reasonable trier of fact could

return a verdict or judgment for the non-movant. *Anderson v. Liberty Lobby, Inc., supra.*, 477 U.S. at 257. A genuine issue of material fact exists only if the non-moving party makes a sufficient showing to establish an essential element to its case, and on which that party will bear the burden of proof at trial. *Celotex Corp. v. Catrett*, 477 U.S. 317, 322-23, 106 S.Ct. 2548, 91 L.Ed.2d 265 (1986). The evidence of the non-moving party is to be believed, and all justifiable inferences are to be drawn in its favor. *Anderson v. Liberty Lobby, Inc., supra.*, 477 U.S. at 248; *Griffeth v. Utah Power & Light Co.*, 226 F.2d 661, 669 (9th Cir., 1955).

III

THE NATURE'S BEAUTY TRADEMARK HAS BEEN IN CONTINUOUS USE IN INTERSTATE COMMERCE SINCE THE DATE OF REGISTRATION

Section 45 of the Lanham Act provides, in pertinent part, that a trademark is abandoned when the following occurs:

“(1) When its use has been discontinued with intent not to resume such use. Intent not to resume may be inferred from circumstances. Non-use for 3 consecutive years shall be prima facie evidence of abandonment. ‘Use’ of a mark means the bona fide use of that mark made in the ordinary course of trade, and not merely to reserve a right in the mark.”

A party resisting a claim for cancellation of a trademark based on abandonment may rebut the claim by showing use of the trademark directly or by a licensee. *Giersch v. Scripps Networks, Inc.*, 90 U.S.P.Q.2d 1020, 1024 (TTAB, 2009). To avoid abandonment, the “use” asserted by the owner of the trademark must meet the strict standard of “the bona fide use of a mark made in the ordinary course of trade, and not merely to reserve a right in the mark.” *Paramount Pictures Corp. v. White*, 31 U.S.P.Q.2d 1768, 1774 (TTAB, 1994). For a trademark to be considered to have been used on goods, it must be placed in any manner on the goods or their containers or the

displays associated therewith or on the tags or labels affixed thereto or on documents associated with the goods or their sale and the goods must be sold or transported in commerce. *Lanham Act*, §45, 15 U.S.C. §1127. In the present case, the evidence presented by Opposer to rebut the claim of abandonment is:

1. Labels for skin and hair care products that have been and are available for use on products ordered by customers;
2. A representative sample of purchasers orders and invoices showing the continuous sale of goods identified by the NATURE'S BEAUTY trademark from January 28, 2005 - November 3, 3015;
3. Photographs showing products identified by the NATURE'S BEAUTY trademark on the shelf of Opposer's customer on November 4, 2015.

When the owner of a trademark ceases use of the mark, the issue is whether the trademark owner intended to resume use, not whether the owner intended to abandoned the trademark. *Rivard v. Linville*, 133 F.3d 1446, 1449, 45 U.S.P.Q. 1374, 1376 (Fed. Cir., 1998). To avoid a finding of abandonment, the trademark owner must submit evidence "with respect to what activities it engaged in during the non-use period or what outside events occurred from which an intent to resume use from during the non-use period may reasonably be inferred. *Imperial Tobacco Ltd. v. Philip Morris, Inc.*, 899 F.2d 1575, 1581, 14 U.S.P.Q.2d 1390, 1394 (Fed. Cir., 1990). The President of Opposer has testified that substantially all skin care and hair care products manufactured by Opposer were at all times available to customers to be packaged under the NATURE'S BEAUTY trademark. Any hiatus between sales of a specific product was solely based on the products a customer wanted to sell under the NATURE'S BEAUTY trademark not any action or inaction on the part of Opposer. The evidence before the Board comprises labels of skin care and hair care products that have been used or are available for use by customers and invoices and purchase orders covering the period 2008 through November 4,

2015. It is therefore submitted there is no material fact in controversy regarding whether Opposer abandoned the NATURE'S BEAUTY trademark.

IV


CONCLUSION

DECLARATION OF GREGORY A. RUBIN IN SUPPORT OF
OPPOSER’S MOTION FOR PARTIAL SUMMARY JUDGMENT

I, GREGORY A. RUBIN, do hereby declare and say that:

1. I am the President of Garcoa, Inc., the Opposer in the above matter.
2. Garcoa, Inc. is a manufacturer of extensive lines of skin care and hair care products. The products manufactured by Garcoa, Inc. are sold on both a private label basis using trademark and brand names owned by Garcoa, Inc.’s customers and under proprietary trademarks owned by Garcoa, Inc. NATURE’S BEAUTY is a trademark owned by Garcoa, Inc. that is used to identify skin care and/or hair care products sold to retailers throughout the United States.

3. Garcoa, Inc. maintains its own art department and has the ability to design and manufacture product labels to meet the requests of a customer. Attached hereto as Exhibit 1 are representative samples of labels employing the NATURE'S BEAUTY trademark that have been and are currently available for use to identify both skin care products and hair care products. The labels collectively identified as Exhibit 1 are true and correct copies of labels that have been used in the past and which are currently available for use.

4. When a customer wants to purchase a line of products identified by the NATURE'S BEAUTY trademark, the customer selects from the skin care and hair care products manufactured by Garcoa, Inc. the products that are going to be sold by the customer under the NATURE'S BEAUTY trademark. Substantially all skin and hair care products manufactured by Garcoa, Inc. are always available to be selected by customers to be sold under the NATURE'S BEAUTY trademark. Any hiatus between sales of specific skin care or hair care products is solely the result of the frequency a product is selected by customers.

5. The Applicant has asserted a Counterclaim seeking to cancel the Certificate of Registration of the NATURE'S BEAUTY trademark alleging in Paragraph 12 of the Answer to Notice of Opposition and Counterclaim for Cancellation that: "Applicant is unable to find sale of any of the goods in the registration, whether directly through the Opposer or via third party retailers." Applicant further alleges in Paragraph 12 that "Opposer's registration has been abandoned ..." The allegations of Applicant are totally false.

6. Attached collectively as Exhibit 2 is a representative sample of purchase orders received by Garcoa, Inc. from customers and invoices issued by Garcoa, Inc. covering skin care and hair care products manufactured by Garcoa, Inc in general. The documents identified as Exhibit 2 cover the period from 2008 through November 3, 2015 and are true and correct copies of the purchase orders and invoices used in the stated transactions. The purchase orders and invoices identified by Exhibit 2 specify whether products were sold as private label products using the label and/or trademark of the customer as well as the products sold under


proprietary trademarks owned by Garcoa, Inc. All invoices that are part of Exhibit 2 identify products identified by the NATURE'S BEAUTY trademark by using the abbreviation "NBTY." Exhibit 2, page 46 exhibits purchase order from 99¢ Only Stores identifying the specific proprietary trademarks under which Garcoa, Inc. sells its product. As can be seen in Exhibit 2, page 46, the reference to NATURE'S BEAUTY GEL MEGA constitutes a styling gel product manufactured by Garcoa, Inc. that has been sold by Garcoa, Inc. under the label shown in Exhibit 1, page 1.

7. Since November 27, 2001, the date of registration of the NATURE'S BEAUTY trademark, Registrant has continuously maintained bona fide use of the NATURE'S BEAUTY trademark in the United States.

8. Paragraph 12 of the Counterclaim alleges that Opposer was unable to find sales of any of the goods in the registration. Irrespective of how this purported search was done, the products identified by the NATURE'S BEAUTY trademark were available for sale by customers of Garcoa, Inc. Attached hereto as Exhibit 3, pages 1 and 2, are photographs of Garcoa, Inc.'s NATURE'S BEAUTY products on the shelf at Discount Drug Mart in Medina, Ohio (see Exhibit 2, pages 4 - 6, inclusive). Most importantly, Exhibit 3, page 2 shows the date when the photograph was taken (i.e., November 4, 2015). The documents identified by Exhibits 1, 2 and 3 were provided to counsel for the Applicant on November 11, 2015.

9. The undersigned being hereby warned that willful false statements and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. §1001, and that such willful false statements may jeopardize the validity of this cancellation proceeding.
