



NOTICE OF OPPOSITION

Opposers Dean Rohn and Debbie Rohn, as husband and wife and owners (hereinafter “the Opposers”), having a mailing address and principal place of business at 4794 Timber Ridge Drive, Cadillac, Michigan 49601, believe that they would be damaged by the registration of the mark MINNOWS & GUPPIES (“Applicant’s Mark”) as applied for in U.S. Trademark Application Serial No. 86/540,148 (the “Application”) filed by Minnows & Guppies LLC, 501 Stough Road, Brewster, Massachusetts 02138. Applicant’s Mark should not be passed to issue.

As grounds for its Opposition, Opposers, by and through its attorneys, Howard & Howard Attorneys PLLC, plead as follows:

1. On February 19, 2015, Minnows & Guppies LLC (the “Applicant”), which states in its Application that it is a Massachusetts limited liability company having offices at 501 Stough Road, Brewster, Massachusetts 02138, filed the intent-to-use Application for registration of the mark MINNOWS & GUPPIES (the “Applicant’s Mark”) in connection with “Online retail store services featuring children’s apparel, accessories and footwear; retail store services featuring children’s apparel, accessories and footwear” in International Classes 100, 101 and 102 (“Applicant’s Goods”). The Application was published for opposition on July 21, 2015.

2. Since well before to February 19, 2015, Opposers have used in interstate commerce, and continue to use in interstate commerce, the mark GUPPIE and the mark GUPPIE and Design, which are summarized in the table below (collectively, the “GUPPIE Registrations”).

3. Opposers own federal trademark registrations for the Mark GUPPIE and the mark GUPPIE and Design, which are summarized in the table below (collectively, “GUPPIE Registrations”).

Copies of the GUPPIE Registrations are attached as **Exhibit A**. The GUPPIE Registrations are valid, subsisting and in full force and effect. Copies from the United States Patent and Trademark Office's ("USPTO") Trademark Status & Document Retrieval Database, showing the current status and title for the GUPPIE Registrations, are attached as **Exhibit B**.

4. Opposers are the owner of all common law and federal trademark rights in the marks shown.

5. Because of the high quality of Opposers' Goods sold under the GUPPIE Mark, and because of Opposers' advertising and promotion of such marks in connection with Opposers' Goods, Opposers have developed goodwill in the GUPPIE Marks.

Applicant's Confusingly-Similar Mark

6. Applicant's MINNOWS & GUPPIES mark and Opposers' GUPPIE Marks share the identical "GUPPIE" element. There are obvious spelling, phonetic, and visual similarities

between MINNOWS & GUPPIES and Opposers' GUPPIE Marks. Consequently, the respective marks all look and sound alike when pronounced. Further, Applicant's MINNOWS & GUPPIES mark and Opposers' GUPPIE Marks have similar meanings and similar commercial impressions.

7. Additionally, Applicant intends to offer "apparel" under its MINNOWS & GUPPIES mark and Opposers' Goods include hats, jackets, boxer briefs and/or boxer shorts, pants, shirts, shorts, t-shirts, ties, sweatshirts, hooded shirts, gloves and infant's underwear. The Board has commonly found "apparel" and "clothing" or "hats, jackets, boxer briefs and/or boxer shorts, pants, shirts, shorts, t-shirts, ties, sweatshirts, hooded shirts, gloves and infant's underwear" to be the same (or similar enough) for purposes of the likelihood of confusion analysis.

8. Because both parties' products are apparel, they are also likely to flow through the same channels of trade to the same class of purchasers, particularly as to the children's apparel (or clothing) sold by both Applicant and Opposer.

9. Use and registration of Applicant's Mark is likely to cause confusion, mistake, or deception not only as to the source of the goods, but also confusion, mistake, or deception as to whether Applicant's Goods sold under Applicant's Mark are at least endorsed by, or in some way sponsored by or associated with that of Opposers.

10. If Applicant succeeds in registering Applicant's Mark, statutory rights would be created which will violate earlier established rights of Opposers, all to the harm of Opposers' goodwill and with resultant diminution of Opposers' rights in its GUPPIE Marks. Hence, registration of Applicant's Mark would result in damage and injury to Opposers and to the

public. Therefore, registration of Applicant's Mark should be denied under Section 2(d) of the Lanham Act (15 USC § 1052(d)).

WHEREFORE, Opposers pray that the Board reject Application Serial No. 86/540,148, sustain this opposition, and grant Opposers such other different and additional relief as the Board deems just and proper.






