NOTICE OF OPPOSITION

The above-identified Opposer believes that it will be damaged by registration of the mark shown in the above-identified application, and hereby opposes the same.

The grounds for the opposition are as follows:

1. This is an opposition by Synergent, a leading service company providing a variety of services to credit unions throughout New England and New York, to prevent another from registering the trademark "CU24," which is identical to Synergent's common law and state registered mark "CU24."

2. Synergent uses the CU24 mark in connection with promoting its technology, bank card, ATM, checking and marketing services to credit union consumers. The services are provided to customers in multiple states.

3. Synergent first began promoting its credit union services under the trademark CU24 at least as early as 1990. Since that time, Synergent has spent significant time and money promoting that trademark to customers throughout New England and New York. Customers have come to know the CU24 mark as a symbol of Synergent's quality services. The CU24 mark had become famous before Applicant's first use of the CU24 mark.

4. Synergent owns Maine Trademark Registration No. 19910130 M, dated December 17, 1990, for the mark "CU-24 (& Design)" for "financial services; ATM services" in Class 037. A copy of the Certificate of Registration, the Articles of Amendment evidencing the assignment of that registration by means of change of owner name to Synergent, and the registration renewals are attached as Exhibit 1.

5. Synergent owns Maine Trademark Registration No. 20140120 M, dated December 12, 2013, for the mark "CU24" for "financial services; ATM services" in Class 037. A copy of the Certificate of Registration is attached as Exhibit 2.

6. Synergent owns New Hampshire Trademark Registration No. 5921, dated December 19, 2013, for the mark "CU24" for "financial services; ATM services" in Class 102. A copy of the Certificate of Registration is attached as Exhibit 3.

7. Synergent owns Massachusetts Trademark Registration No. 1211952, dated December 16, 2013, for the mark "CU24" for "financial services; ATM services" in Class 036. A copy of the Certificate of Registration is attached as Exhibit 4.

8. Synergent owns Rhode Island Trademark Registration No. 201312017, dated December 19, 2013, for the mark "CU24" for "financial services; ATM services" in Class 036. A copy of the Certificate of Registration is attached as Exhibit 5.

9. Synergent owns Connecticut Trademark Registration No. 0039463803, dated December 16, 2013, for the mark "CU24" for "financial services; ATM services" in Class 036. A copy of the Certificate of Registration is attached as Exhibit 6.

10. Synergent owns New York Trademark Registration No. S22828, dated February 11, 2014, for the mark "CU24" for "financial services; ATM services" in Class 036. A copy of the Certificate of Registration is attached as Exhibit 7.

11. On April 24, 2002, Credit Union 24, Incorporated ("Applicant"), filed an application with the U.S. Patent and Trademark Office to register the trademark CU24, Serial Number 76399306 (the '306 Application). The application requested registration for "financial management and computerized electronic funds transfer ("EFT") services, namely, offering automated teller machine and point-of-sale network services for credit unions, other financial institutions, merchants, processors and other entities, which permit credit union and other financial institution customers to remotely access their accounts; providing reciprocal interchange arrangements with other EFT networks; and providing ancillary services such as provisioning with encoding plastic cards, and provisioning ATM supplies; and providing all other EFT services which providers of EFT services are authorized to provide, namely, scrip and scrip terminals, prepaid cards, smart cards and providing EFT services via a global communications network" in International Class 036.

12. On November 5, 2003, Synergent filed an opposition to the registration of the '306 Application, TTAB proceeding number 91158461. On August 25, 2005, Applicant withdrew the '306 Application with prejudice and with Synergent's consent and reliance, and Synergent's opposition was thereafter dismissed. A copy of Applicant's Express Withdrawal of Application With Prejudice, With Consent of Opposer, relating to the '306 Application is attached as Exhibit 8. A copy of the TTAB Order acknowledging the abandonment of the '306 Application is attached as Exhibit 9.

13. On November 26, 2014, Applicant filed the instant application to register the trademark CU24, the identical mark as in the '306 Application. The instant application requests registration for "Providing credit union services and ATM banking services in the nature of providing credit unions and retailers with automated teller machine and electronic network services

at point of sale for credit union customers; Providing electronic funds transfer services between credit unions and retailers by telecommunications at point of sale for credit union customers; Providing electronic processing of electronic funds transfer, ACH, credit card, debit card, electronic check and electronic payments between credit unions and retailers at point of sale for credit union customers” in International Class 036. The application is based on Applicant’s alleged use of the mark in commerce.

14. Synergent’s rights in the CU24 mark predate Applicant’s rights (if any) in the CU24 mark.

15. The date of registration for each of Synergent’s state trademark registrations for the CU24 mark predates the filing date of the Applicant’s application.

16. The CU24 mark so closely resembles Synergent’s CU24 mark when applied to the services covered by the Application as to cause confusion, mistake or deception as to the source of Applicant’s services.

17. Applicant’s services are closely related to the services covered by Synergent’s state trademark registrations for the CU24 mark, and to the services offered by Synergent in interstate commerce. As a result of the similarity of services, the public is likely to be confused about whether Synergent is the source of Applicant’s services or whether Synergent is affiliated with or the sponsor of Applicant’s services.

18. Applicant’s registration and/or use of the CU24 mark will infringe and/or dilute Synergent’s prior rights in the CU24 mark.

19. Applicant’s registration and/or use of the CU24 mark will interfere with Synergent’s use of its CU24 mark and will harm Synergent.

20. As a result of its abandonment of the ‘306 Application, with prejudice, Applicant is barred by the doctrine of equitable estoppel from applying to register the CU24 mark. *See Wells Cargo, Inc. v. Wells Cargo, Inc.*, 606 F.2d 961, 964 (C.C.P.A. 1979) (an applicant’s act of


withdrawing a prior application to register a mark "with prejudice" to its subsequent refilling causes the opposing party "to accept the dismissal of the opposition in the reasonable belief that any right [the applicant] may have had to seek registration of [the mark] is abandoned" such that applicant is equitably stopped from seeking to later register the mark).

Therefore, Synergent respectfully requests that the Board refuse registration of the CU24 mark.

The filing fee of \$300.00 for this Notice of Opposition is filed herewith.
