NOTICE OF OPPOSITION

Opposer Abercrombie & Fitch Trading Co. (“Opposer” or “A&F”), an Ohio corporation with its principal place of business at 6301 Fitch Path, New Albany, Ohio 43054, believes that it is or will be damaged by registration of Application Nos. 86/501,135, 86/690,124 and 86/690,155 (“collectively the “opposed applications”), owned by butter LONDON LLC (“Applicant”), a Delaware limited liability company with an address of 549 South Dawson Street, Seattle, Washington 98108, and hereby opposes the same.

The grounds for opposition are as follows:

Factual Background

1. The opposed applications were filed for registration on the Principal Register based on intent-to-use on the following dates: (a) Application No. 86/501,135 for SHADOWCLUTCH, filed January 12, 2015; (b) Application No. 86/690,124 for BRONZERCLUTCH, filed July 10, 2015, and (c) Application No. 86/690,155 for

BLUSHCLUTCH, filed July 10, 2015 (collectively, “Applicant’s Marks”). All of the opposed applications cover “cosmetics.”

2. Application No. 86/501,135 for SHADOWCLUTCH was published for opposition on June 2, 2015. Opposer timely sought, and was granted, an extension of time to oppose this application. Application No. 86/690,124 for BRONZERCLUTCH and Application No. 86/690,155 for BLUSHCLUTCH were published for opposition on September 29, 2015.

3. The parent company of Opposer, Abercrombie & Fitch Co., is one of the largest manufacturers, wholesalers and retailers of high quality, casual apparel and accessories, including fragrances and body sprays, for men, women, and children with an active, youthful lifestyle in the U.S.A.

4. Opposer is a wholly owned subsidiary and holding company of Abercrombie & Fitch Co., the parent company, a Delaware corporation.

5. Opposer is the owner of the following U.S. registrations for the “A&F CLUTCH Marks” (copies of the registration certificates and TSDR printouts for these registrations are attached as Exhibit A):

6. In accordance with § 5 of the Federal Trademark Act, all use of the A&F CLUTCH Marks by Opposer's affiliated and related companies, as alleged herein, inures to the benefit of Opposer.

7. All of Opposer's registrations identified in the chart above are *prima facie* evidence of the validity thereof and Opposer's ownership and exclusive right to use those marks in commerce, and are constructive notice of Opposer's ownership thereof, all as provided by §§ 7(b) and 22 of the Federal Trademark Act of 1946, as amended.

8. Opposer and its predecessors in interest have sold fragrances and colognes under the A&F CLUTCH Marks since at least as early as October 30, 2010, well prior to the filing date of the opposed applications. Opposer and its predecessors in interest have also used the A&F CLUTCH Marks with related goods in Class 3, namely, body sprays, deodorants and antiperspirants, as detailed in the chart above and in Exhibit A.

9. Opposer's A&F CLUTCH Marks have been in valid and continuous use since at least as early as each of the respective dates of first use and have not been abandoned.

10. A&F's goods bearing the A&F CLUTCH Marks are sold in Opposer's abercrombie kids stores as well as through its website www.abercrombiekids.com.

11. As a result of Opposer's long and continuous use of the A&F CLUTCH Marks since at least as early as October 30, 2010, and its substantial investment in advertising and promotion, the A&F CLUTCH Marks have become well-known among its actual and target purchasers of fragrances and body sprays, as well as other members of the public, as a distinctive symbol of Opposer's goodwill.

12. Opposer also has common law rights in the A&F CLUTCH Marks that it relies upon in its opposition to the opposed applications.

Likelihood of Confusion

13. Applicant's Marks so resemble the A&F CLUTCH Marks previously used and registered by Opposer as to cause mistake, or to deceive, or to cause confusion as to source, sponsorship or affiliation.

14. The goods included in Opposer's Registration Nos. 3,927,048, 3,927,049 and 4,511,050 are closely related to the goods covered by the opposed applications.

15. The goods covered by the opposed applications are likely to be sold to the same or overlapping classes of purchasers as goods bearing the A&F CLUTCH Marks, and further are likely to be sold through the same trade channels.

16. Opposer applied for and used the A&F CLUTCH Marks long prior to the filing date of the opposed applications.

17. Prospective purchasers, purchasers and others are likely to be confused, mistaken or deceived into the belief, contrary to fact, that Applicant's goods covered by the marks in the opposed applications emanate from and/or are in some way sponsored or approved by Opposer and/or that Applicant is somehow affiliated with Opposer, thereby damaging Opposer.

18. Applicant is not lawfully entitled to the registrations which it seeks for the reason, *inter alia*, that Applicant's Marks so resemble the A&F CLUTCH Marks as to be likely to cause confusion, to cause mistake or to deceive within the meaning of § 2(d) of the Federal Trademark Act, thereby damaging Opposer.

WHEREFORE, for the foregoing reasons, Opposer respectfully requests that the present opposition be sustained and the registration of Application Nos. 86/501,135, 86/690,124 and 86/690,155 be refused.
