NOTICE OF OPPOSITION

Opposer Brands Worldwide Holdings I.P. Pty. Limited Corporation (“Opposer”), an Australian corporation with its principal place of business at 101 Grafton Street Tower 2, Level 14, Bondi Junction, NSW Australia, believes that it would be damaged by issuance of a registration for the trademark NATRALUS as applied for in Application Serial No. [86336621](#) (the “Application”), by Natralus Australia Pty. Ltd. (the “Applicant”). Accordingly, Opposer, by and through its attorneys, hereby opposes the Application on the following grounds:

1. Opposer is a leading manufacturer of natural skin care products that are available worldwide, in physical retail stores as well as through various websites. Since 2002, Opposer has sold its flagship NATRALIA product line, which is made up of over 10 products that are of

pharmaceutical grade quality. Opposer has and will continue to bring new skin care products to the United States market.

2. Opposer is the owner of the following U.S. trademark registration (“Opposer’s Registration”):

Copies of Opposer’s Registration are enclosed as **Exhibit A**, along with print-outs from the Trademark Office’s electronic database showing the current status and title of the registration.

3. Since at least as early as 2002, Opposer has offered various goods under its NATRALIA mark. Opposer’s cosmetics and related goods are branded with the NATRALIA mark and are marketed and sold throughout the United States, both in retail stores and online.

4. On July 14, 2014, Applicant filed the Application to register the following trademark on the Principal Register:

Applicant's Application was published for opposition in the Official Gazette on June 16, 2015.

5. The goods and services listed in the Application are highly similar to those listed in Opposer's Registration, and appear likely to be offered in the same commercial channels as the cosmetics and other goods offered under Opposer's NATRALIA mark.

6. Opposer's rights are senior to any rights that Applicant may allege to have in its NATRALUS Mark because (a) Opposer's Registration registered before the filing date of the Application; and (b) on information and belief, and in light of Applicant's 1(b) filing basis, Applicant does not currently use its mark in commerce.

7. Applicant's NATRALUS mark so resembles Opposer's NATRALIA mark, in sight, sound, meaning, and commercial impression, as to be likely, when applied to the goods named in the Application, to cause confusion or mistake or to deceive, or to create the false impression that Applicant's services are provided by, related to, endorsed by, or associated with Opposer, or otherwise cause injury to Opposer's rights in its NATRALIA mark, in violation of Lanham Act §2(d) (15 U.S.C. §1052(d)), with consequent damage to Opposer and the public.
