NOTICE OF OPPOSITION

Opposer Andre Young, an individual with an address of 10960 Wilshire Boulevard, 5th Floor, c/o Nigro Karlin Segal & Feldstein, LLP, Los Angeles, California 90024, believes that he would be damaged by the issuance of a registration for the mark DR. DRAI, as applied for in Application Serial No. 86/590,205, and therefore opposes the same. As grounds for the opposition, Opposer, by his attorneys Fross Zelnick Lehrman & Zissu, P.C., alleges as follows:

1. Opposer is a renowned record producer, musician, and entrepreneur who has used the name and trademark DR. DRE since as early as 1981. Under the name DR. DRE, Opposer has become one of the most influential artists and producers in hip-hop music. Due to Opposer's renown, musical recordings and merchandise bearing the DR. DRE mark enjoy massive sales.

2. Opposer is the owner of all right, title, and interest in and to the DR. DRE mark, as used in connection with a wide variety of goods and services. As a result of this use and promotion of the DR. DRE mark, the DR. DRE mark has come to be recognized as identifying

goods and services of Opposer exclusively and has come to represent enormous goodwill of Opposer.

3. In addition to his common law rights, Opposer owns numerous federal registrations for the DR. DRE mark, including, but not limited to, U.S. Reg. No. 2,275,314 for use in connection with “series of musical sound recordings” in International Class 9, registered on September 7, 1999, and based on a first use in commerce in 1981; U.S. Reg. No. 2,271,448 for use in connection with “clothing, namely, T-shirts, sweatshirts, caps” in International Class 25, registered on August 24, 1999, and based on a first use in commerce in 1981; U.S. Reg. No. 2,271,449 for use in connection with “posters, art prints and stickers” in International Class 16, registered on August 24, 1999, and based on a first use in commerce in 1981; and U.S. Reg. No. 2,271,450 for use in connection with “entertainment services by a musical artist and producer, namely, musical composition and production of musical sound recordings” in International Class 41, registered on August 24, 1999, and based on a first use in commerce in 1981.

4. All of Opposer’s registrations relied upon herein are valid, subsisting, and in full effect. Moreover, all of the registrations relied upon herein have become incontestable pursuant to Section 15 of the Lanham Act, 15 U.S.C. § 1065, and therefore serve as conclusive proof of the validity of the DR. DRE mark and Opposer’s exclusive right to use the mark in commerce on or in connection with the goods and services listed in the registrations, as provided by Section 33(b) of the Lanham Act, 15 U.S.C. § 1115(b). Attached hereto as Exhibit A are printouts from the TSDR electronic database records of the U.S. Patent and Trademark Office showing the current status and title of the registrations relied upon herein.

5. Upon information and belief, the owner of the application at issue is Draion M Burch Do, LLC (“Applicant”), a Pennsylvania limited liability company with an address of P.O. Box 99847, Pittsburgh, Pennsylvania 15233.

6. On April 7, 2015, Applicant filed Application Serial No. 86/590,205 (the “Application”) to register the mark DR. DRAI (“Applicant’s Mark”) for “educational and entertainment services, namely, providing motivational speaking services in the field of osteopathic medicine, obstetrics and gynecology provided by a doctor” in International Class 41 and “health care consulting in the field of osteopathic medicine, obstetrics and gynecology rendered by a doctor; obstetric and gynecology services rendered by a doctor” in International Class 44, based on a first use of July 1, 2011.

7. On information and belief, Applicant had actual knowledge of Opposer’s prior rights to and interest in the DR. DRE mark before seeking to register Applicant’s Mark.

**FIRST CLAIM FOR RELIEF UNDER SECTION 2(a)
(FALSE SUGGESTION WITH PERSONS, LIVING OR DEAD)**

8. Opposer repeats and re-alleges each and every allegation contained in Paragraphs 1 through 7 as if fully set forth herein.

9. Applicant’s Mark falsely suggests a connection with persons, living or dead, namely, Opposer, who has long been known by the name DR. DRE.

10. Registration of Applicant’s Mark in connection with the services set forth in the Application therefore violates Section 2(a) of the Lanham Act, 15 U.S.C. § 1052(a).

11. By reason of the foregoing, Opposer is likely to be harmed by registration of Applicant’s Mark.

**SECOND CLAIM FOR RELIEF
UNDER SECTION 2(d) (LIKELIHOOD OF CONFUSION)**

12. Opposer repeats and re-alleges each and every allegation contained in Paragraphs 1 through 11 as if fully set forth herein.

13. Opposer's DR. DRE mark has been used continuously by Opposer since a date prior to any date on which Applicant can rely. As such, Opposer's rights in the DR. DRE mark are prior and superior to any rights Applicant may claim in Applicant's Mark.

14. Applicant's Mark is highly similar to Opposer's DR. DRE mark in sight, sound, and commercial impression.

15. The services identified in the Application are closely related to the goods and services that have long been offered by Opposer under his registered DR. DRE mark.

16. As a result of the similarity of the marks and the goods and services, Applicant's use and registration of Applicant's Mark in connection with the services identified in the Application are likely to cause confusion, cause mistake, or to deceive consumers to falsely believe that Applicant's services emanate from or otherwise are authorized, sponsored by, or affiliated with Opposer, in violation of Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d).

17. By reason of the foregoing, Opposer is likely to be harmed by registration of Applicant's Mark.

THIRD CLAIM FOR RELIEF UNDER SECTION 43(c) (DILUTION)

18. Opposer repeats and re-alleges each and every allegation contained in Paragraphs 1 through 17 as if fully set forth herein

19. Opposer's DR. DRE mark is a famous mark, and became so prior to the earliest date upon which Applicant can rely.

20. Applicant's use and registration of Applicant's Mark will damage Opposer by trading on the enormous goodwill associated with the famous DR. DRE mark, and thus diminishing the goodwill that Opposer has built up in his DR. DRE mark and diluting its distinctiveness. As such, Applicant's use and registration of Applicant's Mark in connection with the services identified in the Application are likely to cause dilution by blurring of


Opposer's famous DR. DRE mark, in violation of Sections 13(a) and 43(c) of the Lanham Act, 15 U.S.C. §§ 1063(a), 1125(c).

21. By reason of the foregoing, Opposer will be harmed by registration of Applicant's Mark.

WHEREFORE, it is respectfully requested that this opposition be sustained and that the registration sought by Application Serial No. 86/590,205 be denied.


