Opposer, Legacy.com, Inc. (“Legacy” or “Opposer”), a corporation existing under the laws of Delaware with its principal place of business at 820 Davis Street, Suite 210, Evanston, IL 60201, believes that it will be damaged by the registration of the mark MYLEGACY.LIFE in Trademark Application Serial No. 86/549,507 for services in International Class 45 (the “Application”) filed by Elias Lee Gil (“Applicant”) and hereby opposes the same.

As grounds for this opposition, Legacy states as follows:

FACTS

1. Legacy is the owner of Registration Number 2,556,944, with a filing date of January 7, 2000 and a first use in commerce date of February 1, 2000 for the Service Mark LEGACY.COM for services in International Class 42, namely, “Providing obituary and memorial information over a global computer network” (the “LEGACY.COM Service Mark”). A copy of the TESS record is attached as **Exhibit A**.

2. Legacy also owns Registration Number 4,780,769, with a filing date of October 28, 2014 and a first use in commerce date of October 14, 2014 for the Service Mark LEGACY for services in International Class 35, namely, “Providing a website featuring directories of services of others in the field of death care and memorialization” (the “LEGACY IC 35 Service Mark”). A copy of the TESS record is attached as **Exhibit B**.

3. Legacy also owns an intent to use application, Application Serial No. 86/437,068, with a filing date of October 28, 2014 for the Trademark and Service Mark LEGACY for following goods and services:

- a. International Class 9, namely, “Computer application software for mobile phones, portable media players, handheld computers, namely, software featuring information about obituaries, tributes, stories, inspirations, life lessons, memories, videos, photographs, music and information about funeral services, memorial flowers and gifts, guest books and charitable donations; Computer application software for mobile phones, portable media players, handheld computers, namely, software to assist users in locating obituaries, tributes, stories, inspirations, life lessons, memories, videos, photographs, music and information about funeral services, memorial flowers and gifts, guest books and charitable donations.”
- b. International Class 41, namely, “Educational services, namely providing on-line articles and blogs about grief support groups, bereavement, funerals, condolences, mourning customs, estate planning, memorial giving and notable births, deaths and events occurring on specific dates in history; entertainment services, namely providing quizzes, polls and surveys on the lives and deaths of historical figures, celebrities and fictional characters.”

- c. International Class 42, namely, “Providing temporary use of non-downloadable software over a global computer network for use in creating online memorials, including obituaries, tributes, stories, inspirations, life lessons, memories, videos, photographs, music and information about funeral services, memorial flowers and gifts, guest books and charitable donations.”
- d. International Class 45, namely, “Providing social networking services via global communication networks to allow users to discover relationships between people, communities and organizations; providing information in the field of online memorials, including obituaries, tributes, stories, inspirations, life lessons, memories, videos, photographs, music and information about funeral services, memorial flowers and gifts, guest books and charitable donations through online social networking.”

(the “LEGACY ‘068 Mark”). The LEGACY ‘068 Mark was published for opposition on March 31, 2015 and allowed on May 26, 2015. A copy of the TESS record is attached as **Exhibit C**.

4. Upon information and belief, Applicant Elias Lee Gil is an individual residing at 7232 Ridigate Farm, San Antonio, Texas 78228.

5. On or about February 28, 2015, Applicant filed an intent to use application to register the Service Mark MYLEGACY.LIFE for use in connection with International Class 45, namely, “Online social networking services provided through a community website; *Online social networking services in the field of memories of the dead provided via a website*; Preparation of custom memory books, scrapbooks, personal archives, family archives, wedding albums, diaries, vacation albums, family albums, family histories, photograph albums, birthday albums, and special event albums for others; Providing a website featuring information regarding

personal relationships; Providing an interactive website concerning notifications of changes in the status of personal relationships; *Providing personal obituary and memorial service information*; Release of doves at funerals, wedding, and memorials for spiritual purposes; Security services, namely, providing a website notifying individuals of a changed status or condition of a sensing device in a security system via electronic message alerts; *Social networking services in the field of memories of the dead provided via a website*” (emphasis added). A copy of the Application is attached as **Exhibit D**.

COUNT I

A Likelihood of Confusion Would Exist if the Application Were Registered

6. Opposer repeats and realleges each and every allegation set forth in paragraphs 1 through 6 as if fully set forth herein.

7. The TTAB has repeatedly affirmed an examining attorney’s refusal to register marks found to be similar in sound and appearance because they would create a likelihood of confusion among the public. *See In re 1st USA Realty Professionals, Inc.*, 84 U.S.P.Q. 2d 1581, 1586 (TTAB 2007) (FIRST USA and 1st USA); *Centraz Industries, Inc. v. Spartan Chemical Co.*, 77 U.S.P.Q. 2d 1698, 1701 (TTAB 2006); and *In re Infinity Broadcasting Corp. of Dallas*, 60 U.S.P.Q. 2d 1214, 1217.

8. The LEGACY Trademarks (LEGACY.COM and LEGACY) and Applicant’s MYLEGACY.LIFE mark bear the identical word LEGACY and are confusingly similar in appearance and sound.

9. The International Class 45 services that Applicant proposes to offer in the field of memorial services, in particular, “providing personal obituary and memorial service information,” overlap significantly with Legacy’s current use of its LEGACY Trademarks, under

which it offers International Class 42 and 35 services, namely, “Providing obituary and memorial information over a global computer network” and “Providing a website featuring directories of services of others in the field of death care and memorialization,” respectively.


10. Additionally, Applicant filed its application for the MYLEGACY.LIFE mark for International Class 45 services on February 28, 2015, proposing to offer services that overlap significantly with Legacy’s intended use of the LEGACY mark, after Legacy had already filed an application on October 28, 2014 for the LEGACY mark for goods and services that included International Class 45 services, namely, “Providing social networking services via global communication networks to allow users to discover relationships between people, communities and organizations; providing information in the field of online memorials, including obituaries, tributes, stories, inspirations, life lessons, memories, videos, photographs, music and information about funeral services, memorial flowers and gifts, guest books and charitable donations through online social networking.”

11. Accordingly, the Application should be refused under Section 2(d) of the Trademark Act, 15 U.S.C. Section 1052(d), because the proposed mark in the Application, so resembles a mark previously used in the United States by Legacy and not abandoned (LEGACY.COM and LEGACY), as to be likely, when used on or in connection with services of Applicant, to cause confusion, or to cause mistake, or to deceive.

WHEREFORE, Opposer, Legacy.com, Inc., prays that this Notice of Opposition be sustained in favor of Opposer and that Serial No. 86/549,507 be denied registration. Opposer submits herewith a copy of this Notice of Opposition, along with a filing fee of \$300.00, as required by 37 C.F.R. § 2.6(a)(17).
