**NOTICE OF OPPOSITION**

Opposer Canada Goose Inc. (“Opposer”), a Canadian corporation having a place of business at 250 Bowie Avenue, Toronto, Ontario, Canada M6E4Y2, believes it will be damaged by the registration of the mark NORTHERN GOOSE FIRST EDITION & Design shown in Application Serial No. 86/648,706 filed June 2, 2015 (the “Application”) and hereby opposes same.

As grounds for the opposition, by its attorneys Fross Zelnick Lehrman & Zissu, P.C., Opposer alleges as follows:

1. Opposer is the owner of CANADA GOOSE brand clothing, a leading brand of apparel specializing in cold weather outerwear. Opposer has manufactured and offered outerwear and related goods under the CANADA GOOSE, CANADA GOOSE ARCTIC PROGRAM & Design and other CANADA GOOSE-formative marks (collectively, the “CANADA GOOSE Marks”) in the U.S. since at least as early as 1994.

2. Opposer’s meticulous craftsmanship and designs have led to the brand’s enormous popularity and success, as has Opposer’s extensive favorable media attention in the

fashion and outerwear industries. Opposer's products are regularly worn by celebrities on and off screen, as well as arctic researchers and military personnel the world over.

3. As a result of Opposer's significant sales and advertising and promotional efforts and expenditures, consumers have come to recognize the CANADA GOOSE Marks as denoting Opposer's goods.

4. In connection with protecting its rights in the CANADA GOOSE Marks, Opposer owns United States federal trademark registrations:

- U.S. Reg. No. 4,455,111 for CANADA GOOSE in connection with "Outerwear, namely, coats, parkas, jackets, vests, pullovers, shirts, headwear, scarves, gloves and mittens, substantially made of goose down, where applicable" in International Class 25, based on first use in 1998;

- U.S. Reg. No. 3,254,771 for CANADA GOOSE ARCTIC PROGRAM & Design, shown here:



for "Clothing, namely parkas, coats, jackets, pullovers, vests, sweaters, shirts, anoraks, and headwear, substantially made of goose down, where applicable" in International Class 25, based on first use in 1994;

- U.S. Reg. No. 3,983,188 for CANADA GOOSE & Design, shown here:



for “Outerwear, namely, coats, jackets, parkas, pull-overs, substantially made of goose down, where applicable” in International Class 25, based on a priority date in 2009; and

- U.S. Reg. No. 3,979,986 for CANADA GOOSE ADVENTURE TOURS

& Design, shown here:



for “Travel and tour services, namely, arranging and coordinating travel arrangements for individuals and groups, arranging travel tours, organization of excursions, tours and travel; arranging and operating adventure activity tours and excursions” in International Class 39, based on a priority date of September 10, 2009.

These registrations are valid and subsisting, and U.S. Reg. No. 3,254,771 has obtained incontestability status, pursuant to 15 U.S.C. § 1065. A copy of the U.S. Patent and Trademark Office database printouts concerning such registrations is attached as Exhibit 1.

5. On June 2, 2015, Applicant, Freedom Rains, Inc., a New York corporation with an address of Suite M1, 530 Seventh Avenue, New York, NY 10018, filed Application Serial No. 86/648,706 for the mark NORTHERN GOOSE FIRST EDITION & Design shown here:



for “Coats; footwear; gloves; hats; jackets; outer jackets; pants; parkas; scarves; shell jackets; snow pants; sweaters; vests” in International Class 25, based on an intent to use (the “Applicant’s Mark”).

6. Applicant’s Mark is virtually identical to Opposer’s previously used and registered CANADA GOOSE Marks so as to be likely, when used in connection with the goods set forth in the Application, which are identical and/or highly related to the goods provided by Opposer under its CANADA GOOSE Marks, to cause consumers to falsely associate Applicant’s goods under Applicant’s Mark with Opposer or with Opposer’s goods, or to falsely believe that Applicant’s goods are sponsored, endorsed or licensed by Opposer, or that there is some relationship between Applicant and Opposer when there is no such relationship.

7. Upon information and belief, Applicant applied to register Applicant’s Mark with full knowledge of Opposer’s use of and exclusive rights in the CANADA GOOSE Marks.

8. For the above reasons, registration and/or any use of Applicant’s Mark by Applicant in connection with the applied-for goods is likely to cause confusion, cause mistake or to deceive the public, and to cause the public to believe that the goods sold by Applicant under the Applicant’s Mark emanate from, or are sponsored by, endorsed by or otherwise connected with Opposer, in violation of Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d).

9. By reason of the foregoing, Opposer will be damaged by the registration of the Application.


WHEREFORE, Opposer requests that the Application be rejected, that no registration be issued to Applicant on the Application, and that this opposition be sustained in favor of Opposer.
