

SoulCycle Inc., a Delaware corporation having a business address of 609 Greenwich Street, New York, New York, 10014 (“SoulCycle”), believes that it will be damaged by registration of the subject marks of Applications Ser. Nos. 86/471,545 and 86/566,781 (the “Challenged Applications”), SOUL POSE, both covering Classes 25 and 41, and hereby opposes those applications. On information and belief, the owner of the Challenged Applications is TCR IP Holdings, LLC, a Utah limited liability company having a business address of 12244 S. Business Park Drive, Suite 100, Draper, Utah 84020 (“Applicant”).

As grounds for this opposition, SoulCycle alleges as follows:

1. SoulCycle is an internationally acclaimed and rapidly expanding fitness and lifestyle brand, with a focus on inspirational coaching and personal development, that also offers a successful and widely publicized line of clothing and apparel items, as well as other related merchandise. The lifestyle retail shop is a key component of each studio, with at least twelve (12) collections released each year, and the business is well-known and recognized for

its retail collections.

2. SoulCycle currently includes fifty-one (51) studios located in the United States, providing fitness and exercise services and selling a range of products, including clothing, bags, accessories, and other merchandise. Clothing and related items, including stationary exercise bicycles, are available in SoulCycle studios and/or online at <https://www.soul-cycle.com/shop/>.

3. Beginning in 2006, SoulCycle established and developed a family of SOUL-formative marks in Class 41 in connection with its unique brand of fitness and exercise services, including SOULCYCLE (2006),<sup>1</sup>SOULSURVIVOR (2006), SOULTEEN (2007), SUPERSOUL (2008), FIND YOUR SOUL (2007), SOULBANDS (2009), SOULCHALLENGE (2010), SOUL (2011), and SOUL101 (2013), among others. In addition, SoulCycle has extensively used, and continues to use, a family of SOUL-formative marks in connection with numerous Classes: 25 for athletic apparel (2006) and 35 (in studio 2006 and online 2009), 14 (2009), 18 (2009), and 28 (2012), and provides a fitness-related website (2006) with a blog (2009), known as a “community page,” and related entertainment and educational services in 41, among other goods and services (with the SOUL-formative marks listed in paragraph 3, above, the “SOUL Marks”).

4. SoulCycle is the owner of numerous federal registrations and applications for its SOUL Marks, a schedule of which is annexed hereto as **Exhibit A**, together with printouts from the TSDR Database showing the current status and title of each of those filings.

5. Among SoulCycle’s existing U.S. trademark filings are the following filings in Class 25 for clothing and other goods:

SoulCycle uses an array of SOUL-formative marks that foster and reinforce consumer association of SOUL and marks containing that term in the fields of fitness and apparel, as part of the lifestyle brand that is SoulCycle. Among the historic marks are SOULYOGA, SOUL BURN, SOUL TRIP, SOUL PARTY, SOUL FAMILY, SOUL BASICS, SOUL SCHEDULE, SOUL CLASSES, SOUL RESERVE, SOUL PRICING, SOUL BIOS, SOUL CONTACT, and DOUBLE YOUR SOUL used in connection with fitness classes and fitness studio services at various times, certain of which from as early as 2006; SOULBLOG, used in connection with a blog and on-line articles since as early as 2009; and SOUL COLLECTION and SOUL SHOP, used in connection with SoulCycle's on-line retail store since as early as 2009 and 2011, respectively.

8. Accordingly, SoulCycle is the owner of common law trademark rights in a significant number of other SOUL Marks in connection with its fitness services and related website, community page, and merchandise, based on use in commerce since well prior to December 4, 2014 and March 17, 2015, the filing dates of the Challenged Applications. Those rights include rights in the marks SOUL STUDIOS (2009), SOUL COMMUNITY (2009), SOUL TRANSFORMATION (2010), and SOUL ETIQUETTE (2011), among others, as well as rights in the mark SOUL alone for retail store services in the field of apparel and other goods.

9. SoulCycle has expanded its offerings of clothing by entering into limited retail collaborations pursuant to which clothing has been sold by third parties, including via Amazon-owned fashion site SHOPBOP, accessible on-line at [www.shopbop.com](http://www.shopbop.com), and mobile shopping application, SPRING. Additionally, SoulCycle has been the subject of extensive domestic and international media coverage in more than seventy (70) countries, and has received considerable attention in the fashion-industry trade journal, *Women's Wear Daily*.

10. By virtue of the longstanding use and extensive promotional efforts made by SoulCycle, as well as substantial unsolicited media attention, the SOUL Marks have developed extensive and valuable goodwill that belongs exclusively to SoulCycle.

11. Applicant filed Application Ser. No. 86/471,545 on December 4, 2014 based on intent to use the mark SOUL POSE in Class 25 for "Clothing for athletic use, namely, shirts, caps, hats, sweat shirts, sweat bands, head bands" and in Class 41 for "Athletic and sport event services, namely, organizing, arranging, and conducting running events and running competitions; providing a website featuring information on the sport of running and running events; providing online information in the fields of running and running events."

12. Applicant filed Application Ser. No. 86/566,781 on March 17, 2015 based on intent to use the mark SOUL POSE in Class 25 for "Clothing, namely, shirts, caps, hats, sweat shirts, sweat bands and headbands" and in Class 41 for "Athletic and sport event services, namely, organizing, arranging and conducting yoga events; providing a website featuring information on yoga and yoga events; providing online and electronic information in the fields of yoga and yoga events."

13. The clothing covered by the Challenged Applications is identical to, or closely similar to, the athletic and other apparel and other goods offered under the SOUL Marks in

connection with SoulCycle.

14. The athletic services and related website and provision of online information covered by the Challenged Applications are closely related to the fitness services and fitness-related website and community page offered under the SOUL Marks in connection with SoulCycle.

15. SoulCycle's rights in and to its SOUL Marks, including its statutory and common law rights in and to the mark SOUL for apparel (as described in U.S. Reg. No. 4,829,066) and the mark SOULCYCLE for apparel (as described in U.S. Reg. No. 3,844,345), are long prior to any rights Applicant may have in the United States with respect to the subject mark of the Challenged Applications for apparel.

16. SoulCycle's rights in and to its SOUL Marks, including its statutory and/or common law rights in and to the marks SOUL, SOULCYCLE and other SOUL Marks for fitness services and a related website and blog (as described in, *inter alia*, U.S. Reg. No. 4,688,307, U.S. Reg. No. 3,264,026, U.S. Reg. No. 4,434,026, U.S. Reg. No. 4,609,667, U.S. Reg. No. 4,353,330, U.S. Reg. No. 4,353,332, U.S. Reg. No. 4,353,331, U.S. Reg. No. 4,620,811 and allowed U.S. Appln. Ser. No. 85/378,841) are long prior to any rights Applicant may have in the United States with respect to the subject mark of the Challenged Applications for athletic services and providing a related website and online information.

17. The subject mark of the Challenged Applications so resembles SoulCycle's SOUL Marks as to be likely, when used in connection with Applicant's goods, to cause confusion, to cause mistake, or to deceive as to the affiliation, connection or association of Applicant with SoulCycle, or as to the origin, sponsorship or approval of Applicant by SoulCycle.

18. The subject mark of the Challenged Applications so resembles SoulCycle's SOUL Marks as to be likely, when used in connection with Applicant's services, to cause confusion, to cause mistake, or to deceive as to the affiliation, connection or association of Applicant with SoulCycle, or as to the origin, sponsorship or approval of Applicant by SoulCycle.

19. SoulCycle believes that it will be damaged by the registration of the subject mark of the Challenged Applications because such registration would support and assist Applicant in the confusing and misleading use of the designation it seeks to register, and would give color of exclusive statutory rights to Applicant, in violation and derogation of the prior superior rights of SoulCycle.

WHEREFORE, SoulCycle requests that the Challenged Applications be refused registration, and that the Trademark Trial and Appeal Board grant such other relief as it deems just and proper.


