27. Marks featuring the term “TINK” or “TINKER” are used in the United States in commerce by numerous third parties.

28. The term “TINK” is weak and diluted in connection with the goods and services of Opposer.

29. The term “TINKER BELL” is weak and diluted in connection with the goods and services of Opposer.

30. The terms “TINK” and “TINKER BELL,” as used by Opposer, describe a character.

31. The character known as “TINK” and/or “TINKER BELL” is featured in a well-known literary work that is in the public domain.

32. The character known as “TINK” and/or “TINKER BELL” is a famous public domain character.

33. The names “TINK” and/or “TINKER BELL” have highly descriptive connotations when used in connection with the public domain character “Tink” or “Tinker Bell.”¹

34. The names “TINK” and/or “TINKER BELL” have highly descriptive connotations when used on toys or other products that portray the public domain character “Tink” or “Tinker Bell.”

35. Applicant’s mark and each of Opposer’s pleaded marks have different appearances.

36. Applicant’s mark and each of Opposer’s pleaded marks have different meanings.

37. Applicant’s mark and each of Opposer’s pleaded marks have different sounds.

38. Applicant’s mark and each of Opposer’s pleaded marks have different commercial impressions.

39. Applicant’s mark and the pleaded marks of Opposer are not likely to cause confusion, mistake, or deception among purchasers as to the source of Opposer’s and Applicant’s respective goods.

40. Opposer’s pleaded marks are entitled to only a very narrow scope of protection.

41. Opposer’s pleaded marks are not likely to be damaged by continued registration and use of Applicant’s mark.
