PROCEEDINGS CONTINGENT UPON ENTRY OF AMENDMENT AND
ABANDONMENTS

Opposer. and Applicant, through their undersigned counsel, requests the drawing of the mark for Application No.: 86478284 (subject of Opposition proceeding 91225295) to be amended to delete the space appearing in the mark between the word KICK and POWER, pursuant to a settlement agreement executed between Petitioner and Registrant, whereby the amended drawing and mark should appear as one word KICKPOWER. The parties believe that this amendment constitutes a non-material alteration of the mark and should be allowed post publication.

Applicant further amends the identification of goods set forth in Application No.: 86478284 to the following: Cellular telephones; Tablets; Cellular telephone accessories, namely, battery chargers, ac adaptors, and ac chargers; car chargers that plug into a cigarette lighter adapter; travel battery chargers, rapid battery chargers; USB flash drives sold blank; USB

chargers for mobile devices, namely, smart phones and tablets; cell phone cradle units; adaptor plugs that plug into a car cigarette lighter; batteries; electric cables; 3.5 auxiliary audio cables; cases for cellular telephones, tablet computers, pagers, and GPS navigation devices; laptop protective cases; laptop and tablet protective covers and sleeves; computer styluses, video cameras, back packs especially adapted for holding laptops and tablets; messenger bags especially adapted for holding laptops and tablets, sports helmets, namely, bmx helmets, ski helmets, and motocross helmets

Further, Applicant, with the consent of Opposer, withdraws and expressly abandons Application Serial Nos: 86588862 and 86588853.


