CONSENTED MOTION FOR LEAVE TO AMEND APPLICATIONS

Applicant, Multi-State Neighborhood Financial Services, Inc., and Opposer, Citigroup Inc., have settled this consolidated opposition. The settlement agreement requires Applicant to amend Application Serial Nos. 86/534,601 and 86/534,633 by deleting “picture identification cards and transit cards” from the recitation of services for International Class 35, deleting “Credit card services,” “Issuing prepaid debit cards,” and “Telephone calling card services” from the recitation of services for International Class 36, and adding the limitation “all of the foregoing excluding credit cards and debit card services” to the end of the recitation of services for International Class 36. The parties request the Board’s assent to that amendment. The recitation of services (both applications cover the identical services) would then read:

IC 035: Retail outlets featuring prepaid cell telephones, ~~picture identification cards and transit cards~~; Tax filing services; Tax preparation.

IC 036: Bill payment services; Check cashing; ~~Credit card services~~; Electronic funds transfer; Financing loans for consumers; Insurance brokerage in the field of property and casualty and automobile insurance; ~~Issuing prepaid debit cards~~; Money order services;
